Minutes of 4th meeting of the Informal Working Group on Halloumi/Hellim 19 June 2023

The 4th meeting of the Informal Working Group (WG) on Halloumi/Hellim (HH) was held on 19 June 2023 in the Home 4 Cooperation in Nicosia. The meeting was chaired by the Commission services, with the presence of 6 out of 10 WG members (see Annex 1; 9 members had confirmed).

The WG adopted the draft agenda shared in advance of the meeting.

The objective of the meeting was to discuss recent developments and to have a more detailed insight into the Halloumi/Hellim PDO certification process directly form the delegated body, Bureau Veritas.

Members welcomed further progress in the Halloumi/Hellim PDO certification process in the Turkish Cypriot community, and have informed of bi-communal initiatives that took place in the past months.

Bureau Veritas presented the Halloumi/Hellim PDO certification process (as per PowerPoint Presentation in Annex 2). Members raised queries about specific aspects. The scope and methodology of checks was explained, taking into account the recent product specification changes and its present version in force.

It was concluded that the Halloumi/Hellim PDO scheme is progressing well in both communities and helps boost cooperation also between the communities. The benefits for the Turkish Cypriot community shall become tangible once all the preconditions for trading in the EU market are met. The quantities of small ruminants' milk were addressed as a pertaining challenge for both communities.

Members suggested that the Commission takes initiative in organising bi-communal events beyond the scope of the WG, related to different topics relevant for the Halloumi/Hellim PDO scheme implementation, as to support further the exchanges between the communities.

The proposal by the Commission to invite at the next meeting external experts to present possible strategies and Member States' good practice examples for increasing sheep and goats milk yields was welcomed.

It was announced that the next meeting would be held in late September or October 2023.




