amending Commission Decision C(2015)9059 concerning the adoption of the 2016 work programme in the field of Communication, serving as a financing decision

### THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002<sup>1</sup>, and in particular Articles 84(2) and 128 thereof,

#### Whereas:

- (1) The financing decision for the 2016 work programme in the field of Communication has been adopted by Commission Decision C(2015)9059 on 17 December 2015<sup>2</sup>.
- (2) Following the definitive adoption of the European Union's budget for the financial year 2016, an amendment to Decision C(2015)9059 of 17 December 2015 has now become necessary.
- (3) New action should be included.
- (4) This amending Decision complies with the conditions laid down in Article 94 of Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union.<sup>3</sup>

### HAS DECIDED AS FOLLOWS:

### Article 1

Article 2 of Commission Decision C(2015)9059 is amended as follows:

The maximum Union contribution for the implementation of the programme for 2016 is set at EUR 78 704 500, and shall be financed from the appropriations entered in the following lines of the general budget of the Union for 2016:

- budget lines remain unchanged with the addition of:
- budget line 16.03 77 05: EUR 500 000

The penultimate paragraph remains unchanged.

The last paragraph is deleted.
