

2023 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the European rule of law mechanism, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, three editions of the Rule of Law Report have been published in 2020, 2021 and 2022.

In the preparation of the first three editions of the Rule of Law Report, the Commission has relied on a diversity of relevant sources, including from Member States, country visits, and stakeholders' contributions collected through the targeted stakeholder consultation [1]. The information provided has informed the Commission's country-specific assessments in preparing the Report. Building on the positive experience from the first three editions of the Rule of Law Report, the Commission is now inviting stakeholders to provide written contributions for the preparation of the 2023 Rule of Law Report through this targeted consultation.

The contribution to be provided should include (1) information on measures taken to implement the recommendations addressed to the Member State in the 2022 Rule of Law report, as well as developments with regard to the points raised in the respective country chapter and (2) any other significant developments since January 2022 [2] falling under the 'type of information' outlined in the next section.

The input should be short and concise and summarise information related to one or more of the areas referred to in the template. You are invited to focus on the areas that relate to the scope of work and expertise of your organisation. Existing reports, statements, legislation or other documents may be referenced with a link (no need to provide the full text). Stakeholders are encouraged to make references to any contributions already provided in a different context or to Reports and documents already published. Contributions should focus on significant developments both as regards the legal framework and its implementation in practice.

If you wish to submit information concerning several Member States, you will have to fill-in the questionnaire separately for each Member States (due to the size of the questionnaire). There is no limit to the number of contributions submitted by a single participant. In such cases, you are not required to repeat the information in the section "about you" that is non-mandatory nor the information on horizontal developments.

We saw in 2022 new attempt from intelligence services to write their own laws, that were leaked to the media - see <https://www.g4media.ro/legile-securitatii> These laws do not improve human rights aspects, checks and balances or their oversight, but they focus solely on expanding their current powers.

One of these laws - the one on cybersecurity - was published as a draft law in November by the Ministry of Digitisation and it has passed in a very quick procedure (just 9 days in both chambers of parliament!) with no debate on any key matters: access to info with no legal mandate, on the oversight and with an expansion of the attributions of intelligence services to cover "disinformation and propaganda", which is an awful attempt to limit freedom of expression. The law has been attacked to the Constitutional Court by the Ombudsman and Political parties - <https://www.romania-insider.com/romania-ombudsman-constitutional-court-cyber-security-law>

When the NGOs asked for a review on what has happened and asked for real auditing of how the system works and where are its flows, everyone rejected any competences on the case (CSM, IJ, Ministry of Justice)

The Media Pluralism assessment relating to 2021 produced a high risk score in two areas - Market Pluralism and Social Inclusion - and a medium risk score in two others - Independence and Protection of fundamental rights.

The key risk factors undermining pluralism and the ability of the media to mission remain the same, although the risk scores for some indicators have changed.

we emphasise that at the root of many problems lie institutions and procedures - both formal and informal, both regulatory and non-regulatory, both self-regulatory. This is because they do not encourage and protect journalistic work that meet high professional standards, prioritise the public interest and be free from interference
