Introduction

The annual Rule of Law Report lies at the centre of the European rule of law mechanism, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, three editions of the Rule of Law Report have been published in 2020, 2021 and 2022.

In the preparation of the first three editions of the Rule of Law Report, the Commission has relied on a diversity of relevant sources, including from Member States, country visits, and stakeholders' contributions collected through the targeted stakeholder consultation [1]. The information provided has informed the Commission's country-specific assessments in preparing the Report. Building on the positive experience from the first three editions of the Rule of Law Report, the Commission is now inviting stakeholders to provide written contributions for the preparation of the 2023 Rule of Law Report through this targeted consultation.

The contribution to be provided should include (1) information on measures taken to implement the recommendations addressed to the Member State in the 2022 Rule of Law report, as well as developments with regard to the points raised in the respective country chapter and (2) any other significant developments since January 2022 [2] falling under the 'type of information' outlined in the next section.

The input should be short and concise and summarise information related to one or more of the areas referred to in the template. You are invited to focus on the areas that relate to the scope of work and expertise of your organisation. Existing reports, statements, legislation or other documents may be referenced with a link (no need to provide the full text). Stakeholders are encouraged to make references to any contributions already provided in a different context or to Reports and documents already published. Contributions should focus on significant developments both as regards the legal framework and its implementation in practice.

If you wish to submit information concerning several Member States, you will have to fill-in the questionnaire separately for each Member States (due to the size of the questionnaire). There is no limit to the number of contributions submitted by a single participant. In such cases, you are not required to repeat the information in the section "about you" that is non-mandatory nor the information on horizontal developments.

Reporte al sistema de alerta rápida de la UE (MFRR) los ataques a la libertad de prensa que se producen en España. También colabora estrechamente con organizaciones europeas de periodistas como la Federación Europea de Periodistas (EFJ), el International Press Institute (IPI) y de defensa de la libertad de expresión como Article 19. También con organizaciones de defensa de los derechos digitales como Wikimedia y EDRI. En muchos casos, las deficiencias que se producen en España ocurren en otros países, en particular los litigios estratégicos contra periodistas (SLAPP), la falta de transparencia de los medios audiovisuales, control político de los medios de comunicación a través de la publicidad gubernamental, deficientes leyes de transparencia y limitada protección de fuentes-denunciantes. Respecto al primer punto, en julio se aprobaba la Ley 13/2022, de 7 de julio, General de Comunicación Audiovisual con la se transpone, con año y medio de retraso, la Directiva (UE) 2018/1808 de Servicios de Comunicación Audiovisual (https://www.boe.es/diario_boe/txt.php?id=BOE-A-2022-11311) Entre otro aspectos, la ley modifica el régimen de financiación de RTVE (la radio televisión pública española) Sin embargo, no termina de garantizar su independencia respecto al poder gubernamental, ni tampoco la de otros medios públicos autonómicos, que

quedará pendiente del anunciado reglamento europeo “Media Freedom Act” (https://ec.europa.eu/commission/presscorner/detail/en/ip_22_5504) Respecto al acceso a la información, el segundo hito ha sido la aprobación en agosto del anteproyecto de ley de información clasificada , una norma que viene a sustituir a la vigente vigente Ley 9/1968, de 5 de abril, sobre Secretos Oficiales, y cuya modificación viene siendo reclamada por organizaciones sociales y políticas desde hace tiempo y a la que, además, nos ha urgido la propia Comisión.

Sin embargo, la norma aún se mantiene en esa fase previa a la tramitación parlamentaria y, además, se trata de un articulado muy deficiente, de acuerdo a las valoraciones realizadas por juristas expertos y por esta Plataforma que ha presentado al Gobierno un documento pormenorizando sus objeciones:

Así, se censuraba que el anteproyecto no respetase los criterios de proporcionalidad, necesidad y legalidad, incluyendo límites desproporcionados e innecesarios para la salvaguardar la seguridad nacional, además de contener multitud de generalidades.

Especialmente preocupante para el pluralismo informativo son las sanciones previstas en el anteproyecto para los medios de comunicación que lleguen a publicar información veraz de interés público proveniente de filtraciones.
