Introduction

The annual Rule of Law Report lies at the centre of the European rule of law mechanism, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, three editions of the Rule of Law Report have been published in 2020, 2021 and 2022.

In the preparation of the first three editions of the Rule of Law Report, the Commission has relied on a diversity of relevant sources, including from Member States, country visits, and stakeholders' contributions collected through the targeted stakeholder consultation [1]. The information provided has informed the Commission's country-specific assessments in preparing the Report. Building on the positive experience from the first three editions of the Rule of Law Report, the Commission is now inviting stakeholders to provide written contributions for the preparation of the 2023 Rule of Law Report through this targeted consultation.

The contribution to be provided should include (1) information on measures taken to implement the recommendations addressed to the Member State in the 2022 Rule of Law report, as well as developments with regard to the points raised in the respective country chapter and (2) any other significant developments since January 2022 [2] falling under the 'type of information' outlined in the next section.

The input should be short and concise and summarise information related to one or more of the areas referred to in the template. You are invited to focus on the areas that relate to the scope of work and expertise of your organisation. Existing reports, statements, legislation or other documents may be referenced with a link (no need to provide the full text). Stakeholders are encouraged to make references to any contributions already provided in a different context or to Reports and documents already published. Contributions should focus on significant developments both as regards the legal framework and its implementation in practice.

If you wish to submit information concerning several Member States, you will have to fill-in the questionnaire separately for each Member States (due to the size of the questionnaire). There is no limit to the number of contributions submitted by a single participant. In such cases, you are not required to repeat the information in the section "about you" that is non-mandatory nor the information on horizontal developments.

In connection to the EUs recommendation to booster the independence of the judicial council members and to ensure their protection against arbitrary call off, no substantial progress has been achieved. The constitutional regulation remains unchanged and the judicial council members might be called off any time before their mandate expires.

This constitutional provision has been challenged by a group of MPs before the constitutional court. However, the constitutional court rejected to review the constitutionality of the pertinent provision due to lack of authority of the constitutional court over this topic (decision no. PL. ÚS 12/2022, para. 65)

According to the rule of law report 2022 and EUs recommendation, the Ministry of Justice was supposed to begin preparation works on the amendment of Prosecutor General's discretion to close cases.

These works have been halted for indefinite, and there doesn't seem to be sufficient political support to abolish, or limit the power of Prosecutor General to close criminal cases. In the meanwhile, this power has been used in other high profile cases including former prime minister and other high government representatives.

This ambiguity over the Prosecutor Generals competence coupled with the changing opinions of the politicians creates a big uncertainty and distrust over the criminal procedure in the eyes general public.

Unfortunately, no significant progress has been achieved in the inclusiveness of the law-making process in comparison with the 2022 Rule of Law report. Although the initiatives of the The Office of the Plenipotentiary of the Government for Civil Society Development in order to booster the public participation in thw lawmaking process continue, this have not had any significant impact on the precocess itself yet. Representatives of the Office od the Public Defender of Rights also took a part in these consulations /workgoups.

One of the biggest concerns still remains to be the adeption of MP proposed bills. Some significant changes to important bills have been introduced through MP proposals conciously in order to avoid public constulations.

To name just a few, for example the state budget has been significantly amended through MP proposals just few days before being adopted by the parliament. Another important change in the building act has been achieved by a MP proposal. According to some NGOs this change can significantly limit the public participation in creating the area plans.

Another persisting and harmful practice if the use of so called "sticker" amanedments (prílepy). These amendments are usually adopted in jointly with another bill that is actually discussed in the parliament. The sticer amendment (usually of a compeltely different topic) is that sticked to the discussed bill and adopted together with it. Not only that this makes the legal enviroment very dissaranged, but also leaves out the public from participating on the adoption of the bill.

Rules and use of fast-track procedures and emergency procedures (for example, the percentage of decisions adopted through emergency/urgent procedure compared to the total number of adopted decisions)

In year 2022, 21 out of 179 statutes were enacted using the fast-track procedure. This represents 11.7% of statutes enacted this year. [<https://www.nrsr.sk/web/default.aspx?sid=zakony/prehľad/slk>] This still represents an increase in comparison to years 2002-2020, where the average portion of laws enacted in fast-track procedure was 7.3% [<https://viaiuris.sk/aktuality/blog/bagrovane-zakonov/>]

For the first time in history, unjustified use of fast-track procedure led the Constitutional Court to rule that the adopted regulation was unconstitutional. This was caused by not taking a proper account of other constitutional provisions (The Slovak Republic protects the long-term sustainability of its economy, which is based on the transparency and efficiency of the use of public funds. Art. 55a of Slovak Constitution) due to the use of the fast-track procedure (decision no. PL. ÚS 13/2022)

Regime for constitutional review of laws

There haven't been any significant changes concerning the constitutional review of laws. However, the Constitutional court continued to apply its restrictive case law on the general courts standing rights in the constitutional review proceedings. Under this case law, the area, where a general court might be empowered to initiate a constitutional review of a legal norm is very limited.

However, there has been an important development in the area of the constitutional review of constitutional norms, i. e. the protection of the substantial constitutional core. After the constitutional court decided that it is empowered to protect the substantial constitutional core even by rendering the constitutional provisions void (2019), the parliament adopted a constitutional amendment. Under this amendment, effective from 1.1.2021, the constitutional court was explicitly no longer empowered to review the constitutionality of other constitutional provisions.

The amendment has been challenged before the constitutional court by a group of MPs and the Constitutional court decided on the motion this year. The constitutional court decided to dismiss the motion due to lack of its competence to rule on the challenged issue. However, the court reserved the power to render void such constitutional provisions that would present and extreme and substantial erosion of the democracy and rule of law principle in Slovakia. The pertinent constitutional amendment however remains in force.

2022 was marked by the inability of the Parliament to elect the new Public Defender of Rights. Hence this position has been vacant since march 2022 until December 2022 when the newly elected public defender was sworn in by the speaker of the parliament.

In order to avoid similar situations form occurring in the future, the parliament adopted a constitutional amendment which allows the public defender to stay in the office until the new public defender is elected even after his term of office has expired.

This vacancy caused, that the majority of the public defender's competences have not been exercised almost throughout the whole year 2022. Even though the cases have been analysed and draft been prepared by the employees of the office of the public defender, any findings or recommendations couldn't be communicated to the relevant authorities. This was also the case with the refugee crisis caused by the Russian aggression in Ukraine.

Such uncertainty and inability to decide on the received cases caused a significant drop in the number of cases received by the office of the public defender of rights. In comparison to last year, the number of received complaints has dropped by 50% and in comparison with year 2020 by 60%. It remains unclear yet, weather the Public Defender will be able to regain the lost confidence of the public in a reasonable time span.

Concerning other development, Slovakia still did no establish the National Preventive Mechanism under the UN OPCAT. The proposal has been delivered to parliament in January 2023

Unfortunately, due to the vacant post of the Public defender, majority of the cases have not been communicated to the relevant authorities, or the period for a voluntary implementation of the recommendations has not elapsed yet. Because of this, we are providing some cases or issues opened for longer time that can be considered as systematic flaws. In these cases, the Public Defender is still in communication with the relevant authorities.

1/Case 1751/2021/VOP, concerning the access of the prisoner to a healthcare. Due to a mismanagement of the COVID-19 pandemic, the prisoner didn't have access to the required ventilation and died. Ministry of Healthcare didn't respond to the recommendation of the public defender until today.

2/ Case 1466/2017/VOP, concerning the detention conditions in the Zilina prison. The previous PDR found a violation of art. 3 and 8 of the European Convention. the reconstruction of the pertinent prison is still underway, due to lacking finances.

3/ Case 878/2022/VOP, concerning a secret reasoning of the alien police in its decision not to grant a permanent residence. Such decisions are based on the negative secret service report, which is not disclosed to the public. In these cases, person who receives a negative secret service report doesn't have any practical legal means to oppose such a decision. The secret service and the alien police refuse to alter their practices. Constitutionality of the provision has been challenged before the Constitutional court. the proceedings are still pending.

4/Ministry of healthcare

- lacking guidelines and standards in performing the gender transition,
- no adoption of standards and healthcare procedures in the area of pedopsychiatry and legal framework defining specific rights of psychiatric patients.

5/ Hermanovce city

- did not adopt steps to improve the access to drinking water

6/ Ministry of Education, Science, Research and Sports of the Slovak Republic

- cancel the education of children with a mild degree of mental disability according to "plan A",
- enshrine the definition of segregation in education and the prohibition of discrimination and segregation in the creation of school districts, establish sanctions for its violation,
- ensure the methodology of diagnostic examinations for children coming from the socially disadvantaged environment (Roma communities),
- ensure a sufficient number of teacher assistants in the education of pupils with special educational needs,
- remove discrimination against athletes with mental disabilities and blind chess players when claiming a contribution for achievements in the field of sports

7/Ministry of the Interior of the Slovak Republic

- remove discrimination against men - members of the armed forces included in the special social security system when accessing maternity leave compared to men included in the general social insurance system.
