Josep BORRELL FONTELLES

High representative/Vice-president of the European Commission in charge of coordinating the external action of the European Union. Previously, Mr. Borrell Fontelles was the Minister of Foreign Affairs of Spain (2018-2019) and the President of the European Parliament (2004-2007).



Virginijus SINKEVIČIUS

Currently Commissioner for Environment, Oceans and Fisheries, European Commission, Virginijus Sinkevičius was the former minister of Economy and Innovation of Lithuania (2017-2019) and a former member of the Lithuanian Parliament (2016-2019). As Commissioner, one of his main tasks is ensuring the environment,

oceans and fisheries remain at the core of the European Green Deal, promote international ocean governance and develop a sustainable blue economy. He is also in charge of the Commission's Arctic Policy.

Mr. Andreas Raspotnik is a Senior Fellow and Leadership Group member at The Arctic Institute. His research focuses on European Union Arctic policies, maritime transportation, international law, and new technologies' introduction to the North. He received his jointly awarded PhD in Political Science from the University of Cologne, Germany, and the University of Edinburgh, United Kingdom in October 2016.

Mr. Raspotnik is also a Senior Fellow & Leadership Group Member at The Arctic Institute - Center for Circumpolar Security Studies in Washington, DC, a Senior Researcher at the High North Center, Nord University in Bodø, Norway and a Senior Fellow at the Institute of European Studies (IES), University of California, Berkeley. Mr. Raspotnik is a Member of the Arctic Economic Council's Blue Economy Working Group and was the host of both the Arctic Frontiers Conference 2021 and the High North Dialogue 2021.

Pekka HAAVISTO

Mr. Pekka Haavisto currently serves as Minister for Foreign Affairs, Finland. He was the Minister for Environment and Development in Lipponen's first government (1995-1999). He has also recently served as a Minister for Development and State Ownership in

Katainen-Stubb government (2013-2014).

In autumn 2014, he was appointed as Foreign Minister's Special Representative for African Crises. Before he worked as the European Union Special Representative (EUSR) in Sudan and Darfur (2005-2007) and as a Special Advisor for the UN (ASG) in Darfur peace process (2007). He has also led several missions to conflict areas as the Chairman of UNEP's post-conflict work in 1999-2005.



Robert RYDBERG

Mr Rydberg is the Deputy Minister for Foreign Affairs of Sweden. Between 2015 and 2019, Mr Rydberg was Ambassador to the Italian Republic, the Republic of San Marino, the Food and Agriculture Organization of the United Nations (FAO), the International Fund for Agricultural Development (IFAD) and the World Food Programme (WFP). Previously he was the Deputy Director

General of the Ministry of Foreign Affairs, Head of Department for Middle East and North Africa (2008–2015), Ambassador at the Ministry for Foreign Affairs Africa Department on a special mission for Chad (2007–2008), Ambassador to the State of Israel (2003–2007), Ambassador to the Democratic Republic of the Congo, the Central African Republic, the Gabonese Republic, the Republic of Cameroon, the Republic of Chad, the Republic of the Congo and the Republic of Equatorial Guinea (2001–2003). He also was the Chair of the EU

Committee for Civilian Aspects of Crisis Management (CivCom) in 2001 and the Director, Deputy Head of the Department for European Security Policy (1999–2001).



Thomas WINKLER

Mr. Thomas Winkler is Arctic Ambassador and Head of the Arctic and North America Department at the Danish Ministry of Foreign Affairs. As Arctic Ambassador, he is also the Senior Arctic Official in the Arctic Council for the Kingdom of Denmark. He is a career diplomat and has worked with the Ministry of Foreign Affairs since 1986.

Prior to his appointment as Arctic Ambassador, he worked as Legal Adviser of the Minister (2008-2013), as Danish Ambassador to Russia (2013-2018) and to Canada (2018-2019). Previously, he has also been posted in Kiev and Stockholm. He has an extensive background and experience in Arctic matters. In 2008, he drafted the Ilulissat Declaration, which addresses issues relating to Arctic Ocean jurisdiction, climate change, and maritime safety.



Ólafur Ragnar GRÍMSSON

Mr. Ólafur Ragnar Grímsson served as President of Iceland for twenty years, 1996-2016. Previously, he was Minister of Finance and Member of Parliament. He now serves as Chairman of the Arctic Circle, which he founded in 2013 with various Arctic partners.

Before and after his presidency, President Grímsson worked closely with members of the U.S. Congress and the U.S. Senate as well as with many key members of governments in European countries. He was the

Chairman of a commission established by IRENA on the new geopolitics emerging from global renewable energy transformation. Mr Grímsson served on the Advisory Board of Sustainable Energy for All, created by the United Nations and the World Bank. Mr Grímsson is also involved in international cooperation on the oceans and the evolution of sustainable use of marine resources.



Åsa LARSSON BLIND

Ms. Åsa Larsson Blind is vice-president of the Saami Council. She was the President for the Saami Council between 2017 and 2021.

In June 2019 she was, as first woman, elected chair of the National Sámi Association in Sweden (SSR). Ms. Larsson Blind has been a member of Saami Council since 2008, and elected vice President in 2011. She was also a Saami Council board member of

IPS, Indigenous Peoples Secretariat and Head of Delegation for the Saami Council at Arctic Council SAO meetings. She holds an MSc in Human Resources Management and Development. She has been active in several Sámi organizations in Sweden.



Louise C. FLENSBORG

Ms.Louise Flensborg is a PhD student from Center for Ocean Life, Technical University of Denmark. Her background is marine biology and a strong interest in conservation and biodiversity. Her main area of work is on ecological resilience, structures and functioning of marine ecosystems. She also studies how anthropogenic activity alter ecosystems in the Arctic and has travelled to different areas such as Greenland, Iceland and Svalbard. Furthermore, she has worked at the Natural History Museum of Denmark for 5 years. She

is part of the All-Atlantic Ocean youth ambassador programme as Arctic representative.

Panel "Addressing the climate change and environmental challenges"



Thomas JUNG

Mr Jung is the Vice-Director of the Alfred Wegener Institute (AWI). He is Head of the Climate Dynamics Division at the AWI, Helmholtz Centre for Polar and Marine Research in Germany. He has received his PhD in atmospheric physics from University of Kiel and the Institute for Marine Research (now GEOMAR). He then went on to

work for 10 years in the Research Department of the European Centre for Medium-Range Weather Forecasts (ECMWF) in the UK. He is a professor for physics of the climate system at the University of Bremen. He is an expert in the analysis, modelling and prediction of the climate system. Currently his work is focusing on the development of a new generation Earth system models that effectively and realistically simulate critical processes, such as ocean eddies, along with their impact on climate.

Mr. Thomas Jung is also spokesperson of AWI's research programme. Furthermore, he acts as the chair of various committees, including the Polar Prediction Project of the World Meteorological Organisation. Mr. Jung coordinates major research projects such as APPLICATE, which is funded through the Horizon2020 program, and Advanced Earth System Modelling Capacity, which is funded through the Helmholtz Association.



Florika FINK-HOOIJER

Ms. Florika Fink-Hooijer is the Director-General of the Directorate General for the environment (DG ENV) of the European Commission. She has been working in the European Commission for more than 20 years. Prior to her arrival at DG ENV, Ms. Fink-Hooijer was the Director General at the European Commission's department for interpretation (SCIC) (2016-2020) and Director for strategy, policy, and international cooperation at the Directorate in charge of

humanitarian aid and civil protection (DG ECHO). Before joining the European Commission, she worked for a Dutch Law firm in The Hague and for a German law firm in Berlin.





Dr. Mia Rönkä is the Chair of the Conservation of Arctic Flora and Fauna (CAFF) working group of the Arctic Council. As the CAFF Chair Rönkä is with the Finnish Ministry of the Environment. Rönkä is also Chair of the Circumpolar Seabird Expert Group (CBird) under CAFF. Rönkä is Adjunct Professor at the Biodiversity Unit of the University of Turku in Finland and has addressed environmental topics in her work both as researcher, science writer and poet.

Her specific interest is in multidisciplinary research projects, science-art interface and communications.

Ms. Christel Schaldemose is the S&D coordinator to the Committee on the Internal Market and Consumer Protection in the European Parliament. She is Parliament's Rapporteur on the DSA file and sits on the Special Committee on Artificial Intelligence in a Digital Age (AIDA). She is also a member on the Committee on Environment, Public Health and Food Safety (ENVI) and Chair of the Parliament's Japan Delegation. Christel Schaldemose has been a member of the European Parliament since 2006 and heads the Danish

delegation of social democrats.

Olivier POIVRE D'ARVOR



Mr Poivre d'Arvor, is a diplomat and writer. He was appointed Ambassador for the Poles and Maritime Issues in 2020 and, in this capacity, chaired the 43rd Antarctic Treaty Consultative Meeting in June 2021 and has been designated to prepare the One Ocean Summit due to take place in Brest early 2023. He formerly served as French ambassador to Tunisia (2016-2020),

and director of radio channel France Culture (2010-2015). Since 2014, he has also been chairman of the board of the French national Navy museum.

Olivier Poivre d'Arvor is the founder with Pascal Lamy in 2018 of the World Sea Forum in Bizerte and of the Blue Season (Tunisia).

Jan DUSIK



Mr Dusik leads the sustainable development agenda in the WWF Arctic Programme since 2020. Previously, he was the Principal Adviser for Strategic Engagement for the Arctic and Antarctic at UN Environment. Mr. Dusik has been active in international environmental relations for two decades. He has been heading UN Environment's Europe Office since joining the organisation in summer 2011. Prior to joining UN Environment, Mr. Dusik worked with the Ministry of Environment of

the Czech Republic on managing accession of the Czech Republic to the European Union, coordinated international activities including served as Head of the Delegation of the Czech Republic to numerous meetings of multilateral conventions and international organizations. He was also in charge of the environmental portfolio of the 2009 Czech EU presidency. In

2009-2010 he served as Minister of the Environment of the Czech Republic in the care-taker government. Previously, Mr. Dusik also worked in the Environment Directorate-General of the European Commission in Brussels, handling cases of infringements of EC environmental legislation.



Giulia CASTELLANI

Ms. Castellani is a researcher in ice-ecosystems at the Alfred Wegener Institute Helmholtz Centre for Polar and Marine Research. As a polar scientist she works with sea ice in both the Arctic and Antarctic regions. Her main interest is in the sea-ice microbial ecosystem, in particular on the physical drivers for the spatial variability of sea ice algae. A large part of her work happens in the field, where she collects sea ice samples and

applies newly developed methods to estimate, e.g., sea-ice algal biomass from bio-optical platforms. She also works with sea-ice physical and biogeochemical numerical models with the goal to upscale field results

Ms. Castellani took part in the MOSAiC expedition. In September 2019, the German research icebreaker Polarstern set sail from Tromsø, Norway, to spend a year drifting through the Arctic Ocean - trapped in ice. The goal of the MOSAiC expedition was to take the closest look ever at the Arctic as the epicenter of global warming and to gain fundamental insights that are key to better understand global climate change. MOSAiC is spearheaded by Alfred Wegener Institute, Helmholtz Centre for Polar and Marine Research (AWI).

Michael MANN

Mr. Michael Mann has been the EU's Special Envoy for Arctic matters since April 2020. Prior to that, he was the EU's Ambassador to Iceland. Between 2011 and 2017, he was head of Strategic Communications at the European External Action Service, doubling up as Chief Spokesperson to High Representative/Vice President Catherine Ashton from 2011 to 2014. Mr. Mann worked as a European Commission Spokesperson between 2002 and 2011, covering a wide range of portfolios. He began his career in Brussels as a journalist, working

for the Financial Times, Reuters and Bloomberg News, among other media.



Charlina VITCHEVA

Since 2001, Ms. Retter has worked with Arctic Environmental issues, first at Arctic Council Indigenous Peoples' Secretariat (IPS) (Copenhagen, Denmark) and since 2005 in the present position as Head of Arctic and Environmental Unit of the Saami Council. She has served as a board member of the Sámi University of Applied Sciences (2011-2019) and has served as Member of Saami Parliament (Norway) for two terms (2005 –

2013). In her position as Head of the Arctic and Environmental Unit in the Saami Council, Ms. Retter has been involved in issues related to indigenous peoples and indigenous knowledge related to climate change, biodiversity, language, pollution and management of natural resources.



Nuiana HARDENBERG

Ms. Hardenberg is a member of the Youth Advisory Team of the Arctic Council's CAFF working group which was launched to amplify youth voices and to engage young people in an open and transparent dialogue on the climate emergency.
