The information from Operational Programmes (OPs) and Annual Implementation Reports (AIRs) has allowed the Country Expert to develop Task 1. For Task 2, the Country Expert contacted the Managing Authority (MA) (the Directorate General of Community Funds), the Intermediary Body (IB)/Beneficiary for the national-level OP on the Knowledge-based Economy (the national agency Red.es<sup>4</sup>) and several IBs/beneficiaries in the following regions: Catalonia, Valencia, Galicia and Canary Islands. The stakeholders provided the following documentation and information:

In Spain, only funds made available at national and regional level under Priority Theme Code 13 and Thematic Objective 2 of the European Regional Development Fund (ERDF) have been used in reforming areas of the justice system, according to the available documents and consultation with the MA and the IBs/Beneficiaries. The funding available for Spain under the European Social Fund (ESF) has not been used for investment in the justice system.

Evaluations available for the first programming period (2007–2013) do not report on ERDF investments. As confirmed by all IBs/beneficiaries contacted, final evaluations for the funding period 2007–2013 and interim evaluations for the funding period 2014–2020 had not been carried out at the time of conducting the research. According to the IBs/Beneficiaries, evaluations of the impact of any of the projects funded in 2007–2013 are not foreseen.

In addition to the websites listed above, regional government websites were consulted but, although they usually include a section on European funds, the reports refer back to the documents published on the MA websites. No additional information is provided at regional level.

### Intervention logic 2007–2013

**Needs to invest in the justice system have been identified** in Spain in several documents including the 'Plan Estratégico de Modernización de la Justicia 2009–2012' (Strategic Plan for the Modernisation of Justice 2009–2012, approved in November 2008<sup>7</sup>) and the Programa Nacional de Reformas (the National Reform Programme 2011<sup>8</sup> 2012,<sup>9</sup> 2013<sup>10</sup>). Although these plans do mention the need to modernise the administration of

justice, including upgrading ICTs and the digitalisation of services, the documents **do not refer explicitly to the use of ERDF funding in this regard**.

However, the **National Strategic Reference Framework for 2007–2013 (NSRF)**<sup>11</sup> **does not explicitly mention the need for investing in the modernisation of the justice system**, although it includes a general statement on the need of Spain to increase its use of ICT in the public administration more generally to further align itself with other EU Member States.

This need for the use of ICT in public administration is reflected in one of the national-level OPs – the **OP for a Knowledge-based Economy – and the regional OPs for Valencia, Catalonia and Canary Islands**. Although the OPs do mention the justice system explicitly as being targeted as part of the public administration, the OPs do not provide any further details on planned activities.

However, **although the programming documents in Spain remained quite general and high-level, the OPs did enable the use of ERDF funding to improve and develop ICT in the justice system**. In terms of implementation, projects supporting the justice system were implemented as follows:

- The majority of projects supporting the justice system (46 out of 63 projects) have been financed through the OP on the Knowledge-based Economy (one of the three national-level OPs). The 11 regions that benefited from these projects were Andalusia, Asturias, Canary Islands, Valencia, Galicia, Castilla-La Mancha, Castile and Leon, Extremadura, Murcia and the autonomous cities of Ceuta and Melilla. These projects have been executed directly by the IB/beneficiary, Red.es.
- The remaining projects were funded through the three regional OPs (OPs for Valencia, Catalonia and Canary Islands), which benefited these regions.<sup>12</sup>

These projects implemented in the area of justice have been funded in order to upgrade ICT by purchasing both software and hardware, developing web portals and digitalising the archives and civil registry services for ordering certificates and registering events such as births and deaths. All projects carried out in Spain during the programming period 2007–2013 had multiple final recipients, namely: officials in the regional administrations, especially the Justice Departments of the Autonomous communities, the officials within the Ministry of Justice, officials in Civil Registries (public entities tasked with the registration of vital events such as births, marriages, and deaths), as well as all of the regional courts and tribunals (all types) and the Peace Courts (in particular the Civil Registry function delegated to them).

Once the projects funded under the national OP were finalised, Red.es (the IB and Beneficiary) transferred all the equipment (software and hardware) purchased or developed to the Autonomous Communities. Thus, the ownership of the outputs of the projects funded under the national OP is ultimately with the regions. According to information provided by IBs/beneficiaries contacted by the Country Expert, the **projects funded were not followed up; neither were they evaluated** to measure their results or impacts.

In conclusion, for the first programming period the need for modernising the justice system through digitalisation and ICT was identified. Although the programming documents referred to the need for digitalisation and ICT in the public administration more generally, four OPs mentioned the justice system as one of the administrations to be modernised. Through these OPs 63 projects supporting the justice system were funded. Thus, although

support to justice was not programmed for in a very detailed manner in Spain, the justice system has been supported through ERDF funding.

### Intervention logic 2014–2020

For the funding period 2014–2020, the MA –the Directorate General of Community Funds – established in the ex-ante evaluation to the Partnership Agreement (PA) that there is a **need for modernising digital public services** in the areas of education, health and justice. In this context, the need to invest in modernising the justice system is only mentioned once when setting out the rationale for investing in Thematic Objective 2 (TO2).

These **needs are reflected in the PA**, namely with regard to the administration of justice. The PA also links this need to TO2 for improving the use and quality of ICTs, and states that e-justice will be supported through the OP for Smart Growth (ERDF), specifically extending the use of the electronic judicial record across the country, and in this manner contributing to improving the efficiency of the Spanish judicial system. The PA does not mention the regional OPs in this context.

**Although the PA mentions the OP for Smart Growth as the programme overseeing the justice reforms under TO2, the OP itself does not mention objectives or planned activities in relation to justice.**<sup>13</sup> In terms of implementation at national level, at the time of writing of this report, **no projects supporting the justice system had been funded under this OP.** This is in line with the decision of the government, the MA and the European Commission to invest in other policy areas (i.e. Smart Cities, Education, Healthcare and Small and Medium Enterprises (SMEs)) in Spain, based on identified needs in other areas and limited funds available for the current programming period.<sup>14</sup>

**Catalonia’s OP**, adopted in 2015, mentions e-justice in one of its objectives, namely ‘promoting the concept of open government to improve relations between the administration and the citizens in different areas such as e-health and e-justice’.<sup>15</sup> Specifically, the OP pursues digitalisation, the development of information systems and applications and training that allows for the use of the Electronic Judicial File to be extended, and the improvement of online services for users and professionals.

**Galicia’s OP**, adopted in 2015, establishes that new activities will be undertaken in the area of e-justice with the creation of the Electronic Judicial File for the region. The creation of the Electronic Judicial File aims to reduce the use of paper in the administration of justice and to improve the accessibility to information and services addressed to citizens.<sup>16</sup>

In terms of implementation, the MA and IBs/beneficiaries confirmed that two justice projects are currently in progress funded under the OP for Catalonia and Galicia under TO2, which are in line with what was programmed under these OPs. Both projects are a continuation of investments already carried out in 2007–2013 with the aim of modernising, digitalising and improving the efficiency of the administration of justice in both Autonomous Communities. As per their respective OPs, both projects – ‘Development of the information system e-justicia.cat and modernisation of courtrooms’ in Catalonia and ‘Administration and Electronic Judicial File’ in Galicia – seek the modernisation of the services and procedures carried out by the Departments of Justice in both regions and also the

modernisation and technological upgrading of the regional courts in the Autonomous Communities.

Projects in Catalonia and Galicia are still ongoing, so outputs, results and impacts have not yet been measured. Authorities in Catalonia aim to measure the following outputs on project completion:

- Result indicator (R025C): Percentage of the population using e-government services.
- Productivity indicator (E016): number of users covered by a specific electronic public service.

In Galicia, the following indicators will be monitored:

- Persons (aged 16–74) interacting with the administration of justice via the Internet.
- Judicial bodies covered by the Electronic Judicial File. Expected value between 159 and 198 bodies (out of a total of 260 bodies). The total coverage of 260 bodies is expected by 2023.

Although the **Operational Programme for Andalusia** 2014-2020 does not detail specific plans for investing in the administration of justice, three projects to digitalise and modernise the administration of justice have started in 2016-2017 under TO2. They share some commonalities with the projects developed in Catalonia and Galicia, in particular a project to develop of the Electronical Judicial File. The other two projects are related to de development of ICT management systems in relation to the administration of juvenile justice and the right to free legal assistance. Details of outputs, results and impact expected for these projects have not been provided by the IB/beneficiary, in this case the Andalusian government (Junta de Andalucía).

In **conclusion**, for the second programming period the need to modernise digital public services, including in the justice system, was identified. Although the PA mentions the OP for Smart Growth as the programme overseeing the justice reforms under TO2, the OP itself does not mention any justice-specific objectives or planned activities and up until 2017 no projects supporting the justice system have been funded under this OP. The OPs for Catalonia and Galicia did programme support to the justice system under TO2, and two justice projects are currently in progress. Three more projects are in development in Andalusia, even if the OP does not specify planned activities in the area of justice for the 2014-2020 programming period.

## 2. Funding Period 2007–2013

### 2.1. The needs of the Member State relating to the national justice system

Spain's National Strategic Reference Framework for 2007–2013 (NSRF)<sup>25</sup> highlights Spain's need for improvement in relation to Europe with regard to the penetration of ICTs and establishes that the actions of axis 1 under the ERDF are intended to increase the penetration of ICT in the administration, among other things. Although the NSRF does not explicitly mention the need for investing in the modernisation of the justice system, it has enabled funding for the purpose of improving and developing ICTs in the field of justice. No evaluations have been located to allow the Country Expert to follow up on this issue.

Ex-ante evaluations (including needs assessment) are available for the ERDF in this programming period but do not refer specifically to the justice system. Investments in this area have been allocated under Priority Theme Code 13.

Each year the Spanish government sets out its plans for reform in the **Programa Nacional de Reformas** (the National Reform Programme). Some of these plans, for example Programa Nacional de Reformas 2011<sup>26</sup> 2012<sup>27</sup> and 2013,<sup>28</sup> refer to plans for improving the justice system, although these plans do not link the reforms to allocation of ERDF funding under Axis 4 of the Lisbon Strategy.<sup>29</sup>

Improvements to the justice system set out in the 2011 NRP follow on from the objectives of the 'Plan Estratégico de Modernización de la Justicia 2009–2012' (Strategic Plan for the Modernisation of Justice 2009–2012), approved in November 2008.<sup>30</sup> The strategic plan has the objective of providing Spanish citizens with a justice system that is agile, transparent, responsible and adapted to the constitutional values of the country and the current needs of the citizens. The strategic plan covered different domains organisational, technological, economic, social and normative and had the following overarching aims:

- To achieve an administration of justice that guarantees effective, accessible and speedy judicial protection and that also assures an adequate defence of the rights of all citizens.
- To ensure that the administration of justice is a quality public service, equipped with an adequate organisation, highly qualified professionals and the necessary material and technical means to carry out its mission in an agile, effective, accessible and attentive manner.
- To establish a model of effective cooperation and coordination with all institutions involved in the field of justice and with the international community as a whole.

Underpinning these overarching aims, the plan aimed to achieve the following objectives:

- To facilitate effective access of people to the judicial system.
- To promote and protect human rights more effectively.
- To achieve more transparent justice.
- To improve judicial services for people in vulnerable situations.
- To rationalise the organisation and regulatory framework of human resources in the justice system.

- To achieve a professional and highly qualified justice system.
- To organise the administration of justice effectively and efficiently.
- To consolidate the electronic services of the Civil Registry.
- To develop and to evolve the ICT infrastructure of the Justice System.
- To guarantee inter-institutional coordination and international cooperation.

These objectives, structured around 24 action programmes and 147 activities, are developed through projects and specific activities, provided for in the Immediate Action Plan, whose coordination corresponds to the Commission for Modernisation and Informatics.

Although no reference is made to ERDF funding in the document, Axis III of the strategic plan for 'a technologically advanced justice [system]' overlaps with the initiatives in the area of justice that have been funded through the ERDF Priority Theme Code 13. Axis III of the Strategic Plan for the Modernisation of Justice has the following objectives:

### The Strategic Plan for the Modernisation of Justice, Axis III objectives

Objective	Description
Objective 1	To facilitate the access to judicial information to citizens and professionals
Objective 2	To improve the quality of the service in the civil registries, through the culmination of the Project Registration
Objective 3	To strengthen the functioning of the Public Prosecutor's Office and its coordination with judicial bodies through development of its Information System
Objective 4	To increase the effectiveness and efficiency of the administration of justice through the deployment of the judicial information (management, information and documentation)
Objective 5	To facilitate the communication between different legal entities and operators, ensuring the interoperability of information and communication systems

The Country Specific Recommendations (CSRs) for 2013 stated that there is still scope to improve the efficiency of the Spanish judiciary and that in this context, Spain should "adopt and implement the ongoing reforms to enhance the efficiency of the judicial system".<sup>31</sup>

## 2.2. Planning stage: The extent to which the Member State programmed support to the justice system through ESF and ERDF

### 2.2.1. High-level objectives related to justice set in the programming documents

As mentioned above, the NSRF<sup>32</sup> includes a general statement on the need for Spain to catch up with the rest of Europe with regard to the use of ICT in the public administration but does not explicitly mention the need for investing in the modernisation of the justice system. The NSRF, however, has enabled the use of the funds for the purpose of improving and developing ICTs in the field of justice and this has been taken further in one of the national-level OPs: the OP for a Knowledge-based Economy.

Three ERDF OPs have been included in this chapter for the funding period 2007–2013: the ERDF Operational Programme for a Knowledge-based Economy<sup>33</sup>; ERDF Operational Programme Catalonia 2007–2013 (last valid version, 2015<sup>34</sup>); and ERDF Operational Programme Canary Islands 2007–2013 (both in the initial plan of 2007<sup>35</sup> and last valid version of the plan published in 2016<sup>36</sup>). All other ERDF OPs at national and regional level for the programming period 2007–2014 have been reviewed (using the relevant keyword list) but excluded from the analysis as they did not mention justice<sup>37</sup>. However, most of the detailed information on the use of the ERDF in the area of justice is provided in the Annual Implementation Reports reviewed for Spain. There are eight Annual Implementation Reports (AIRs) available for each region in Spain as well as for each of the national-level OPs.

The tables below list three further OPs for Andalusia, Galicia and Valencia.<sup>38</sup> Although the OPs do not mention projects in the area of justice specifically, relevant operations are subsequently reported in several AIRs for each of these regions. It is important to note that the projects in Andalusia and Galicia have been executed under the national-level OP and not the regional OPs. Nevertheless, the progress of the projects is included in the regional AIRs.

The **OP for a Knowledge-based Economy**, adopted in 2007, establishes under the Priority Theme Code 13 that services related to the administration of justice are a key instrument in the lives of citizens and businesses, requiring numerous procedures and formalities.<sup>39</sup> Incorporating ICT in the administration of justice is crucial for accessing information in a timely and easy manner, while safeguarding personal data. According to

this national-level OP, one of the main objectives under the Priority Theme Code 13 is to achieve the digitalisation of the General Register Office, including the digitalisation of documents.

The **OP for Catalonia** adopted in 2007 does not mention the plans for investing ERDF funding to support the justice system, but an updated version of the OP, adopted in 2015, establishes the development of a new computer system, including infrastructure, applications and content, that allows for the implementation in the region of an online justice office.<sup>40</sup> The objective is to modernise the procedures and improve the efficacy and efficiency in the administration of justice and make communications between the administration, public registers, professionals, external organisations and citizens more agile.

The **OP for the Canary Islands** adopted in 2007 mentions plans for opening up the software system used for the management of human resources in several public administrations, including the regional health system and the Education, Justice and Telecommunications departments.<sup>41</sup>

As stated above, the OPs for Andalusia, Galicia and Valencia do not mention any of the relevant justice-related keywords, but subsequent regional AIRs do mention projects carried out in the area of justice in the three regions. Valencia has undertaken projects under the regional OPs, while Andalusia and Galicia have worked with the IB/Beneficiary at national level (the agency Red.es) to execute projects aimed at modernising the administration of justice through the purchase and development of IT equipment and applications. This is discussed further in section 2.3.

No Action Plans or Annual Work Programmes are available on the website of the Managing Authority, the Directorate General of Community Funds, the central government body responsible for the study, assessment and coordination of how the Community Structural Funds, in particular the ERDF and the Cohesion Fund, are applied in Spain. Ex-post evaluation reports are not available for this programming period on the MA website, although according to the evaluation ex-post evaluations are underway.<sup>42</sup> 'Operational Evaluations' (Evaluaciones Operativas), examining changes to the OPs, do not mention investment plans in the justice system even for the regions that have reported these investments in the AIRs.<sup>43</sup> The Monitoring Committee's project selection criteria for some regions –Catalonia and Galicia – and for projects linked to the OP for a Knowledge-based Economy make reference to the justice system, and this information has been summarised below in section 2.3.1. Other reports by the Monitoring Committee (minutes, activities, evaluation plans and monitoring reports) do not refer to funding allocations to the justice system.

#### 2.2.2. Planned projects listed in the programming documents aiming to support justice

No specific projects are mentioned in the programming documents.

## 2.3. Implementation stage: Support to the justice system through ESF and ERDF

### 2.3.1. Support to the justice system: reported at programme level

No support to the justice system through the ESF has been identified in the research. The ERDF has been used in Spain to support the modernisation of the justice system under Priority Theme Code 13.

#### Note

Based on the research undertaken in Task 2, it has been established that the national Operational Programme on a Knowledge-based Economy has funded regional projects (e.g. in Andalusia and Galicia). However, the progress of these regional projects funded by the national OP has been reported in the AIR of the national OP, as well as in several AIRs of regional OPs (i.e. the AIR for Andalusia and Galicia). It is unclear what the reason is for this way of reporting; however, it could be related to the fact that the same team managed the funding under the regional and national OP (e.g. the Directorate of Financial Policy, Treasury and European Funds for the region Galicia).

The Annual Implementation Report for the OP for a Knowledge-based Economy 2014<sup>44</sup> reports on the programme **Justicia Ius+ReD** (also mentioned in the Annual Reports for the years 2008, 2010, 2011, 2012 and 2013<sup>45</sup>). The objective of the programme was to achieve a high-quality, agile, reliable and technologically advanced public service in the area of justice, in addition to solving some of the bottlenecks and inefficiencies in judicial procedures. The programme is part of the Strategic Plan for the Modernisation of Justice 2009–2012.

The confirmed amount spent in the justice sector reforms according to the AIRs 2009–2014 for the OP for a Knowledge-based Economy was, by 2014, EUR 70,897,849.13.<sup>46</sup> The programme has been implemented as part of a collaboration framework agreement between the Ministry of Justice, Ministry of Industry and Tourism, and the Red.es<sup>47</sup> (the agency in charge of developing the government's digital agenda in Spain) in order to develop digital public services in the justice system and the Civil Register Offices. The regions that have had competences in the field of justice devolved – Andalusia, Galicia, Asturias and Valencia – have also joined the framework agreement to tackle the reforms in the field of the justice system in their territories. According to the 2014 AIR, the programme **Justicia Ius+ReD** seeks the following reforms:

- In the justice system:
  - a. Implementation of the judicial electronic file entails eliminating the use of paper in judicial procedures, as well as presenting documents and accessing the files digitally.
  - b. Updating infrastructure of courtrooms such as audio-visual and videoconferencing systems that are integrated and allow integration with the electronic file system, so recordings can be integrated in judicial procedures.

- c. Reinforcing the central technological infrastructure of the Ministry of Justice, supporting the implementation of the Electronic Judicial File and the new model for Civil Register Offices, and the unified access to the systems that support the administration of justice.
  - d. Implementing the ICT infrastructure, application and capacity in the regions (Autonomous Communities).
- Civil Register Offices:
    - a. Computerisation and digitalisation of peace courts.
    - b. Deployment of self-service electronic kiosks for citizens in the Civil Register Offices, as an additional channel of access to electronic services for certifications, applications, consultation of procedures, etc.
    - c. Support the transition to the new model for the Civil Register Offices by means of analysis, process optimisation, digitalisation, provision of ICTs, capacity development.
    - d. Promotion and capacity development initiatives for citizens and professionals to encourage the use and showcase the functioning of the new system.

In the field of judicial procedures, expenditure that has been verified by the Ministry of the Economy<sup>48</sup> corresponds to the provision of equipment, installing the application 'e-Fidelius' and the coordination of the upgrading of the courthouses and courtrooms in the Autonomous Communities where the Ministry of Justice has competence in the area of the administration of justice (Castilla-La Mancha, Extremadura, Murcia, Ceuta, Melilla and Castile and León). The funding has also been used to index and digitalise judicial files in the fields of social and administrative law. Under the framework agreement with the Autonomous Communities that have been devolved the competence in the area of justice (Andalusia, Galicia and Asturias), the confirmed expenditure covers the activities undertaken in courts and the provision of equipment. In the Autonomous Community of Valencia, projects implemented the application 'Lexnet' for the secure exchange of electronic files among the different stakeholders in the administration of justice (contributing to the Electronic Judicial File), as well as putting in place a system for the management of personal data and unified access to support the administration of justice in the region.

In terms of the reforms of the Civil Registry Offices, the verified expenditure corresponds to the activities of computerisation and digitalisation in peace courts in Andalusia, Asturias, Canary Islands, Castilla-La Mancha, Castile and León, Extremadura, Galicia, Murcia and Valencia, as well as the establishment of self-service electronic kiosks.

The AIR for the OP for a Knowledge-based Economy 2014<sup>49</sup> states that, at central government level, the main activities taken forward in the area of justice under Priority Theme Code 13 are related to the provision of technological infrastructure to the Ministry of Justice and capacity building to support the putting in place of the Electronic Judicial File. At regional level, the following has been achieved by 2014:

- Upgrading courts in Galicia.

- Provision of the infrastructure to implement the Lexnet system in Andalusia.
- Interoperability of the Valencia's Procedural Management System (Cicerone) to adapt the system to the compatibility test with the General Judicial Council and communication with the management system of the prosecution office through the Lexnet system.
- The e-Fidelius system has been deployed in 603 courtrooms of 199 courthouses under the jurisdiction of the Ministry of Justice. Basic implementation per courtroom included: 6 microphones, 1 mixer, 1 camera and 1 personal computer. In total, 1,096 computers, 300 printers and 137 servers have been installed. 13,737 email accounts have been created.
- 45,460 papers, 873 volumes, and 8,890 applications have been digitalised and catalogued.

Although the programme was not mentioned in Galicia's OP for the funding period 2007–2013, according to the AIR for the OP for a Knowledge-based Economy 2014,<sup>50</sup> the programme **Modernización Justicia Galicia** (Modernisation of Justice Galicia) received funds of EUR 17,483.90 in 2014, equivalent to 0.1% of the funding allocated to Priority Theme Code 13 at national level. The activities have been developed through a bilateral agreement with Xunta de Galicia under which EUR 1,950,000 have been allocated to develop digital public services and modernise the administration of justice in the region. The project ended in 2013 with the provision of ICT infrastructure for offices and judicial bodies, through the provision and putting in place of uninterrupted power supply systems, storage, server provision and computer equipment. Also, substantial progress was made in the provision of technological infrastructure to contribute to the development of the Electronic Judicial File, with the putting in place of the Lexnet system. 1,045 PCs and 526 laptops for judicial bodies have been installed, as well as 18 servers and 5 uninterruptible power supply (UPS). In 2013, an extension to the framework agreement was signed to cover all judicial bodies (and not only courtrooms) in putting the programme in place.

The programme **Administración Justicia Andalucía** was not mentioned in the OP for Andalusia for the funding period 2007–2013. However, according to the Annual Implementation Report for the OP on Knowledge-based Economy 2014,<sup>51</sup> in 2013 the Andalusian government (Junta de Andalucía) signed an agreement as part of the Digital Administration Programme including two main activities:

- Implementation of the Lexnet application to enable the electronic exchange of information among the different stakeholders involved in the administration of justice (lawyers, prosecutors, courtrooms and tribunals). The objective is to install the system in all judicial bodies in the region.
- Implementation of a recording system during oral procedures continuing the project started under the programme **Justicia Ius+reD** to extend it to all judicial bodies in the Autonomous Community.

The ERDF has also been used in **Catalonia**, under their regional OP, to support the justice system by developing the following systems, among others:

- Analysis services, technical design and putting in place of 'e-justicia.cat' information system;
- System for managing common legal procedures; Deployment Module procedural common services management;

- System for managing police requirements;
- System for managing features spanning several areas, such as communication with external organisations, electronic signature, and management of legal documents.

The modernisation of the justice system through the creation of the 'e-justícia.cat' platform in Catalonia falls under Axis 1 of the ERDF Operational Programme for a Knowledge-based Economy. The project involved analysing, designing, developing and implementing the new information system and its articulation through various management modules adapted to the new organisational model. One result of this project is the putting in place of the digital judicial file, which allows data transmission of data and documents.

The AIR of the execution of the OP for Catalonia 2014,<sup>52</sup> summarising the activities for the entire funding period 2007–2013, establishes that the total eligible cost for the project is EUR 6.6 million of which ERDF co-finances 50% of the cost. The Department of Justice is both responsible for implementing the project and the beneficiary of the subsidy. The project has been finalised.

The Operations Selection Criteria set out by the Monitoring Committee with regard to the ERDF OP on the **Knowledge-based Economy**<sup>53</sup> has established that actions promoting the effective putting in place of ICT would be part of the effort to achieve a modern and efficient justice service. In particular, there would be actions aimed at completing the process of modernisation and digitalisation the Civil Registry Offices and peace courts, as well as activities aimed at achieving more efficient procedural management and more agile access to information by the courts, court professionals and citizens.

According to the Selection Criteria, actions would have to involve comprehensive projects that ensure a real modernisation of the administration of justice, such as the provision of necessary ICT equipment, applications and services, as well as other actions necessary to put this in place, such as the revision of procedures and processes and training in the use of the implemented solutions. The project would fall under the following streams:

- Peace courts that lack the appropriate technological infrastructure (equipment, connectivity, specific applications, etc.) for its digitalisation.
- Civil Registries and Peace Courts with manual process for the inscriptions in books, especially those subsequent to 1950. They would carry out digitalisation and recording of all the books of the Civil Registry, among others.
- Integration of information technologies to streamline the electronic processing of all the procedures of the Civil Registry, also facilitating electronic access by citizens, administrations and other Public Institutions.
- Courts and Tribunals with management of paper judicial files.
- Interoperability between the different systems that work in the area of justice across the country.
- Putting in place of the Electronic Judicial File.

The Operations Selection Criteria document related to the ERDF OP for the region of **Galicia**<sup>54</sup> sets out the following requirements:

- Planning, development and installation of systems and tools for the configuration of the Electronic Judicial File.

- Development and installation of systems and tools for digitalisation, document management and electronic archiving of the Electronic Judicial File.
- Development and installation of systems and tools for integration into the 'EJIS' (Spanish acronym for the Judicial Interoperability and Security Scheme).
- Creation and integration of content in the 'eXustiza' ('e-justice' in Galician) portal, for the information and provision of services related to justice.
- Development and or installation of systems for the electronic exchange of information between the different agents involved in the judicial processes and procedures.
- Creation of collaborative spaces and digital tools for the promotion of information, knowledge and documentation among professionals from the different areas of the public administration.
- Training of agents involved in the judicial process in the knowledge and use of electronic administration systems and tools.
- Digital accreditation of public employees.

The Monitoring Committee's Operations Selection Criteria for **Catalonia**<sup>55</sup> sets out actions in the area of justice involving the provision of a new computer system (infrastructures, applications and contents) that would allow the modernisation of the administration of justice and the establishment in Catalonia of a digital judicial office to increase the levels of efficiency and efficacy in the administration of justice, and streamline communications between administrations at regional and national level, public registries, law professionals, external entities and citizens. Potential beneficiaries include: public administrations, judicial bodies, service providers, law professionals and citizens in general.

Although **Andalusia's** and **Valencia's** selection criteria documents do mention that projects related to justice are eligible for funding, they do not specify the requirements that projects need to meet to receive funding.<sup>56 57</sup> The Operations Selection Criteria for **Canary Islands** does not mention requirements for projects related to the area of justice.<sup>58</sup> All other regions have not stated in their OPs or AIRs any activities in the area of justice being funded through the ERDF, although, as discussed above, some regions have benefited from investment in the justice system under the national OP on a Knowledge-based Economy.

### 2.3.2. Support to the justice system: reported at project level

Although the programming documents in Spain remained quite general and high-level in their description of planned reforms in the area of justice, the OPs did enable the use of ERDF funding to improve and develop ICT in the justice system.

No calls for proposals have been issued with regard to justice projects. Instead, the national agency Red.es has reached framework agreements with the Autonomous Communities to fund digitalisation and ICT projects in the area of justice. As the Autonomous Communities are part of the public administration, it was not considered necessary to set up calls for proposal as they do in other areas (e.g. SMEs).<sup>59</sup>

Red.es was set up in 2002 with the aim of executing and implementing the Digital Agenda of Spain and converging with Europe in the modernisation of public services and development of the digital economy. Red.es is both the IB and the beneficiary for projects funded under the national OP for Knowledge-based Economy 2007–2013.

According to information provided by Red.es, in April 2010, the Spanish Government authorised a framework agreement between the Ministry of Justice and the Ministry of Industry, Tourism and Trade through which the public agency Red.es would develop digital public services in the area of the Administration of Justice. This framework agreement set up the 'Ius+ReD' (justice and net) programme to implement the technological development envisaged in the Strategic Plan for the Modernisation of Justice 2009–2012.

Although no selection criteria were used in the Spanish context in the strict sense, as explained above, the framework agreement established the possibility that the Autonomous Communities in Spain to which Justice competences have been transferred<sup>60</sup> (although in different degrees) could sign their own collaboration agreements to co-finance projects that fulfil the following criteria: 1) projects to technologically upgrade and modernise judicial procedures, 2) projects implementing systems that allow the interoperability of systems used across the country and 3) projects improving communication across the country. Regions with no justice competences<sup>61</sup> have also received funding to upgrade their justice systems if they were convergence regions (Castilla-La Mancha and Extremadura), phasing-out regions (Murcia, Ceuta, Melilla) or phasing-in regions (Castile and Leon). Competitiveness Regions with no justice competence (in this case only Balearic Islands) were not eligible for funding.

The projects were directly executed by Red.es and, once the projects were completed, the outputs of the projects were transferred to the regions. The investment and specific coverage of each project has been agreed under the following tri- or multi-lateral agreements between Red.es and several regions in Spain:

- **Project Digital Justice Administration:** Collaboration agreement with Government of Andalusia included in the Digital Justice Administration Programme, set in the 'Digital Agenda for Spain'.
- **Projects under the Nationality Dossiers operation, the Computerisation and digitalisation of Peace Courts operation, the R&D Peace Courts operation, the IUS+ReD operations:** Framework Collaboration Agreement between the Ministry of Justice and the Ministry of Industry, Tourism and Trade for the development of digital public services in the scope of the Justice Administration, Programme 'Ius+reD'.
- **Projects under Ius+reD Trilateral operations:** Trilateral Collaboration Agreement between the Ministry of Justice and the Justice Department of the Regional government of i) Andalusia, ii) Asturias, iii) Valencia, and iv) Galicia for the development of digital public services in the scope of the Justice Administration, Programme 'Ius+reD'.
- **Project Procedural Management System:** Collaboration Agreement between the Ministry of Justice and the Regional government of Galicia for the strategic coordination and development of advanced services in the scope of ICT in the administration of Justice.

- **Project Justice Integrated System:** Framework Collaboration Agreement between the Ministry of Justice and the Ministry of Industry, Tourism and Trade for putting in place modules of the Justice Integrated System (JIS).
- **Project Modernisation of Justice:** Collaboration Agreement with the Regional Government of Galicia for the development of actions in the Region of Galicia aimed to introduce digital services in the scope of the administration of Justice.
- **Project Online Civil Register:** Framework Collaboration Agreement with the Ministry of Justice establishing the programme 'Online Civil Register' included in the Plan Avanza (Go forward Plan).

Table 3 provides an overview of all projects implemented that supported the justice system. All projects funded between 2007 and 2013 have been closed. Although several regional governments in Spain have been the beneficiaries of the projects, and they had the possibility of funding projects related to justice through the regional OPs, most of the projects were funded under the national OP for a Knowledge-based Economy. In total 63 projects have been carried out in Spain. Of these, **46 projects have been implemented by Red.es under the national OP for a Knowledge-based Economy**. The Valencia region, Canary Islands and Catalonia have also carried out projects under the regional OPs: **15 projects have been implemented under the OP Valencia 2007–2013, 1 under the OP Canary Islands 2007–2013, and 1 under the OP Catalonia 2007–2013.**

### **Project activities undertaken related to support to justice**

As presented in Table 6, the ERDF has mainly been used to fund the following types of activities in the field of justice:

- Upgrading courts technologically: new systems to integrate the regional justice system to communicate with the national system; audio-visual and video-recording equipment to record all oral procedures in regional courts (including first-instance, criminal, violence against women, family, administrative, and social courts);
- Digitalising the services provided by the administration of justice through an e-justice web portal;
- Digitalising archives (in particular Civil Registers);
- Digitalising civil registry services (e.g. procedures for ordering certificates and registering events such as births and deaths);
- In some cases, training in the use of the new systems has been provided to officials in the courts.

The majority of projects funded multiple activities and nearly all aimed at modernising the administration of justice by technologically upgrading courtrooms and other judicial bodies (and were therefore recorded under 'Digitalisation of court services' and/or 'Purchase of ICT systems'). Thus, most projects have the purchase of software, hardware, or the development of an ICT system as one of their main activities.

In 11 projects, the funding was also used in the provision of training for civil servants in the use of new technologies (categorised as 'Training' below'). In 22 projects, ERDF funds have been invested in projects to digitalise the regional Civil Registries archives and services (registration of citizens' vital events, such as births, deaths, marriages. These have been recorded as 'other' in Table 6. The other three times that the activities have been recorded as 'other' in Table 6 are for:

- one project implemented in Valencia with the aim of recruiting personnel to implement the projects funded by the ERDF in the area of Digitalisation and ICT of the justice system
- two projects implemented in Valencia to assess to what extent the new data protection legislation was met by current systems and, in case of non-compliance, to develop a plan to meet the requirements in both existing and new ICT applications.

### **Project final recipient related to support to justice**

All projects funded in the period 2007–2013 in Spain under the national OP on a Knowledge-based Economy had multiple recipients. In 19 projects the final recipients were officials in courts and tribunals (including: first-instance, criminal, violence against women, family, administrative, and social courts). In 23 projects, final recipients were officials within the Ministry of Justice at national level. In 26 projects, final recipients were officials working in Civil Registries or in Peace Courts, but carrying out the Civil Registry competences delegated in them (and thus categorised as 'Registry offices'. In eight projects, final recipients were the officials working in the regional administration (Justice Departments of the Autonomous Communities). For 16 projects information was not provided by the beneficiaries.

### **Project outputs, results and impacts related to support to justice**

According to the IB/beneficiary of the projects implemented under the national OP for a Knowledge-based Economy, no evaluations of the projects supporting the justice system were conducted as such in the 2007–2013 programming period. Moreover, no specific monitoring of the projects financed through ERDF has been conducted. Instead, only overall investments (beyond ERDF) to modernise the public administration in Spain more generally (beyond justice) have been monitored. No evaluations for the regional OPs have been found or provided by the MA or IBs/beneficiaries of these OPs.

For the national-level OP, the agency Red.es has focused on process indicators and did not set result or impact indicators for the projects implemented under the national OP for a Knowledge-based Economy that are relevant to the study. The output indicators set for the projects developed under the Knowledge-based Economy OP and their reported values are presented in Table 8. As shown in Table 8, the output indicators for the OP on a Knowledge-based Economy measure the number of judicial bodies peace courts and courtrooms – that have had their ICT systems upgraded, and thus have been modernised, and the judicial bodies that now have access to broadband.

As other output indicators reported in the relevant programming documents and AIRs under the national OP do not fit the categories of output indicators used for this study, they have not included in the table below. Instead these indicators measure the number of Register Offices and Peace Courts that have been digitalised or the number of pieces of equipment or software licences bought.



In terms of the regional OPs, indicators for the Valencia Region OP measure the output of projects in terms of general employment and employment for women. The OP for Catalonia measures the number of new ICT systems that have been implemented in courts, and the number of civil courts where the civil procedure has been implemented. No result or impact indicators for the regional OPs has been found or provided by the MA or IBs/beneficiaries of these OPs.

Table 8 presents the two indicators that did fit the study indicator categories.

#### 2.5. Budget information

Overall budget information for projects supporting the justice system funded through the ESF and ERDF was generally available. However, there is no universally accepted taxonomy for project budget owners to classify budgets according to type of activity or final recipient. Moreover, many projects involve multiple activities and/or multiple final recipients. Whether and how budgets for these complex projects are analysed by activity or final recipient varies across project owners and countries. This militates against using reported data to make meaningful comparisons between projects and Member States.

For the purpose of this study, the researchers have therefore created a high-level taxonomy in order to enable an analysis of budget allocations for activities and final recipients of the identified projects funded through the ESF and ERDF supporting the justice system. Information from interviews and documents has been used to apply this taxonomy and allocate budgets based on the main focus of the projects as well as the final recipients.

In cases where it has not been possible to determine budget allocations for projects with **multiple final recipients**, these have been classified as 'multiples' (further details and explanations have been provided in the text below). Where a project had **multiple activities** and/or included activities which did not fall under one of the focus categories, the categorisation of that project reflects its aim and not necessarily all individual activities undertaken in the context of this project. This approach is further explained in the Final Report.

In terms of final recipients, as shown in Table 13, multiple recipients are: 1) officials in regional justice administration and in courts and tribunals; 2) officials in the Ministry of Justice and in courts and tribunals; or 3) officials in the Ministry of Justice or in Civil Registries.

### 3. Funding Period 2014–2020

#### 3.1. The needs of the Member State relating to the national justice system

In a similar way as with the programming period 2007–2013, only the ERDF funding is used or can be used for interventions related to the justice system under Thematic Objective 2 for the period 2014–2020. The ESF is not used for investment in this field as no funds have been allocated to Thematic Objective 2 (TO2) or Thematic Objective 11 under the Fund.

In the ex-ante evaluation to the Partnership Agreement (PA), the Directorate General of Community Funds establishes that there is a need for modernising digital public services in the areas of education, health and justice.<sup>64</sup> In this context, the need to invest in modernising the justice system is only mentioned once when setting out the rationale for investing in TO2. It is necessary to note that the main objectives in achieving this goal through the investment provided by the European funds are to increase productivity, competitiveness and promote employment in Spain and its regions. To achieve these overall objectives, investment of European Funds is concentrated on a limited number of priorities to try to achieve a greater impact.<sup>65</sup>

The ex-ante evaluation of the PA<sup>66</sup> refers to a broad set of needs to reform the justice system; for example, improving the quality, independence and efficiency of the judicial systems, seeking the professionalisation of the judicial career; new organisation of the judicial system and case allocation; reform of the court fee system; and enhancing the out-of-court settlement of disputes. However, the PA makes no reference to the issues mentioned above and instead focuses on the modernisation of the public administration, including the administration of justice, through the use of ICTs under Thematic Objective 2 (TO2).

The same document discards that the objectives sought in the area of modernising the administration of justice should be financed under Thematic Objective 11 (TO11). TO11 has received no funding in the period 2014–2020. TO2 has received most of its funding under the ERDF and in a lesser extent through the European Agricultural Fund for Rural Development (EAFRD).

The 2014 Country Specific Recommendations (CSRs) stated that Spain should “remove remaining bottlenecks in the corporate insolvency framework, in particular by enhancing the expertise of insolvency administrators and the capacity of the judicial system to handle insolvency cases, and develop a permanent framework for personal insolvency, paying due attention to balanced creditor/borrower rights and financial stability considerations” and “adopt pending reforms on the structure of the judiciary and on the judicial map and ensure implementation of adopted reforms”.<sup>67</sup>

The recitals of the 2015 CSRs underlined the “limited progress was made with regard to the adoption of judicial reforms aimed at improving the effectiveness of the justice system”, but no justice-specific recommendations were included.<sup>68</sup>

The European Commission's recommendation issued prior to the abovementioned Council Recommendation on the 2015 National Reform Programme of Spain mentions the progress made by Spain in implementing the recommendations of the committee for the reform of public administration at all levels of government (Recital (16), pages 5–6).<sup>69</sup> Recital 16 of the European Commission's recommendation also mentions that "limited progress was made with regard to the adoption of judicial reforms aimed at improving the effectiveness of the justice system: draft laws on the judiciary and on civil procedure, which include some reforms, were submitted to Parliament on 27 February 2015; draft bills on legal aid and on voluntary jurisdiction are subject to parliamentary procedure. Some progress was made in implementing the reforms that have been adopted, including the Oficina Judicial, the reform introducing the digitalisation of justice and improving the interoperability of regions' electronic case management systems. Efforts need to be continued in this area".

Based on the above, it can be confirmed that EC recommendations on the adoption of judicial reforms aimed at improving the effectiveness of the justice system have been addressed through the use of ERDF funds.

The recitals of the 2016 CSRs mentioned that "efficient justice", among other things, could "spur aggregate productivity" of the economy in Spain, but no justice-specific recommendations were included.<sup>70</sup>

### 3.2. **Planning stage:** The extent to which the Member State programmed support for the justice system with ESF and ERDF

#### 3.2.1. High-level objectives related to justice set in the programming documents

In Spain, only the ERDF has been programmed to support reforms of the justice system under TO2. The PA<sup>71</sup> builds on the 2014 National Reform Programme for Spain (PNR) establishing five priority areas for reform:

- fiscal consolidation to favour growth;
- restoring normal lending conditions to the economy;
- promoting current and future growth and competitiveness;
- fighting against unemployment and the social consequences of the crisis; and
- modernising the public administration.

According to the PA, given that education, health and justice represent around 10% of Spanish GNP, the smart use of ICTs in these areas could bring about a substantial improvement in the quality of their services, considerably boosting the efficiency of the public sector.

These measures are at the same time based on the Annual Growth Survey (AGS) 2014<sup>72</sup> and are in line with the objectives set out in the Europe 2020 Strategy. Under objective AGS 5 'Modernising public administration' the PNR for Spain establishes three axes:

- Axis 1: Rationalising and eliminating duplications;
- Axis 2: Transparency and trust in institutions; and

- Axis 3: Administration of justice.

Axis 3 seeks to achieve reforms that should be able to provide the judicial system with greater efficiency, agility and flexibility in order to speed up delays in the resolution of litigation processes. According to the PA, this Axis is linked to TO2 for improving the use and quality of ICTs and through the Operational Programme for Smart Growth the ERDF should support the use of e-justice, specifically extending the model of the electronic judicial file, and in this manner contributing to improve the efficiency of the Spanish judicial system.

According to the PA, in the justice systems, efforts would be made to support the technological modernisation of the system through digitalising a large proportion of its resources, facilitating the redesign and digitalisation of the processes, interconnecting the systems used by the different agents who participate in this field, and tackling the interoperability of the different solutions that are already in use.

### Operational Programmes that explicitly mention justice

As with the previous programming period, only some of the national and regional ERDF OPs include specific investment, improvements or reforms in the justice sector for the programming period 2014–2020. All other ERDF OPs at national and regional level for the programming period 2014–2020 have been reviewed (using the relevant keyword list) but excluded from the analysis as they did not mention any foreseen activities in the area of justice<sup>73</sup>).

The tables below list the ERDF OPs that include the justice sector in their funding plans (the remaining national and regional plans have been reviewed and excluded as they were not relevant):

Although the PA mentions the Operational Programme for Smart Growth as the programme overseeing the reforms under TO2, this OP does not mention specific uses or objectives in relation to justice.<sup>74</sup> Regional Operational Programmes also discuss the aims of TO2; however, only a few of them set out their actual plans in the area of e-justice. These are Catalonia, Galicia and Valencia.<sup>75</sup> In the case of Andalusia, the term "justice" is only mentioned in a table describing sub-priority axis 078 (services and applications of the electronic public administration). There are no detailed plans for activities in the area of justice developed in the OP.<sup>76</sup>

**Catalonia's** Operational Programme, adopted 2015, has selected as one of its objectives under TO2 'promoting the concept of open government to improve relations between the administration and the citizens in different areas such as e-health and e-justice or emergency control, among others'.<sup>77</sup> Catalonia's OP establishes that the actions in the field of e-justice seek to improve the administration of justice through the use of ICTs. Specifically, the OP pursues the development of information systems and applications, digitalisation projects and technological endowment and training that allow for extending the use of the electronic judicial file, and improving the processing and setting up of online services for users and professionals. The plan establishes two main actions: the development of the 'e-justicia.cat' information system and the refurbishment of courtrooms.

In the area of e-justice the plan seeks to:

- develop functionalities in the field of civil law;

- develop online procedures for matters of social law;
- develop the first instance and second instance of criminal law; and
- modernise courtrooms through the use of new technologies such as systems to record trials.

The main jurisdictions covered include: provincial hearings and prosecution services and common civil enforcement proceedings (including civil hearing). Any intervention in the area of electronic justice should ensure compatibility and interoperability with other systems and applications used by the justice system in Spain.

**Galicia's** Operational Programme, adopted in 2015, establishes that new activities will be undertaken in the area of e-justice (**Plan e-Justicia**) with the creation of the electronic judicial record with the aim of improving access to information and reducing the use of paper, adapting the registration system and procedural processing to the needs of the Administration of Justice in Galicia and the development of services offered to citizens.<sup>78</sup> According to the OP, the e-Justicia Plan also foresees the development of services aimed at citizens and groups of professionals in Galicia through an Internet justice portal. By 2020, 100% of all judicial bodies (260 in total) would be covered by the electronic judicial file system. An integrated system for managing the judicial procedures would be developed to incorporate the systems of the different agents involved in this area, guaranteeing interoperability with the technological solutions that currently exist, both at regional and national level.

The Operational Programme of the **Valencia** region, adopted in 2015, establishes that one of the strategic objectives seeks to strengthen the e-government through promoting the electronic administration, in particular the administration of justice and the re-use of public sector data (open government and open data).<sup>79</sup> According to the OP, by the time the second funding period was launched, existing digital infrastructures and information systems in the area of justice did not allow electronic processing of court proceedings, since only 7% of courts had a connection to more than 30 Mbps, and there was no interoperability between the different systems across the administration of justice. Specifically, it is expected that the investment in the area of justice will achieve the following aims:

- To have adequate ICT equipment and infrastructures in all judicial offices, in order to be able to implement a system allowing the electronic processing of procedures.
- To implement the Electronic Judicial File.
- To allow citizens and professionals to interact with the administration of justice through an online portal.
- To develop and implement a system that allows the processing all transactions electronically, eliminating the use of paper in the administration. This includes the putting in place of digital forms, electronic signature and other digital tools.
- To implement a system for the management and storage of electronic documents while they are still active and when they need to be archived. The systems will allow for the secure exchange of information between the different levels of the administration.
- To implement the access by professionals to the recordings of judicial acts through the portal of the administration of justice.
- To implement in all the bar associations of the Valencian Community an expert system for the automatic pre-evaluation of files and to start to define a model and

protocol of communication of the justice system and the procedural management system.

The Operations Selection Criteria in Catalonia<sup>80</sup> establish that the objective in the field of e-justice is to improve the administration of justice through ICT, as well as to promote the development of products and services for the same by the ICT industry. Information systems and applications would be developed, and digitalisation, technological endowment and training projects would be carried out to allow the extension of the Electronic Judicial File, and improve the processing and introduction of online services for users and professionals. Specifically, two actions are considered: the development of the 'e-justicia.cat' information system and improving facilities in the courtrooms. Specific actions include:

- Development of a communications platform for agents across the justice system.
- System functionalities still to be developed in the civil and criminal law (first and second instance), as well as transversal modules. Developments of the first instance of the criminal area.
- Modernisation of courtrooms by incorporating new technologies such as trial recording systems.

The jurisdictions covered include: provincial hearings and prosecution of the provincial hearing, common civil enforcement proceedings (including civil hearing), among others. Any intervention in the area of electronic justice should ensure compatibility and interoperability with other systems and applications used in Spain in the administration of justice.

The operation selection criteria for Galicia<sup>81</sup> require that beneficiaries receiving funding in the area of justice are agents within the public administration. According to the document, selection would be carried out following public procurement management rules of transparency, competence, objectivity, equality and non-discrimination. Selected operations would be those that are aligned with Galicia's Digital Agenda 2020, the Spanish Digital Agenda and the European Digital Agenda, as well as projects aligned with the Europe 2020 Strategy. Operations should be technically and financially sustainable and should be geared towards improving the efficiency and quality of management for businesses and citizens and reducing costs. Potential operations receiving funding should be:

- Projects whose impact is more relevant in terms of the number of users they will benefit, and for reaching disadvantaged groups and contributing to the development of sustainable models for the provision of public services.
- Projects with a good coverage of the territory and sustainable over time.
- Projects that improve user confidence in e-government services and digital public services.
- Interoperability of systems and technical platforms and compliance with national and international standards, particularly in terms of accessibility, safety and quality.
- Systems and platforms that comply with the current European, state and regional regulations in this area.

Operations Selection Criteria for the ERDF OP for Andalusia, establishes the possibility to fund actions that promote the supply of digital public services in all areas (agricultural, environmental, cultural, educational, tourism, health and justice, among others) and improve their efficiency through smart development models. According to the selection criteria, actions include the development of the electronic judicial file and the promotion

of an integrated procedural management system among other development areas related to the public administration as a whole.<sup>82</sup>

smart development models. Operations Selection Criteria for the ERDF OP for Valencia are not available online,<sup>83</sup> while the Operations Selection criteria related to the ERDF OP for a Smart Growth do not refer to actions in the field of justice.<sup>84</sup>

No Action Plans or Annual Work Programmes are available on the website of the Managing Authority, the Directorate General of Community Funds. Evaluation Plans and Monitoring Committee Documents available online up until June 2017 for the funding period report on the reforms being undertaken in the area of justice.

### 3.2.2. Planned projects listed in the programming documents aiming to support justice

No projects were mentioned in the programming documents.

## 3.3. Implementation stage: Support to the justice system through ESF and ERDF

### 3.3.1. Support to the justice system: reported at programme level

According to the evaluation plan for the second funding period, no evaluations relating to the OPs have been conducted to date.<sup>85</sup> The available AIR for the year 2015 for Galicia's OP reports that, so far, in the putting in place of the Electronic Judicial File, the online justice portal and other digital tools for the administration of justice, an estimated amount of EUR 4,032,000 has been allocated.<sup>86</sup> In the AIR for Valencia's OP 2015, it is stated that a budget of EUR 7,160,000 has been allocated for contracts in the areas of digital administration, open government and justice.<sup>87</sup>

### 3.3.2. Support to the justice system: reported at project level

Although justice is an area that has been included in the OP for Smart Growth, the IB in charge of implementing the projects under this OP, the agency Red.es, has confirmed that no ERDF funding has been allocated to new justice-specific projects at national level up to July 2017. The areas for investment agreed between the Spanish authorities and the European Commission are Smart Cities, Education, Healthcare and SMEs.

At regional level, there are currently two projects ongoing: one in Catalonia, 'Development of the information system e-justicia.cat and modernisation of courtrooms' – and one in Galicia, 'Administration and Electronic Judicial File'. Both projects are funded under the regional OPs – Catalonia ERDF 2014–20 OP and Galicia ERDF 2014–20 OP – reviewed under section 3.2. These projects are further outlined in the table and text below.

The projects have been selected using the programme selection criteria included in the following two documents:

- **'ERDF Operational Programme 2014–2020 for Catalonia. Criteria and Procedures for the Selection of Operations'**<sup>88</sup>: establishes that the objective

In the case of Galicia, there is an official request of the agency AMTEGA (Axencia Galega de Modernización Tecnolóxica) to the regional government (Xunta de Galicia) – the IB for the 2014–2020 OP in Galicia – to receive ERDF funding to continue with the modernisation of the administration of justice started in the programming period 2007–2013 under the national OP (Knowledge-based Economy) by upgrading systems and ICTs, as per the selection criteria document mentioned above.

### **Project beneficiaries**

The Catalanian Government (Generalitat de Catalunya) is the IB/beneficiary for the project being implemented in Catalonia – ‘Development of the information system e-justicia.cat and modernisation of courtrooms’ – for the programming period 2014–2020, according to the information provided by the regional authorities. The project seeks to improve the administration of justice through ICTs, as well as to promote the development of products and services for the administration of justice by the ICT industry.

The regional government of Galicia is also IB/beneficiary of ERDF funding to modernise the administration of justice. The ongoing project – ‘Administration and Electronic Judicial File’ – aims at the modernisation of the services provided by the administration of justice in the Autonomous Community.

As in the previous projects, the Andalusian government is the IB/beneficiary for the projects being implemented in the region. The three projects fall under the operation ‘Agenda for a Digital Justice in Andalusia 2020’ and they aim at 1) develop an information system for the management of the right to free legal assistance; 2) develop a juvenile justice management information system; and 3) develop and implement of a Procedural Management System and the Electronic Judicial File.

### **Activities of projects in tendering process and of ongoing projects related to support to justice**

As explained above, all projects seek to upgrade the ICTs used in the administration of justice, especially through the purchase or development of systems or equipment and digitalising services and procedures.

In Catalonia, under the project 'Development of the information system e-justicia.cat and modernisation of courtrooms', new information systems and applications will be developed with the aim of: 1) extending the Electronic Judicial Record, by improving the processing and setting up of online services for users in the regional administration (Justice Department and officials in civil and social courts); 2) further developing the 'e-justicia.cat' information system, an online portal for the administration of justice in Catalonia, and 3) the technological upgrade of regional courts. Activities to be carried out include digitalisation of files and procedures, technological endowment and training in the use of the new systems for public officials. Specifically, the activities to be developed include:

- new system functionalities to be built for courts dealing with civil matters (details on the functionalities have not been provided);
- telematic processing of files and communications of courts dealing with social matters;
- development of digital services for criminal courts of first instance;
- development of digital services for criminal courts of second instance; and
- modernisation of courtrooms by incorporating new technologies such as audio-visual and video-recording systems for hearings.

According to the information provided by the Generalitat de Catalunya (Catalonia's government), any intervention in the area of electronic justice must guarantee compatibility and interoperability with the other systems and applications used in Spain by the justice administration.

In Galicia, the project 'Administration and Electronic Judicial Record' has as its main activities 1) the development and setting up of information systems for the operation, dissemination and installation of the Electronic Judicial Record, 2) the development of the Electronic Judicial Office (web portal) to provide digital services citizens, professionals and civil servants interacting with the administration of justice in Galicia. The modernisation of the administration of justice covers the prosecutor's office, courtrooms, archives, repositories, declaration rooms, and other locations where digital services are set up.

In Andalusia, there are currently three ongoing projects that started between 2016 and 2017. All projects are part of the actions foreseen in the Agenda for a Digital Justice in Andalusia 2020, and they are being implemented in order to effectively manage the judicial processes, streamline communications between the judicial bodies and bring the Administration of Justice closer to the citizens.

The **Juvenile Justice** project is expected to increase the percentage of minors' family members who interact with the centres electronically. It is expected to cover 100% of the targeted population (the group of juvenile offenders who are subject to judicial measures). The main objectives of the project are to:

- Implement the "Single Electronic File of the Minor Offender", which includes in an integrated manner all the actions, measures, psychosocial reports, follow-up evaluations of the measures, imposed to each minor, guaranteeing an agile, secure and pertinent access of the different stakeholders (juvenile judges, juvenile prosecutors, psychosocial technical teams, public administration, etc.)
- Implement the operating processes and services that the Public Administration develops in the field of Juvenile Justice to improve its internal management and increase its productivity.
- Strengthen the e-Government in matters of Juvenile Justice by creating new channels of interrelation between the administration and the professional groups

involved (Juvenile Courts, Juvenile Prosecutor's Offices, in charge of providing services that support compliance with the measures imposed, etc.)

- Provide top management with effective decision-making support mechanisms related to the efficient use of public resources dedicated to Juvenile Justice.
- Contribute to the public transparency model by improving access to information, dissemination and opening of public data in the area of resources dedicated by the Andalusian Public Administration to Juvenile Justice.

The **Free Legal Assistance** project aims at contributing to increase the percentage of citizens who interact with the administration through the Internet, specifically the beneficiaries of Free Legal Assistance and for the professionals responsible for providing the service. The main objectives of this project are to:

- Implement digital operational processes and services that the Public Administration develops in the field of free justice to improve the internal management and thus increase productivity.
- Expand the number of digital services that the Administration offers and make available to citizens and professional groups in this area and improve existing ones.
- Strengthen the e-Government in matters of Free Justice by creating new channels of interrelation between the administration, citizens and the professional groups involved.
- Provide top management with effective decision-making mechanisms related to the efficient use of public resources dedicated to Free Justice.
- Contribute to the public transparency model by improving access to information, dissemination and opening of public data in the field of free justice.

The largest of the three projects is the project "**Development and implementation of the Procedural Management System and Electronic File**". Similar to the projects in Galicia and Catalonia described above, the main objectives of the project are:

- The acquisition of infrastructure for the new Procedural Management System and Electronic Judicial File.
- The development and implementation of the new Procedural Management System and Electronic Judicial File. The necessary actions will be executed to comply with the specified objectives, that is, a new Procedural Management System will be built and implemented, whose outstanding features are: centralised, modular, integrated system, with electronic judicial file management capacity, task control based on permissions, guided milestones during the processing of procedures, automatic generation of documents based on templates, inclusion of parameterisable query modules to facilitate internal management and the provision of data required during inspections, document management and custody policy.
- The creation of an Office to manage projects, quality and security: this will allow, through an ICT office, the management of the projects aimed at the transformation of Justice in Andalusia in the period 2016-2020 and the necessary measures of quality assurance and security, as well as technical, functional and change management support.
- The development and implementation of a digital signature services platform for the new Procedural Management System and the other information systems for the Justice Administration in Andalusia.
- The development of a management system for judicial, digital and paper files.

As can be seen in Table 18, all projects had multiple activities, though 'digitalisation of court services' and 'putting in place/upgrading the cooperation and communication within the judiciaries of the Member State' were relevant in all. The project *Information system e-justicia.cat and modernisation of courtrooms* also included 'Training' and *Administration and Electronic Judicial File (I)* also included the 'Purchase of ICT systems'.

### **Project final recipient related to support to justice**

The projects funded by the ERDF have two types of final recipients each, namely officials in the regions' Departments of Justice, and ultimately officials in the regional courts, supporting justice in Catalonia, Galicia and Andalusia. According to information provided by the Xunta de Galicia (the regional government in Galicia), final recipients include:

- Galicia High Justice Court
- General Prosecutor's Office of Galicia
- All 4 Provincial Audiencias (second instance)
- Courts in all 49 judicial districts (290 judicial bodies overall)
- 12 provincial or local prosecution offices
- 7 territorial sub-directorates of the Legal Medicine Institute
- 290 Peace Courts
- Generally, all units and officials in Galicia's administration of justice

### **Project outputs, results and impacts related to support to justice**

None of the indicators developed for the projects funded in the 2014-2020 programming period fit the categories of output indicators used for this study, and therefore the tables below state "N/A".

Authorities in Catalonia aim at measuring the following output at project completion:

- Result indicator (R025C): Percentage of the population using e-government services.
- Productivity Indicator (E016): number of users covered by a specific electronic public service.

In Galicia, the following indicators will be monitored:

- Persons (aged 16–74) interacting with the administration of justice via the Internet.
- Judicial bodies covered by the electronic file. Expected value between 159 and 198 bodies (out of a total of 260 bodies). The total coverage of 260 bodies is expected by 2023.

Indicators for Andalusia have not been provided by the IB/beneficiary to the Country Expert.

### 3.4. Relevant programme output and result indicators

#### 3.4.1. Programme indicators

According to the OPs referenced above, the indicators that will be used to monitor the modernisation of the public administration in terms of the putting in place of ICTs are not specific to justice. Instead the indicators will be the number of users who have access to or are covered by the services and applications of the electronic administration. This includes the measures and activities planned in the area of justice.

#### 3.5. Budget information

Overall budget information for projects supporting the justice system funded through the ESF and ERDF was generally available. However, there is no universally accepted taxonomy for project budget owners to classify budgets according to type of activity or final recipient. Moreover, many projects involve multiple activities and/or multiple final recipients. Whether and how budgets for these complex projects are analysed by activity or final recipient varies across project owners and countries. This militates against using reported data to make meaningful comparisons between projects and Member States.

For the purpose of this study, the researchers have therefore created a high-level taxonomy in order to enable an analysis of budget allocations for activities and final recipients for projects funded through the ESF and ERDF supporting the justice system. Information from interviews and documents has been used to apply this taxonomy and allocate budgets based on the main focus of the projects as well as the final recipients.

In cases where it has not been possible to determine budget allocations for projects with **multiple final recipients**, these have been classified as 'multiples' (further details and explanations have been provided in the text below). Where a project had **multiple activities** and/or included activities which did not fall under one of the focus categories, the categorisation of that project reflects its aim and not necessarily all individual activities

undertaken in the context of this project. This approach is further explained in the Final Report.

For the 2014–2020 programming period it is also important to note that the majority of projects are still ongoing. The tables below therefore only provide an overview of the **budget allocated** for project activities and final recipients.

Only the IBs/Beneficiary in Galicia has provided information on budget, including the expected budget allocation by broad categories. The budget breakdown is presented below:

However, the activities presented above do not match the categorisation system applied in the study and therefore offering a budget breakdown by activity that is comparable across Member States is not possible. In the case of Galicia and Andalusia, however, it is possible to aggregate activity expenditure using the higher-level categorisation 'Digitalisation & ICT', as presented in Table 22.

Table 23, in which 'Courts and Tribunals' and 'Regional justice administration', categorised under 'Multiple', received all of the budget allocated, refers to the budget allocated for the projects in Galicia and Andalusia as data for the project implemented in Catalonia was not made available.

## 4. Overview of existing national and regional data and documentation related to the ESF and ERDF

---

### 4.1. Ex-ante evaluations and needs assessments

Needs assessment of reforms in the area of justice in Spain have been conducted through the National Reform Programme and a Strategic Plan for the Modernisation of Justice 2009–2012. These are only mentioned at high level in the programming documents such as NSRF and PA. Although the Strategic Plan and the NRPs do not link the reforms to the ERDF funding, there is overlap with areas identified as needing reform and investment in the area of justice, specifically investment in ICTs, and funding provided within the Priority Theme 13 and Thematic Objective 2.

### 4.2. Programming documents

Several, but not all, programming documents make reference to operations and actions in the field of justice. Spain as a decentralised country has developed national OPs and regional OPs for both funding periods (for 17 regions and 2 autonomous cities), which means that a large volume of documents is available online. However, for the first programming period six OPs have been included (Knowledge-based Economy; Catalonia; Canary Islands; Andalusia; Galicia; Valencia) and four for the second programming period (Smart Growth; Catalonia; Valencia; Galicia). Not all of them discuss reforms in the area of justice; however, some of these improvements are discussed later in the Annual Implementation Reports (AIRs). It is important to note that the initiatives funded in justice may be referred to interchangeably as programmes, projects, operations and actions.

### 4.3. Implementation reports

As per the above paragraph, the AIRs of the national and regional OPs that mention actions in the area of justice have been included in this MS Chapter. In the AIRs information on investments in the area of justice is incremental, meaning that new actions are refer to year after year. Here it is important to note that there are regions that seem to have implemented reforms under the regional OPs (mainly because competence in the area of justice has been devolved to them), regions that implement reforms under the national OP, and regions that seem to be implementing the changes under a combination of national and regional programmes. The information on the reforms is generic, therefore building an intervention logic at this stage is not possible. Also, the indicators reported in the AIRs are not defined in detail.

### 4.4. Interim and ex-post evaluations

No ex-post evaluations have been conducted so far (or are not available in the MA website) and interim evaluations do not mention investment in the area of justice.

### 4.5. Other non-project level documents

Information on planned reforms in the area of justice in Spain was provided in the above-mentioned 'Plan Estratégico de Modernización de la Justicia 2009-2012' (Strategic Plan for the Modernisation of Justice 2009–2012) and the National Reform Programme, although the planned reforms were not specifically linked to ESF or ERDF funding.

### 4.6. Project-level data sources

Project-level data has been provided by the Spanish MA, IB, and beneficiaries.
