In the period from January to December 2025, the Commission for the Code of Ethics received 16 initiatives for determining violations of the provisions of the Judges' Code of Ethics/opinions given by the Commission for the Judges' Code of Ethics.

The new composition of the Commission for the Judges' Code of Ethics was elected on October 28, 2025, after which the initiatives EK 14/25; EK 15/25; and EK 16/25 were received.

As of December 31, 2025, 6 initiatives remained unresolved.
