COMMISSION DECISION

amending Commission Decision C(2014)9492 on the adoption of the 2015 work programme in the field of Communication, serving as a financing decision

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union¹ (hereinafter referred to as the 'Financial Regulation'), and in particular Articles 84 and 128 thereof,

Having regard to Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of the Regulation of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union² (hereinafter referred to as the Rules of Application), and in particular Articles 94 and 188 thereof,

Whereas:

- (1) Under Article 54(2)(d) of the Financial Regulation, appropriations for one-off actions, or even actions for an indefinite duration, carried out by the Commission by virtue of tasks resulting from its prerogatives at institutional level pursuant to the TFEU and the Euratom Treaty, other than its right of legislative initiative referred to in point (b), and under specific powers directly conferred on it by those Treaties, a list of which is given in the Rules of Application in Article 31, may be implemented without a basic act.
- (2) Communication is one of the Commission's tasks resulting from its prerogatives at institutional level.
- (3) Under Article 84 of the Financial Regulation and Article 94 of the Rules of Application, the work programme is prepared by each authorising officer responsible and it is subject to be adopted and published at the start of the year, and the work programme specifies the basic act, the objectives, the schedule of calls for proposals with the indicative amount and the results expected.
- (4) This Decision allocates to the amended 2015 work programme a total of EUR 73 300 000. These appropriations may also cover interest due for late payment³.
- (5) The present decision constitutes a financing decision for the 2015 budget in the sense of Article 84 of the Financial Regulation, Article 94 of the Rules of Application, and Article 22 of the Internal Rules on the implementation of the general budget of the European Union⁴.

- (6) The financing decision for the 2015 work programme in the field of Communication has been adopted by Commission Decision C(2014)9492 on 15 December 2014⁵.
- (7) Following the definitive adoption of the European Union's budget for the financial year 2015, an amendment to Decision C(2014)9492 of 15 December 2014 has now become necessary.
- (8) New action should be included and certain actions modified.

HAS DECIDED AS FOLLOWS:

Article 1

Article 2 of Commission Decision C(2014)9492 is amended as follows:

The maximum contribution authorised by this Decision for the implementation of the Programme is set at EUR 73 300 000, and shall be financed from the following lines of the General Budget of the European Union for 2015:

- budget lines remain unchanged with the addition of:
- budget line 16.03 77 05: EUR 1 000 000

The penultimate paragraph remains unchanged.

The last paragraph is deleted.

Article 2

The Annex to the Commission Decision C(2014)9492 is amended in order to add new points 3.3. and 11. and to modify points 2.2., 3.2., 4.1., 4.2., 5.2., 6.1., 6.2., 7.2., 8.1., 8.2., 10.1., as specified in the Annex to the present Decision.

Article 3

All remaining articles of Commission Decision C(2014)9492 and points of its Annex remain unchanged by this Decision.
