Amendment to the 2012 annual work programme on grants and contracts for the Lifelong Learning programme

(European Commission C(2011)9520 of 20 December 2011)

SUMMARY

Under Article 75 of the Financial Regulation, the commitment of the expenditure shall be preceded by a financing decision adopted by the Commission.

Under Article 110 of the Financial Regulation, grants are subject to an annual programme.

The annual work programme on grants and contracts for the Lifelong Learning Programme for 2012 has been adopted by Implementing Decision C(2011)5502 of 4 August 2011.

The attached Commission Implementing Decision amends Decision C (2011)5502, in order to cover the participation of a candidate country and two potential candidates from the Western Balkans - the former Yugoslav Republic of Macedonia, the Republic of Albania¹ and the Republic of Serbia² - in the action programme in the field of lifelong learning (2007/2013) as from 2012, subject to the signature of the Memoranda of Understanding between the European Commission and the competent authorities of the countries concerned, allowing them to participate in all the programme actions listed in Point A.2 of the Annex to Decision No 1720/2006/EC of 15 November 2006 of the European Parliament and of the Council establishing the Lifelong Learning Programme, except in eTwinning.

The funds allocated to the Eurydice, Europass and Euroguidance networks have been increased, according to the new country distribution of Appendix 3.

The Implementing Decision also complements the lump sums and flat-rate financing authorised for application for the years 2012 and 2013 allowing these three Western Balkan countries to benefit from flat-rate and lump sum financing as from 2012, and updates the table for the Jean Monnet Programme, Key activity 3, for all participating countries in this programme for the years 2012 and 2013.

The total expenditure foreseen under the 2012 amended work programme on budget line 15.0222 for the year 2012 has been increased to €1,222,251,516 to include the financial contribution of the former Yugoslav Republic of Macedonia, Albania and Serbia (€474,140), subject to the availability of appropriations on budget line 15.0222 for the year 2012 and the signature of the Memoranda of Understanding between the European Commission and the competent authorities of the countries concerned.

This decision serves as a financing decision within the meaning of Article 90 of the Implementing Rules.

RÉSUMÉ

L'article 75 du règlement financier prévoit que l'engagement de toute dépense est précédé d'une décision de financement adoptée par la Commission.

L'article 110 dudit règlement dispose que les subventions font l'objet d'un programme de travail annuel.

Le programme de travail annuel en matière de subventions et de marchés relatif au programme pour l'apprentissage tout au long de la vie pour 2012 a été adopté par la décision d'exécution C(2011) 5502 du 4 août 2011.

La décision d'exécution de la Commission ci-jointe modifie la décision C (2011)5502 pour couvrir la participation d'un pays candidat et de deux candidats potentiels des Balkans occidentaux (l'ancienne République yougoslave de Macédoine, la République d'Albanie¹ et la République de Serbie²) au programme d'action dans le domaine de l'apprentissage tout au long de la vie (2007/2013) à partir de 2012, sous réserve de la signature du protocole d'accord entre la Commission européenne et les autorités compétentes des pays concernés, les autorisant à participer à toutes les actions du programme énumérées au point A.2 de l'annexe à la décision n° 1720/2006/CE du Parlement européen et du Conseil du 15 novembre 2006 établissant le programme pour l'apprentissage tout au long de la vie, à l'exception de l'action eTwinning.

Les fonds alloués aux réseaux Eurydice, Europass et Euroguidance ont été augmentés compte tenu de la nouvelle répartition par pays de l'appendice 3.

La décision d'exécution complète également les montants forfaitaires et le financement à taux forfaitaire pouvant être appliqués pour les années 2012 et 2013, permettant à ces trois pays des Balkans occidentaux de bénéficier d'un financement forfaitaire et d'un financement à taux forfaitaire à partir de 2012. Elle actualise aussi le tableau du programme «Jean Monnet», activité clé 3, pour tous les pays participant à ce programme pour les années 2012 et 2013.

La dépense totale prévue dans le programme de travail pour 2012 modifié sur la ligne budgétaire 15 02 22 pour l'année 2012 a été portée à 1 222 251 516 EUR pour inclure la contribution financière de l'ancienne République yougoslave de Macédoine, de l'Albanie et de la Serbie (474 140 EUR), sous réserve de la disponibilité des crédits sur la ligne budgétaire 15 02 22 pour l'année 2012 et de la signature du protocole d'accord entre la Commission européenne et les autorités compétentes des pays concernés.

La décision ci-jointe vaut décision de financement au sens de l'article 90 des modalités d'exécution.

ZUSAMMENFASSUNG

Gemäß Artikel 75 der Haushaltordnung geht jeder Ausgabe ein Finanzierungsbeschluss der Kommission voraus.

Gemäß Artikel 110 der Haushaltordnung werden Finanzhilfen in ein Jahresarbeitsprogramm aufgenommen.

Das Jahresarbeitsprogramm 2012 für Finanzhilfen und öffentliche Aufträge im Rahmen des Programms für lebenslanges Lernen wurde mit dem Durchführungsbeschluss K(2011) 5502 vom 4. August 2011 angenommen.

Mit dem beigefügten Durchführungsbeschluss der Kommission wird der Beschluss K(2011) 5502 geändert, um die Teilnahme eines Bewerberlandes und zweier möglicher Bewerberländer – der Westbalkanstaaten ehemalige jugoslawische Republik Mazedonien, Republik Albanien¹ und Republik Serbien² – am Aktionsprogramm im Bereich des lebenslangen Lernens (2007–2013) ab 2012 zu ermöglichen, vorbehaltlich der Unterzeichnung der Vereinbarungen zwischen der Europäischen Kommission und den zuständigen Behörden der betreffenden Länder über deren Teilnahme an allen Maßnahmen, die in Punkt A.2 des Anhangs des Beschlusses Nr. 1720/2006/EG des Europäischen Parlaments und des Rates vom 15. November 2006 über ein Aktionsprogramm im Bereich des lebenslangen Lernens aufgeführt sind, mit Ausnahme von eTwinning.

Die den Netzen Eurydice, Europass und Euroguidance zugeteilten Mittel wurden entsprechend der in Anlage 3 vorgesehenen Verteilung auf die Länder erhöht.

Mit dem Durchführungsbeschluss wird auch der für die Jahre 2012 und 2013 genehmigte Rückgriff auf Pauschalbeträge und Finanzierungen auf der Grundlage von Pauschaltarifen ergänzt, so dass den drei Westbalkanländern die Finanzierung auf der Grundlage von Pauschaltarifen und Pauschalbeträgen ab 2012 zugute kommt. Ferner wird die Tabelle für das Programm Jean Monnet, Schwerpunktaktivität 3, für alle an diesem Programm teilnehmenden Länder für die Jahre 2012 und 2013 aktualisiert.

Das Gesamtvolumen der im Rahmen des geänderten Arbeitsprogramms 2012 in der Haushaltlinie 15 02 22 für das Jahr 2012 vorgesehenen Ausgaben wurde aufgrund der Finanzbeiträge der ehemaligen jugoslawischen Republik Mazedonien, Albaniens und Serbiens (474 140 EUR) auf 1 222 251 516 EUR aufgestockt, vorbehaltlich der Verfügbarkeit von Haushaltmitteln im Rahmen der Haushaltlinie 15 02 22 für das Jahr 2012 und vorbehaltlich der Unterzeichnung der Vereinbarungen zwischen der Europäischen Kommission und den zuständigen Behörden der betreffenden Länder.

Dieser Beschluss dient als Finanzierungsbeschluss im Sinne des Artikels 90 der Durchführungsbestimmungen.

ANNEX

Amending Decision C(2011)5502 of 4 August 2011 on the 2012 annual work programme on grants and contracts for the "Lifelong Learning Programme"

Budget lines: 15.0222

Title: The Lifelong Learning Programme

Legal basis: Decision n° 1720/2006/CE¹ of the European Parliament and of the Council of 15 November 2006 establishing an action programme in the field of lifelong learning.

The annual work programme 2012 in the field of Lifelong Learning was adopted by the Commission on 4 August 2011 by Commission decision C(2011)5502.

It is necessary to put forward a supplementary financing decision in order to:

- Cover the participation of the Republic of Albania², the former Yugoslav Republic of Macedonia and the Republic of Serbia³ in the action programme in the field of lifelong learning (2007/2013) as from 2012, subject to the signature of the Memoranda of Understanding between the European Commission and the competent authorities of the countries concerned. This will allow them to participate in all the programme actions listed in Point A.2 of the Annex⁴ to Decision No 1720/2006/EC of 15 November 2006 of the European Parliament and of the Council establishing the Lifelong Learning Programme, except in eTwinning⁵.
- Their participation to the LLP Programme will imply to:
 - Add the new flat-rate financing for Albania, the former Yugoslav Republic of Macedonia and Serbia, for the years 2012 and 2013 in Tables 9, 10 and 15 of Appendix 4 and
 - Update the country distribution of funds for Eurydice, Euroguidance and Europass networks in Appendix 3, in order to integrate Albania, the former Yugoslav Republic of Macedonia and Serbia. The new totals are also mentioned in the 2012 budget table of Appendix 1 (points 5.15, 5.22 and 5.23).
- Update the flat-rate financing in the frame of the Jean Monnet Programme, Key Activity 3: European Associations active in the field of education and training, for all participating countries in this programme, for the years 2012 and 2013 (Table 15 of Appendix 4).

The additional funds resulting from the estimated financial contribution of Albania, the former Yugoslav Republic of Macedonia and Serbia amount to €474,140, bringing the total expenditure foreseen under the 2012 work programme to €1,222,251,516, subject to the availability of appropriations on budget line 15.0222 for the year 2012 and the signature of the Memoranda of Understanding between the European Commission and the competent authorities of the countries concerned. The present decision aims at authorising actions and budget changes explained below. The estimated amount and number of contracts envisaged are indicated in Appendix 1.

At this stage, it is not foreseen to sub-delegate the actions covered by the present decision to other DGs.

1. GRANTS

The estimated amount of the grants together with the maximum rates of co-financing and the type of the legal instrument to be used for the award of the grant for the action listed below are specified in the table in Appendix 1.

1.1. Grants to National Agencies or other public-sector or private law bodies with a public-service mission in conformity with Article 54.2(c) of the FR

1.1.1. National units of the Eurydice network

Index reference in the table in appendix: 5.15

Financial support is given for specific actions carried out by the national units of the Eurydice network. The network's goal is to contribute towards a better mutual understanding of education systems in Europe through the production of comparable country descriptions, indicators and comparative studies in the field of education.

The participation of all national units in the work of the network facilitates access to national qualitative and quantitative data that are necessary for the comparison between Eurydice countries. The aim is to gather as (territorially) exhaustive information as possible and to produce high quality studies and analyses that facilitate co-operation in education at the European level. Taken together, these activities give a substantial input, in terms of comparable data, to the current European co-operation in education (ET 2020, Bologna Process, Lifelong Learning, etc.).

Beneficiaries

The Eurydice national units, which are network members and designated as such by the ministries of the countries that participate in the programme. These beneficiaries are explicitly identified in Article 33(1) (d) (3) of the Legal Basis.

The EU financial support is given on the basis of a common frame of reference established by the Commission on the basis of the Eurydice Network Work Programme.

The application of the system of funding the national units for 2012 as regards Albania, the former Yugoslav Republic of Macedonia and Serbia is detailed in Appendix 5. In conformity with the FR, the lump sums and flat rate financing, uphold co-financing and non-profit principles.

The new country distribution of the total amount available for the action is provided in the table in Appendix 3.

1.1.2. Euroguidance

Index reference in the table in appendix: 5.22

The EU contribution finances up to 50% of the operating costs of the national centres of the Euroguidance network, whose mission it is to develop the European dimension in guidance for education and vocational training. Euroguidance centres establish information tools for guidance counsellors, students, pupils and their parents, as well as the trainers of the guidance counsellors and personnel in education and training; they train and advise the guidance centres in terms of European mobility opportunities; they contribute to the update of information included in the Ploteus portal, the European portal on education and training opportunities in Europe and may be involved in the interconnection of national data resources with Ploteus. The Ploteus portal is being gradually integrated into the EQF portal, but this does not have an impact on the contribution by Euroguidance.

The objectives for this year and the results foreseen are as follows:

- Better targeted communication for the various users, as well as intensified co-operation with the relevant European networks in the field of mobility;
- The centres will keep tasks related to Ploteus, which vary from one country to another, including in relation to the second phase of Ploteus, which envisages the interconnection with national data resources.

Beneficiaries

Euroguidance centres are beneficiaries of European Union financial contributions. The national centres that form the Euroguidance network are instruments for the implementation at national level of the lifelong learning programme. These beneficiaries are explicitly identified in Article 33(1) (e) (i) of the Legal Basis. The final beneficiaries of the Euroguidance service are the citizens, either directly or via the guidance counsellors and local guidance centres.

The EU financial support is subject to approval of a work programme and an estimated budget that centres prepare on the basis of terms of reference established by the Commission and a financial framework including in particular the budget available for each country, based on a distribution key approved by the Lifelong Learning Programme Committee. Each application must also be accompanied by a declaration from the competent national authorities with their commitment to cover at least 50% of the costs.

The new country distribution of the total amount available for the action including Albania, the former Yugoslav Republic of Macedonia and Serbia is provided in the table in Appendix 3. The distribution is based on demographic size, cost of living and previous use of resources. The increase in the global Euroguidance amount takes into account the growing number of participating countries (the average unitary grant had actually decreased since 2005).

The distribution may be slightly changed based on information from countries (envisaging not to ask for a grant or to ask less than available).

1.1.3. *Europass*

Index reference in the table in appendix: 5.23

Established by the decision of the European Parliament and of the Council⁶ on a single EU framework for the transparency of qualifications and competences, the Europass action implements since 2005 a direct service to citizens, as well as to training centres, schools, universities and enterprises, through a European portal and the network of national Europass centres mentioned above. The EU contribution

finances up to 50% of the operating costs of the national Europass centres, which implement the Europass action on the national level.

The Europass decision establishes an instrument with no fixed duration and therefore without an overall budget. As from 2007, the financial support to the Europass centres forms part of the budget of the action programme in the field of lifelong learning.

The objectives of this year and the results foreseen are as follows:

- Provision, through a European portal and the network of National Europass Centres, of several instruments for the transparency of qualifications and competencies, aiming in particular at better communication between job-seekers and employers, thus better mobility on the European labour market. The European portal will be further developed and NECs will be asked to contribute with expert views, country related advice, and linguistic support;
- Promotion of these instruments to the public concerned (citizens, training centres, schools, universities and enterprises). Special attention is given to the co-operation between services for employment, orientation and youth.

The detailed tasks are defined by the Commission and the application form for the grant facilitates the preparation of an accurate work programme, with concrete and verifiable indications.

Beneficiaries

The Europass centres are the beneficiaries of the operating grants. The national centres that form the Europass network are instruments for the implementation at national level of the lifelong learning programme. These beneficiaries are explicitly identified in Article 33(1) (e) (iii) of the Legal Basis. The final beneficiaries of the Europass service are the citizens, as well as learning centres, schools, universities and enterprises.

The grant is subject to approval of a work programme and an estimated budget that centres prepare on the basis of terms of reference established by the Commission and a financial framework including in particular the budget available for each country, based on a distribution key approved by the Lifelong Learning Programme Committee. Each grant application must also be accompanied by a declaration from the competent national authorities with their commitment to cover at least 50% of the costs.

The new country distribution of the total amount available for the action including Albania, the former Yugoslav Republic of Macedonia and Serbia is provided in the table in Appendix 3. The distribution is based on demographic size, cost of living and previous use of resources. The increase in the global Europass amount takes into account the growing number of participating countries (the average unitary grant had actually decreased since 2005).

The distribution may be slightly changed based on information from countries (envisaging not to ask for a grant or to ask less than available).

APPENDIX 4

LUMP SUMS AND FLAT-RATE FINANCING AUTHORISED FOR 2012 AND 2013 FOR THE LIFELONG LEARNING PROGRAMME (LLP)

This appendix complements the annual work programme C(2011)5502 adopted on 4 August 2011, allowing Albania, the former Yugoslav Republic of Macedonia and Serbia to benefit from lump sum and flat-rate financing as from 2012, subject to the signature of the Memoranda of Understanding between the European Commission and the competent authorities of these countries for their participation in the Lifelong Learning Programme as from 2012, and updates the table for the Jean Monnet Programme, Key activity 3 (Table 15) for all participating countries in this programme for 2012 and 2013.

Both the method of calculation and the justification of the amounts remain unchanged, and are explained in the 2012 annual work programme.

The flat-rates and lump sums proposed for Albania, the former Yugoslav Republic of Macedonia and Serbia in the Tables 9, 10 and 15 will be valid during 2012 and 2013. The method of calculation used for this update is explained.

1. LUMP SUMS AND FLAT-RATES AUTHORISED FOR APPLICATION IN 2012 AND 2013

1.1. Flat-rates applied to Multilateral Projects, Networks and Accompanying Measures

These actions are managed either under the centralised indirect management mode by the National Agencies - Multilateral Projects: Transfer of innovation for the Leonardo da Vinci programme; or under the centralised direct management mode by the Commission or the Executive Agency for Education and Culture and concern multilateral projects, networks and accompanying measures.

1.1.1. Staff Costs

Eligible staff costs are calculated on the basis of scales of eligible unit costs. The unit cost covers cost of staff assigned to the action, either by the beneficiary or by the co-beneficiaries (partners), comprising actual salaries plus social security charges and other statutory costs included in the remuneration. The staff costs may not exceed those stipulated in Table 9. If any real staff costs do exceed these amounts, the surplus amount will not be taken into account as eligible cost. To ensure the respect of the co-financing and no-profit rules, the global co-financing percentage (normally 75%) will be applied to these rates.

The staff cost rates are based on a study conducted by an independent research company in 2011. The rates have been calculated on the basis of the index reflecting the annual labour costs per country (Structure of Earnings statistics and Labour Cost statistics, published by Eurostat or by the national statistic offices). The table below comprises the maximum eligible daily rates, to which the EU co-financing percentage will be applied.

1.2. Lump sums and flat-rates applied to Jean Monnet actions

In the frame of the Jean Monnet Programme, Key Activity 3: European Associations active in the field of education and training, flat-rate financing has been introduced in 2009 and are updated for the years 2012 and 2013 (see below). The method of calculation used for this up-date is the following:

- The amount of €32,707 € (EU100) that was the basis for calculating the flat-rates of each country for 2009-2010 was indexed by 6,0% (2 x 3%), taking into account the average inflation rate of the two last years 2007 and 2008 (i.e. 2007 => 2,3% and 2008 => 3,7% = 3%) for which data were available, plus 3% for the years 2009 and 2010 for which EUROSTAT data were not available at that time (i.e. 08.2010)⁷.
- The amount calculated above (i.e. €34,669) as the new basis for establishing the flat-rates related to the years 2011 and 2012 was then indexed with the Gross Domestic Product (GDP) per capita (i.e. per person) in Purchasing Power Standards (PPS) (EU-27 = 100) applicable to the countries concerned (depending on each Programme's list of eligible countries)⁸.

APPENDIX 5

LUMP SUMS AND FLAT-RATE FINANCING AUTHORISED FOR 2012 AND 2013 FOR THE EURYDICE NATIONAL UNITS

This appendix complements the annual work programme C(2011)5502 adopted on 4 August 2011, allowing Albania, the former Yugoslav Republic of Macedonia and Serbia to benefit from lump sum and flat-rate financing as from 2012, subject to the signature of the Memoranda of Understanding between the European Commission and the competent authorities of these countries for their participation in the Lifelong Learning Programme. Both the method of calculation and the justification of the amounts remain unchanged, and are explained in the 2012 annual work programme.

Criterion 1. Participation in common activities

Albania, the former Yugoslav Republic of Macedonia and Serbia will be considered as category 1 countries⁹. However, with a view to their progressive integration into the network in 2012, it is proposed that they will not participate to the Eurydice reports and their work will be limited to the following activities:

- Description of their national education system in Eurypedia;
- Promotional activities.

For this reason, the calculation of the flat-rate for this criterion is limited to 88 days in 2012. In 2013, the flat-rate of Albania, the former Yugoslav Republic of Macedonia and Serbia for this criterion will be calculated as follows:

- For countries, which participated in 2012, it will be calculated on the basis of the standard number of days for category 1, i.e. 210;
- For countries, which will only participate as of 2013, the number of days will be 88 for the first year.

Criterion 2. Participation in Eurydice meetings

Albania, the former Yugoslav Republic of Macedonia and Serbia will be considered as category 4 countries¹⁰.

Criteria 3 and 4.

The calculation explained in the 2012 annual work programme also applies to Albania, the former Yugoslav Republic of Macedonia and Serbia.

Criterion 5. Integration of new members

For Albania, the former Yugoslav Republic of Macedonia and Serbia, a special additional lump sum of €15,000 a year over 3 years is given to new units to enable the implementation of the national units

and their gradual integration into the activities of the network. This lump sum is payable de facto. The amount will cover the estimated initial costs such as installation costs, other costs associated with the needs to start up a new unit (set up of an expert pool, additional translation needs to prepare contributions from scratch and make them available in English, etc.).

The flat-rates and lump sums proposed for Albania, the former Yugoslav Republic of Macedonia and Serbia will be slightly increased in 2013, compared to 2012, based on the number of days to be taken into consideration for criterion 1, as explained above.

The estimated distribution of the budget allocated to the Eurydice national units and to Albania, the former Yugoslav Republic of Macedonia and Serbia and the 2012 reference scale for calculating criterion 1 is provided in the following tables:
