Having regard to the Treaty on the Functioning of the European Union,

Having regard to the fourth ACP-EEC Convention signed at Lomé on 15 December 1989<sup>1</sup>, as amended by the Agreement amending the fourth ACP-EC Convention of Lomé signed in Mauritius on 4 November 1995<sup>2</sup>,

Having regard to the Internal Agreement between the representatives of the Governments of the Member States, meeting within the Council, on the financing and administration of the Community aid under the Second Financial Protocol to the fourth ACP-EC Convention<sup>1</sup> (the 'Internal Agreement') setting up, amongst others, the eighth European Development Fund ('eighth EDF'), and in particular Article 33(3) thereof,

Having regard to the Financial Regulation of 16 June 1998 applicable to development finance cooperation under the fourth ACP-EC Convention<sup>2</sup>, and in particular Articles 66 to 74 thereof,

Having examined the revenue and expenditure account and the balance sheet relating to the operations of the eighth EDF as at 31 December 2018 and the Annual Report of the Court of Auditors on the activities funded by the 8th, 9th, 10th and 11th European Development Funds (EDFs) concerning the financial year 2018, together with the Commission's replies<sup>3</sup> contained in that Annual Report,

HEREBY RECOMMENDS that the European Parliament give the Commission a discharge in respect of the implementation of the operations of the eighth EDF for the financial year 2018.
