During my time in Coxes, I advised the Irish Department of Finance on the State's legislative response to the Irish banking and financial crisis, in particular on the response to troika and played a key role in the drafting of the legislation to nationalise Anglo Irish Bank, establish NAMA and the legislation to stabilise Irish banks under which the Minister for Finance was given far reaching powers. Separately, in my time in Arthur Cox I advised multinational companies on establishing in Ireland, on cross-border mergers, registered the first SE in Ireland, and advised companies on complex shareholders' disputes and group directors on their duties and governance obligations.*
