Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Where questions of particular relevance under the single market dimension, this is indicated before the relevant question.

The exchange with Austrian subsidiaries on the ground confirms the potential of the Albanian market, but also points to significant challenges:

- ****Deficiencies in the rule of law****, particularly regarding land rights (unclear ownership structures), non-transparent court rulings, lengthy procedures, insufficient administrative commitment, political influence, and in some cases a lack of transparency in the selection of judges.
- ****Corruption and market distortion****, including suspected unfair practices and a lack of transparency in public procurement. Cross-border trade is affected by informal payments or delays (customs control).
- ****A positive development**** is the notable progress in the digitalisation of public services in Albania.

The results of the most recent Global Business Barometer survey (see Annex, Question 5) underscore these impressions. These factors weigh heavily on the investment climate. Foreign investors would welcome reforms addressing structural deficiencies, improving the business environment, and ensuring more efficient communication with public authorities.

Internal Market and Regulatory Environment

The lack of predictability and stability of the fiscal and legal framework makes reliable long-term business planning difficult for EU companies operating in Albania.

In addition, unclear competences and insufficient consistency among institutions hinder the implementation of EU standards and internal market rules. Despite progress in aligning trade, competition, and consumer protection legislation, significant implementation gaps remain.

Implementation of EU Regulation 2018/858

In this context, we would like to draw attention to the concern raised by Porsche Holding Salzburg (see attached Letter of Interest, submitted during the most recent Austrian–Albanian Joint Economic Commission in October 2025).

****Background:****

In Albania, vehicles intended for the Asian market can currently be imported and registered without a Certificate of Conformity. This results in significant price advantages and potential safety risks. One example is the entire e-taxi fleet, which originates directly from China via intermediaries.

The transposition of EU Regulation 2018/858 into national law would address this issue and forms part of the EU accession chapter “Free Movement of Goods.” However, the current European Commission Country Report notes no progress under Chapter 1.

The European Commission has called on Albania to complete alignment by the end of 2026. During the Joint Economic Commission, the responsible Deputy Minister of Economy stated that implementation would only take place in 2027. In contrast, at the Subcommittee Meeting on Trade, Industry, Customs and Taxation on 25–26 November 2025, Albania indicated that full transposition would be completed by no later than the end of 2026.

This commitment was also reflected in the press release following the Subcommittee Meeting:

> “The Commission also urged Albania to complete the action plan to align with the requirements of Articles 34–36 of the Treaty on the Functioning of the EU and relevant Court of Justice case law covering notably the non-harmonised areas, and accelerate its efforts to align its product legislation, including to ensure full alignment to the *acquis* on motor vehicles by the end of 2026.”

Given the sharp increase in imports of Asian vehicles in recent years, it can be assumed that certain interests exist in maintaining the current situation for as long as possible. In light of the European dimension of this issue (internal market integrity, geo-economic competition, and the shared interests of many EU Member States with automotive industries), as well as the lack of progress in the already opened Chapter 1, we recommend continuing to pursue this matter at the European level.

The issue is known to the European Commission and has already been raised repeatedly with the EU Delegation in Albania, as well as by several embassies (AT, DE, FR) and international automotive groups. Nevertheless, developments should continue to be actively monitored.
