Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

The independence of the German media regulatory authorities are a great guarantee of media freedom. With the media state treaty (MStV) establishing a regulatory framework for platforms and media service providers – including transparency rules, non-discrimination requirements and laying down enforcement powers. However, VAUNET understands self-regulation (including internal codes of practices etc.) as most effective form of media independence and media freedom. Germany implements Art. 30 AVMSD (independent national regulatory

authorities) through the Landesmedienanstalten (media authorities) as independent public-law bodies with clear tasks the enforcement power.

Conditions and procedures for the appointment and dismissal of the head / members of the collegiate body of media regulatory authorities and bodies

Germany is a good example of how self-regulation works. Here are some examples of self-regulatory bodies that have been co-founded and are operated by media companies:

- Freiwillige Selbstkontrolle Fernsehen (FSF): Youth media protection body responsible for setting age ratings for television and audiovisual video-on-demand content.
- Freiwillige Selbstkontrolle Multimedia-Diensteanbieter (FSM): Youth media protection body for the online sector. Among other things, it operates a complaints office and is active in the field of technical protection measures.
- Deutscher Werberat (German Advertising Council): This self-regulation body for the advertising industry, which has been in existence for over 50 years, operates a complaints procedure for consumers.
- Deutscher Pressrat (German Press Council): A self-regulation body that has been in existence since 1956 and is responsible, among other things, for ensuring compliance with ethical standards and responsibility in journalism.

The state media authorities have media assemblies and media councils.

B. Safeguards against government or political interference and transparency and concentration of media ownership

A functioning State is dependent on a space to distribute public/state information to provide relevant information to its citizens. Through a distribution key with the state media authorities a fair and transparent allocation is granted.

In Germany, political advertising is prohibited on radio and television and in broadcast-like online media. However, by law (Interstate Media Treaty and state media laws), radio and television and broadcast-like online media are obliged to broadcast election advertising for political parties before elections. The independent media authorities of the federal states develop objective criteria on the basis of which the election advertising of political parties is broadcast.

Safeguards against state / political interference, in particular:

- safeguards to ensure editorial independence of media (private and public)
- specific safeguards for the independence of heads of management and members of the governing boards of public service media (e.g. related to appointment, dismissal), safeguards for their financial and operational independence (e.g. related to reporting obligations and the allocation of resources) and safeguards for plurality of information and opinions
- **[single market relevance]** information on specific legal provisions and procedures applying to media service providers, including as regards granting /renewal/termination of licenses, company operation, capital entry requirements, concentration and corporate governance

In addition to the highest possible degree of editorial independence, a high degree of financial independence is also a protective shield against state/political influence. State regulatory measures that restrict or impede the refinancing of private media, such as advertising bans, can undermine the economic basis and thus the independence of private media. In addition, the legislator must ensure fair competition with broadcasters, taking into account the Commission's guidelines on the application of state aid rules to public service broadcasting. Furthermore, a level playing field with gatekeepers is required.

High-quality, trusted media subject to editorial diligence are the best antidote to disinformation. The dual media system in Germany therefore fulfills an important democratic function (by ensuring publicly funded basic provision on the one hand and enabling market-driven diversity on the other). This duality ensures editorial independence and media freedom. Both parts have their target groups and justification—they should complement each other, not cannibalize each other.

Private media's business model is reliant on advertising while public services media are designed to operate independently from the commercial sphere. In 2024, net media advertising revenues in Germany amounted to €26.68 bn (+3.1% compared to 2023). Therefore, the mandate of public service media should be concretely defined to avoid overlap and competition distortion. The cap on sports rights is a good example of a good intention that needs to go further: While private media providers depend on the popularity of premium sports for their business model, public broadcasters could – and should – use the licence fee to give visibility to less mainstream sports and not compete with private media. For the reporting year relevant to the Rule of Law Report, VAUNET's autumn forecast underlines the pressure on advertising-funded business models: net audio and audiovisual advertising revenues are expected to be broadly stable in 2025 at around €6.1 bn (+0.2%), but with a marked shift - TV advertising is expected to decline to €3.3 bn (-7%), while streaming video advertising is expected to grow to €1.9 bn (+15%). Local and smaller private radio stations are a particularly clear example of the economic pressure on advertising-funded media: their business model depends almost entirely on advertising revenues, while at the same time they face direct competition with public service broadcasters in the advertising market. In practice, this translates into substantial losses for private radio, nationally around -6 % to -10 % and regionally up to -20 %.

Various member State regulations, which govern in particular government access to data, for example in the area of criminal prosecution, contain provisions designed to ensure the status of journalists as persons entitled to professional secrecy and the protection of their journalistic sources. Government crime statistics do not provide any information on the extent to which journalists have been victims of crime in the course of their professional activities. Media companies generally offer their media professionals legal protection and other support measures. In addition, media companies usually offer their employees the opportunity to contact confidential advisors in accordance with the General Equal Treatment Act in the event of violations of equal treatment. Professional associations for journalists offer legal protection, including advice, while in 2018 an independent confidential advice and counselling service was set up to provide psychological and legal advice on sexual violence and harassment in the cultural and media sector. The Federal Agency for Gender Equality is a general government service that offers support.

Law enforcement capacity, including during protests and demonstrations, to ensure journalists' safety and to investigate attacks on journalists

There is an exchange with the Conference of State Ministers of the Interior on the "Principles of Conduct for the Press/Broadcasting and the Police to Avoid Obstructions in the Performance of Police Tasks and the Free Exercise of Reporting," which could be made more regular. State media authorities, law enforcement agencies and private media cooperate in the prosecution of online expression crimes (initiative "Verfolgen statt nur Löschen" ("Prosecute instead of just delete")). However, this cooperation does not exclusively serve to protect journalists.

Access to information and public documents by public at large and journalists (incl. transparency authorities where they exist, procedures, costs/fees, timeframes, administrative/judicial review of decisions, execution of decisions by public authorities, possible obstacles related to the classification of information)

The right of freedom of information is one aspect that could be enhanced in Germany. This observation was explicitly addressed in the recommendation made in the 2025 rule of law report. The Federal Government has not yet continued its work on a law on the media's right to information from federal authorities.

The Member State law implementing Directive (EU) 2024/1069 of the European Parliament and of the Council of 11 April 2024 on protecting persons who engage in public participation from manifestly unfounded claims or abusive court proceedings (Strategic lawsuits against public participation) is still going through the legislative process. A draft law has been presented by the Federal Government.

Aside from the above-mentioned structures and mechanisms to ensure transparency and media freedom. The refinancing and therefore sustainability of the private media sector is imperative to diverse and independent media.

An unlevel playing field is the greatest challenge for private media and thus to reliable, editorial media. Public broadcasting is crisis proof through funding by licensing fees as well as advertising revenues, whereas private media solely relies on advertising revenues and subscription-based models. It is imperative to ensure that there are no further unnecessary regulatory burdens that inherently harm private media. This could be done via a mandatory media impact assessment prior to any new regulation that targets private media – be it as direct regulatory goal or collateral.

An increasing unlevel playing field exists also with global gatekeeping big tech players. They hold enormous market advantages and benefit from existing lock-in and network effects as well as economies of scale resulting from the mostly English-speaking markets of origin. Besides that, they are under-regulated compared to national media companies.
