Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.

Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

I. Justice System

Regarding the justice system there were no significant measures taken to follow-up the recommendations received in the 2025 Report. The same problems still exist.

There has been no improvement regarding the automatic and absolute transparent case allocation at lower courts. The system allows the leader on the department to influence case allocation. Although it is an expectation that the regulation of the case allocation system should be published, the system is too complicated with many factors therefore citizens cannot follow how cases are actually allocated. Moreover, there are many possibilities to make exemptions, and this makes the whole system unaccountable.

According to the Organisation and Administration of Courts Act concerning the case allocation of the Supreme Court (Kúria) there is a difference between the panels of the Supreme Court (art.10): there are 'assigned' panels (6 members) and within that there are the 'adjudicating' panels (5 members from the 6 members), who will participate on the hearing. This system strengthens the possibility to violate the automatic case allocation system.

a) The amendment to the Code of Civil Procedure, which entered into force on August 19, 2025, automatically makes it mandatory for courts to award damages to the parties in civil proceedings ex officio if the statutory deadline for action is exceeded, without any possibility of exemption. Compliance with statutory deadlines is clearly one of the most important factors in any proceeding and should never be a matter of debate. However, the newly introduced provision not only places a financial burden on the already struggling court system but may also affect the independence and impartiality of the judiciary. The payment of financial compensation is automatic, its legality cannot be disputed in any way during the proceedings, the reason for the omission cannot be presented, and there is no room for legal remedy. In practice, this means that judges hearing civil cases may fear administrative consequences, as the financial compensation places pressure on the administrative head due to the impossibility of financing the courts, which in turn may affect the impartiality and independence of decision-making. The prospect of consequences may lead to a loss of impartiality and call into question the professionalism of judges who prioritize quick decision-making to meet deadlines. The contested section of the law therefore jeopardizes the status of judicial independence, and the legislation affects not only judicial independence but also the principles of legal certainty and the right to legal remedy and is also discriminatory. The amendment will enter into force concerning Administrative Courts from June 1, 2026.

b) According to one of the latest amendments, from January 1 in the Code of Criminal Procedure and the Code of Civil Procedure 'online publicity' makes part of the general concept of the publicity of hearings. This means that it becomes a general rule. But not through the journalist or media representatives but through an audio-visual camera system gestured by the National Judicial Office. The first 100 citizens are going to be allowed to participate online, after a registration through their digital citizen profile, providing full name, date and place of birth, mother's name, address, and a photo of the physical person who wishes to attend. And the court will have the data – concerns data protection issues. This amendment – even if there are some exceptions – deprives the judge of the power to determine the extent of the hearing publicity and to ensure a fair trial and to protect private life rights. The text here differs media representatives from ordinary audience because media representatives and journalists in their official capacity practically can't use for their work the possibility of the online publicity. There are no specific instructions regarding journalists, they are still allowed to take pictures or broadcast the hearings with the permission of the parties, after the authorization of the presiding judge.

c) Doxing judges and political criticism

Hungarian judges are facing a completely new phenomenon: judges are being listed based on their perceived political affiliations, after their names appeared in a leaked database of supposed users of an online platform linked to a political party. None of these judges have ever publicly expressed political views or engaged in political activity. On November 2, 2025, news broke that a database of nearly 200,000 people registered with an app linked to Tisza, the strongest Hungarian opposition party, had been leaked and published on the internet. An interactive Google Maps-based database appeared, allowing anyone to search for the home address of individual users whose data had leaked from the app.

Judges appear to be a key target of this doxing attack. An anonymous blog spreading government narratives named three judges who appear on the list and questioned their independence on this basis. Soon, government-aligned media outlets also reported that judges were included on the list, although not all listed their names. The political columnist mentioned earlier, who is also a Fidesz-founder, called for these judges to be dismissed. The anonymous blog also reported that an unnamed judge of the Kúria (the Supreme Court of Hungary) may also be on the list. Considering that the private addresses of the judges mentioned are possibly searchable on an interactive map, this also poses a rather alarming security risk.

A recent decisions concerning privacy rights were strongly criticised by the government when the court banned the dissemination of the governing party's campaign publication. Some members of the government and the pro-government media questions the impartiality and directly the authority of the judge on the base of the above-mentioned leaked database and denies the execution of the judicial decision.

There has been an increase of 15% of the judicial salaries but the monthly net amount is still very low. The courts are still lack of court staff because of the low salary, especially in the central region, where the workload of the judges and court staff is the highest.

The legislation on the salaries of judges and court staff is incompatible with the principle of judicial independence for the following reasons:

It does not ensure that Hungarian judges and judicial employees receive a remuneration that corresponds to the significance of the judicial profession.

There is no such a correction mechanism that guarantees the conservation of the real value of the remuneration of judges and judicial staff.

It does not ensure the separation of the judicial branch from the other two branches of power, because it makes the determination of the remuneration entirely dependent on the political will of the executive and the legislature.

It is contrary to the requirement of the balance of powers, given that it provides a significantly lower remuneration for judges than for the members of both the executive and the legislature.

The supreme judicial body in Hungary (Kúria), entrusted with ensuring the uniformity of national jurisprudence seeks to intervene in the answer phase of the preliminary reference procedure. Its apparent aim is to shape the referring court's interpretation and application of the CJEU's ruling. These dynamics may foreshadow the emergence of an institutional conflict, one that centres on the manner in which the Hungarian judiciary internalizes and operationalizes the jurisprudence of the CJEU. At stake is not merely a technical matter of judicial interpretation, but rather the Simmenthal doctrine and the fulfillment of the principle of sincere cooperation enshrined in Article 4(3) TEU. The main task of the Kúria is to guarantee the uniform application of the law, a duty it fulfils through the uniformity complaint panel ("UCP"). From 1 January 2026, a new law will further strengthen the UCP's role in enforcing the uniformity of case law in civil cases.

According to recent decisions of the UCP, if any new requirements arising from a CJEU judgement may lead to setting aside a prior Precedent, the Kúria's own chambers are required to request the ruling of the UCP. And the UCP in its ruling interprets the CJEU's decision.

The problem is already known to the EU Commission (Rule of law report 2024, and Rule of law report 2025) and must also be evident to the CJEU, given its judgment in Global Ink Kft. and following preliminary references from Hungarian courts in Gyula (April 2025) and Szeged (May 2025), both of which question the UCP's right to interpret the CJEU judgements for the Hungarian courts.
