

2026 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Where questions of particular relevance under the single market dimension, this is indicated before the relevant question.

This contribution aims to provide factual information regarding systemic issues affecting the effective functioning of the justice system in Romania, with cross-border relevance.

In recent years, several cases involving serious cross-border criminality with international implications have encountered significant procedural stagnation or fragmentation at national level. In particular, cooperation mechanisms intended to ensure effective judicial follow-up (including coordination with EU and non-EU partner authorities) appear to be inconsistently applied.

In certain cases, despite the existence of transnational elements and the involvement of foreign jurisdictions, national proceedings have been repeatedly delayed, limited in scope, or procedurally disjointed, resulting in reduced judicial effectiveness. These practices raise concerns regarding institutional capacity, prosecutorial independence in complex cases, and the consistency of judicial cooperation frameworks.

Relevant information related to these matters has already been transmitted through official channels to competent European and international bodies, including mechanisms for judicial cooperation. The present contribution does not seek to assess individual responsibility, but to highlight structural patterns that may undermine the rule of law, legal certainty, and mutual trust between judicial authorities.

These developments are relevant to the pillars concerning the justice system, anti-corruption efforts, and checks and balances, and merit attention in the context of the 2026 Rule of Law assessment.
