Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

**(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Richterbesoldung

Der Bund Deutscher Verwaltungsrichter und Verwaltungsrichtern (BDVR), die berufsständische Interessenvertretung der Verwaltungsrichterinnen und Verwaltungsrichter in Deutschland, hält die Richterbesoldung in Deutschland nach wie vor für nicht amtsangemessen und im europäischen Vergleich für unterdurchschnittlich. Der BDVR fordert eine attraktive und wettbewerbsfähige Richterbesoldung. Eine amtsangemessene Besoldung ist ein wichtiges Instrument zur Sicherung der richterlichen Unabhängigkeit und damit auch zur Sicherung der Rechtsstaatlichkeit.

Das Bundesverfassungsgericht hat in der Vergangenheit mehrfach - etwa für Berlin (2 BvL 4/18), für Nordrhein-Westfalen (2 BvL 6/17 u.a.) und für Sachsen-Anhalt (2 BvL 17/09 u.a.) - festgestellt, dass die Besoldung nicht einmal den verfassungsrechtlichen Minimalanforderungen genügt. Es hat unter anderem beanstandet, dass bei der Bemessung der Besoldung die Sicherung der Attraktivität des Richteramtes für entsprechend qualifizierte Kräfte, das Ansehen des Amtes in den Augen der Gesellschaft, die von Richtern geforderte Ausbildung, ihre Verantwortung und ihre Beanspruchung nicht hinreichend berücksichtigt worden sind. Der Gesetzgeber hat bisher keine ausreichenden Maßnahmen ergriffen, um die vom Bundesverfassungsgericht aufgezeigten

Misstände zu beseitigen und die Besoldung künftig amtsangemessen zu gestalten. Soweit Maßnahmen ergriffen wurden, orientieren sie sich an verfassungsrechtlichen Minimalstandards, was der BDVR als Zeichen mangelnden Respekts und mangelnder Wertschätzung der richterlichen Arbeit und als Gefahr für die Wettbewerbsfähigkeit des Richterberufs wertet.

Nach wie vor sind zahlreiche Gerichtsverfahren anhängig, in denen die Verfassungsmäßigkeit der Besoldung streitig ist. Der BDVR bringt seine Expertise in diese Verfahren ein. So hat der BDVR am 21. Februar 2024 zu den derzeit noch beim Bundesverfassungsgericht anhängigen Verfahren 2 BvL 2/16, 2 BvL 10/18 und 2 BvL 3 /19, die die Prüfung der Verfassungsmäßigkeit der Besoldung und Versorgung der Richterinnen und Richter zum Gegenstand haben, Stellung genommen und darauf hingewiesen, dass die Besoldungsgesetze Bremens, Niedersachsens und Brandenburgs in mehrfacher Hinsicht gegen das Alimentationsprinzip verstoßen und sich insbesondere die Besoldung in den genannten Ländern als evident unzureichend erweist.

In den vergangenen Jahren gab es zudem Proteste von Staatsanwältinnen und Staatsanwälte sowie von Richterinnen und Richter, um auf die prekäre Situation der Justiz aufmerksam zu machen.

Opinion on the remuneration of judges

The Association of German Administrative Judges (BDVR), the professional association representing the interests of administrative judges in Germany, regards the remuneration of judges in Germany as still not appropriate to their office and below average in a European comparison. The BDVR is demanding attractive and competitive salaries for judges. Appropriate remuneration is an important instrument for ensuring judicial independence and thus also for safeguarding the rule of law.

In the past, the Federal Constitutional Court has repeatedly found - for example for Berlin (2 BvL 4/18), for North Rhine-Westphalia (2 BvL 6/17 and others) and for Saxony-Anhalt (2 BvL 17/09 and others) - that the remuneration does not even meet the minimum constitutional requirements. Among other things, it criticized the fact that the attractiveness of the office of judge for suitably qualified candidates, the prestige of the office in the eyes of society, the education required of judges, their responsibility and their workload were not sufficiently taken into account when determining the remuneration. The legislature has not yet taken sufficient measures to eliminate the shortcomings identified by the Federal Constitutional Court and to ensure that remuneration is appropriate to the office in future. Where measures have been taken, they are based on constitutional minimum standards, which the BDVR regards as a sign of a lack of respect and appreciation for the work of judges and as a threat to the competitiveness of the profession of judge.

Numerous court cases are still pending in which the constitutionality of remuneration is in dispute. The BDVR contributes its expertise to these proceedings. For example, on February 21, 2024, the BDVR commented on the proceedings 2 BvL 2/16, 2 BvL 10/18 and 2 BvL 3/19, which are currently still pending before the Federal Constitutional Court and which concern the review of the constitutionality of the remuneration and pensions of judges, and pointed out that the remuneration laws of Bremen, Lower Saxony and Brandenburg violate the principle of remuneration in several respects and that the remuneration in the aforementioned states in particular is clearly inadequate.

In recent years, there have also been protests by prosecutors and judges to draw attention to the precarious situation of the judiciary.

Persönliche Angriffe auf Richter

Im Juni 2025 hat die 6. Kammer des Verwaltungsgerichts Berlin in einem Eilverfahren über die Frage entschieden, ob Personen, die bei Grenzkontrollen auf deutschem Staatsgebiet ein Asylgesuch äußern, ohne Weiteres zurückgewiesen werden dürfen. Die Kammer kam zu dem Schluss, dass eine Zurückweisung ohne Durchführung des Dublin-Verfahrens zur Bestimmung des zuständigen Mitgliedstaats rechtswidrig ist. In der Folge wurden die Richter dieser Kammer, insbesondere der Vorsitzende Richter, in der Presse sowie in Online-Kommentaren massiv persönlich angegriffen, diffamiert und bedroht.

Der Landesverband Berlin des Deutschen Richterbundes (DRB Berlin) und der Verein der Verwaltungsrichterinnen und Verwaltungsrichter in Berlin (VRiV Berlin) verurteilten die Angriffe in einer gemeinsamen Pressemitteilung. Weitere Unterstützung bekamen die betreffenden Richterinnen und Richter von Berlins Justizsenatorin. Auch sie betonte, dass sachlich formulierte Kritik an einzelnen Urteilen zum demokratischen Diskurs dazugehört. Jegliche Form von Gewalt, Drohungen oder Einschüchterungen dürfte jedoch niemals Teil von Kritik an Urteilen oder Richtern sein. Hinter die Betroffenen stellten sich auch die Bundesjustizministerin, die Bundesrechtsanwaltskammer und weitere Akteure.

Der BDVR hat dies zum Anlass genommen, auf die Gefahren hinzuweisen, die sich durch die persönliche Diffamierung von Richterinnen und Richtern für die Unabhängigkeit der Justiz und den Rechtsstaat ergeben.

Personal attacks on judges

In June 2025, the 6th Chamber of the Berlin Administrative Court ruled in preliminary relief proceedings on the question of whether persons who express a request for asylum during border controls on German territory may be rejected without further examination. The chamber concluded that rejection without conducting the Dublin procedure to determine the responsible member state is unlawful. As a result, the judges of this chamber, in particular the presiding judge, were subjected to massive personal attacks, defamation, and threats in the press and in online comments.

The Berlin regional association of the German Judges Association (DRB Berlin) and the Association of Administrative Judges in Berlin (VRiV Berlin) condemned the attacks in a joint press release. The judges concerned received further support from Berlin's Senator of Justice. She also emphasized that objectively formulated criticism of individual judgments is part of democratic discourse. However, any form of violence, threats, or intimidation should never be part of criticism of judgments or judges. The Federal Minister of Justice, the Federal Bar Association, and other actors also stood behind those affected.

The BDVR has taken this as an opportunity to point out the dangers that personal defamation of judges poses to the independence of the judiciary and the rule of law.
