Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

- (1) developments and measures taken in relation to the recommendations in the 2025 report,**
- (2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Where questions of particular relevance under the single market dimension, this is indicated before the relevant question.

The reform on the Act on the Openness of Government Activities is progressing very slowly. In 2025, there was only a stakeholder hearing on the needs to reform the grounds for secrecy, but at the time of this writing there is no summary or draft law available. Vice versa, there are good reasons to fear for a decrease in openness on national security grounds.

Authorities continue to face criticism from administrative courts and oversight bodies for withholding information and for inadequate application of the Act on the Openness of Government Activities. In this respect, the rule of law remains largely superficial. Reforming the legislation will not resolve this issue—particularly given that a recent legislative initiative sought to allow the concealment of information related to government negotiations until their conclusion. In other words, the prevailing pressure from the state appears to favor increased secrecy rather than greater transparency.

A. Media authorities and bodies

There is no issue of appointment or dismissal of the head or members of the collegiate body of media regulatory authorities and bodies in Finland in our view.

The Council for Mass Media is a very well-known and well-functioning self-regulatory body that receives over 500 complaints every year. The issue of state-funding of the Council has raised concerns, as in 2025 the Ministry of Justice cut its funding from 135 000 to 102 000 Eur. However, the member organizations supporting the Council made bigger contributions, and now the percentage of state funding is 20 percent instead of the previous 29.

There are no separate rules concerning the allocation of state advertising in Finland, apart from those arising from European Media Freedom Act. State advertising has not been an issue in Finland

There are no specific safeguards for the independence of heads of management and members of the governing boards of public service media. In general this has not been an issue in Finland.

Most major media companies in Finland (e.g., Sanoma Oyj) are listed on stock exchanges, making their ownership structures relatively accessible. However, smaller companies and indirect ownership chains can be opaque.

The protection of journalistic sources is well taken care of by the law, however the Helsingin Sanomat case casts a shadow over this. On 1 July 2025, the Helsinki Court of Appeals convicted Pietiläinen and Halminen with disclosing state security secret,. The Court of Appeals noted that the articles and drafts mainly aimed to disclose state secrets that were very likely to harm national security, without sufficiently contributing to a meaningful public debate. Unlike the judgment of first instance, which only found the journalists guilty of publishing classified information, the Court of Appeals extended the conviction to include attempted disclosure of details that never appeared in print. In December 2025, the Supreme Court turned down the appeal, thus the Court of Appeal decision remains in force. This means that one of the journalists got a conditional prison sentence, which is a rarity in Finland and whole Europe and will no doubt have a chilling effect on press freedom in the continent.

Law enforcement capacity, including during protests and demonstrations, to ensure journalists' safety and to investigate attacks on journalists

Law enforcement authorities have started to pay some information to the safety of journalists. For instance, before Independence Day demonstrations in 2025 – Independence Day marks the largest demonstrations in Finland – the Police was proactive in contacting the Union of Journalists and cooperating in journalists' safety. The issue of physical safety is not a big one in Finland, however, online targeting and shaming remains a major issue for journalists and can lead to self-censorship and brain drain from the profession.

Access to information and public documents by public at large and journalists (incl. transparency authorities where they exist, procedures, costs/fees, timeframes, administrative/judicial review of decisions, execution of decisions by public authorities, possible obstacles related to the classification of information)

As stated earlier, the problem with access to documents persists when it comes to waiting periods and costs. Also there is a reason to fear that after the Helsingin Sanomat precedent, classification of information will be used more widely to stop journalists from accessing certain information.

Lawsuits (incl. SLAPPs - strategic lawsuits against public participation) and convictions against journalists (incl. defamation cases) and measures taken to safeguard against manifestly unfounded and abusive lawsuits

There are none or very few SLAPP cases in Finland, unless Johanna Vehkoo's defamation process can be categorized as one. The defamation cases are not civil cases and hardly ever cross-border by nature, thus the upcoming directive is of little help in Finland. The problems have to do with national libel suits that can have a chilling effect especially on freelance journalists. The phenomenon is not widespread in Finland.

The clear-cut developments in media freedom are one thing, and another are the quiet signals around journalistic profession. There are signs of disrespect towards journalists among top politicians and other decision-makers, and the understanding of the democracy role of journalism is weakening. Journalism needs support: financial, moral, institutional, in order to be fulfilling its crucial task in democracy. There is also a one-third decrease in the amount of journalistic jobs within the last fifteen years, which no doubt leads to a weakened watchdog role in the society.
