Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

**(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Where questions of particular relevance under the single market dimension, this is indicated before the relevant question.

Over the past decade, the Hungarian state became the most important stakeholder in the media advertising ecosystem. Although the exact figures became increasingly less transparent, we know one indicator from the recent past.

In April 2025, a group of Hungarian media publishers – such as the weekly Magyar Hang – has filed a complaint to the European Commission against the Hungarian state, citing prohibited state subsidies. (<https://hang.hu/eu/bepanaszoltuk-a-magyar-allamot-az-europai-bizottsagnal-175632>) The submission was accompanied by a detailed sector analysis by Professor Kai-Uwe Kühn, former Chief Economist at the European Commission's Directorate-General for Competition, supported by a research team. (https://hang.hu/data/articles/175/1755/article-175565/Final_-_Economic_report_non-confidential_version_.pdf) According to the study, since 2015, the government and state-owned companies have placed €828 million in advertising (excluding interest) mainly in media outlets (press, online news portals and TV channels) that are considered close to the government based on their ownership or tone – including interest, this amount exceeds €1.1 billion. Since the logic of advertising placements in no way corresponds to the rules followed by commercial advertisers (which are mainly based on the audience share offered by a given press product), the submission argues that the Hungarian government's practice constitutes unnotified state aid, which is prohibited by EU law.

Putting the €828 million in context, according to its 2024 financial report, one of the most popular news sites of Hungary, Telex, had a total income of HUF 1,78 billion (€4.62 million). (<https://telex.hu/kozlemeny/2025/06/02/itt-a-telex-friss-atlathatosagi-jelentese>)

Concerns about press freedom were sparked by the National Sovereignty Protection Act, which was referred to the CJUE by the European Commission in December 2024. Although then-President of Hungary Katalin Novak, who promulgated the bill in December 2023, insisted it would comply with the constitution and would not threaten media freedom, representatives of the ruling majority included the media in the list of organisations potentially targeted by the new Sovereignty Protection Office. Given the constitutional nature of the new Office combined with the vague definition of its powers, the new law led to administrative harassment of the media and to pressures against confidentiality of journalistic sources. Most notably, the investigative watchdog Átlátszó became a subject of the Office's inquiry in June 2024 after which Átlátszó filed a lawsuit against the Office – which was won first-instance in December 2025. Apart from Átlátszó, the independent media outlet Válasz Online also filed a lawsuit against the Office following its defamatory pamphlet about Válasz Online's interview with Ukrainian president Volodymyr Zelensky. According to Válasz, the Office falsely claimed that the interview was a result of foreign funding and interests. There has been no progress since the assessment of the European Commission's 2025 Rule of Law Report which pointed out: "Transparency in the ownership structure of media companies is not regulated by any specific provisions. Section 41 of the Media Act mandates the NMHH to maintain registers on media service providers, but these registers do not, however, contain information on ownership or beneficial ownership of these companies. Direct ownership information is available via the business register. This leads the 2025 MPM to once more consider this a high-risk area. There has been no change to the system of review of market concentration in the media market."

Independent media outlets have to work hard to get access to public documents or information. If a usual press inquiry fails, one can initiate the procedure of 'publication of data of public interests'. It is regulated by the 2011 /CXII Act .

A bill titled "On the Transparency of Public Life" was submitted on 13 May 2025 by János Halász, a parliament member who belongs to the ruling Fidesz party. The text would allow fines to be imposed on any media outlet or organisation receiving foreign funds – including from the European Union – and accused of threatening "national sovereignty." This deliberately vague article of the draft law encompasses everything from the "unity of the Hungarian nation" to "traditional family structures" and "Christian culture." In other words, anything that does not align with the agenda of Prime Minister Viktor Orbán.

Similar to the "foreign agents" law adopted by Russia in 2019, this draft law would enable the Sovereignty Protection Office to blacklist media outlets and NGOs suspected of expressing "anti-Hungarian" views. These entities would then be required to justify the origin of their funding. If foreign financing is involved, the tax authority could impose fines of up to 25 times the amount received.

After widespread domestic and international objection over the summer of 2025, the government backed out of its plans however the threat of bringing the draft back to the Parliament's floor looms large over the independent Hungarian media and NGOs.

RSF recommends the following measures:

firmly relaunching, at the European level, the sanctions procedure against Hungary for rule of law violations under Article 7 of the Treaty on European Union, especially in the light of the National Sovereignty Protection Act adopted in late 2023 which must be revoked (<https://rsf.org/en/hungary-s-sovereignty-law-viktor-orban-s-new-dangerous-provocation-targeting-independent-media>);

ensuring that Hungary's public media as well as its media regulator are independent of the ruling party or coalition; this includes ensuring a balanced representation within the Media Council, which has exceeded its powers in order to render political services to the government, such as by arbitrarily refusing to renew the licence of an independent radio station, Klubradio, in early 2021 (<https://rsf.org/en/hungary-s-leading-independent-radio-station-taken-air>);

allocating state advertising in a transparent and fair manner and refraining from using it to subject media outlets to political pressure, as it was with the independent news website Index.hu before its demise in 2020 (<https://rsf.org/en/hungary-urgent-eu-response-needed-leading-independent-news-site-s-demise>);

repealing the law under which spreading fake news is punishable up to five years in prison (<https://rsf.org/en/european-media-criticized-hungarian-prime-minister-asked-apologize>), and ensuring that a transparent and thorough criminal investigation is conducted into the use of the Pegasus spyware against journalists critical of the government (<https://rsf.org/en/nsopegasus-17-journalists-7-countries-join-rsf-s-complaint-paris-and-un>).

Hungary is ranked 68 out of 180 countries in RSF's World Press Freedom Index for 2025.
