Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

**(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Regarding the implementation of the Italy-Albania Protocol, there have been relevant judicial developments at Italian and European level.

In June, the Italian Court of Cassation released a non-binding advisory opinion on the Protocol, summarizing academic legal interpretations to assist judges apply new regulations. The Court highlighted several critical issues regarding compliance with international law and constitutional principles. On the latter, the Protocol refers to migrants in general terms without indicating who should be transferred to Albania, creating a disparity in treatment among foreign nationals, which is prohibited under Article 3 of the Constitution. Further concerns involve the inviolability of personal freedom (Art. 13); since people cannot be released immediately once their detention expires, this results in *sine titulo* detention (detention without legal basis). Finally, the judges identified a serious threat to the right to health (Art. 32), as the level of healthcare in Albania and the access to health facilities are not comparable to the Italian National Health Service.

In August, the CJEU ruled on an appeal that followed the denial of international protection applications for two Bangladeshi citizens transferred to Albania, based on the alleged safety of their country of origin. The ruling in Joined Cases C-758/24 and C-759/24 states that the designation of a safe country of origin shall be defined by a legislative act, provided that it can be subject to effective judicial review regarding compliance with the substantive criteria established by the Union law. For instance, a Member State may not include a country in the list of safe countries of origin unless it offers sufficient protection to its entire population and on its entire territory.

According to the Italian Constitution, a law-decree should meet the preconditions of necessity and urgency to be legitimate. This should not apply to migration, which is a structural phenomenon that would require appropriate planning and resources. The unjustified use of decree is a common practice of latest Italian governments, limiting Parliament to a role of mere ratification of legislative acts and confirming a worrying trend. During this legislature, from October 2022 to March 2025, 142 of the 192 laws approved were proposed by the government (including 87 decrees).

The reiteration of this practice compresses parliamentary debate, restricting the possibility of proposing amendments and changes, especially by oppositions. The use of this fast-track legislative procedure accelerates approval times and does not allow for an in-depth consideration of the issues addressed: decrees are often converted in only two parliamentary readings, which means that one Chamber has the possibility of amendment while the other only formally ratifies the text.

Several times, the conversion of decrees into law is accompanied by the government's motion of confidence: this is an extraordinary but often more common tool, which limits the parliamentary timetable and binds the vote to the government's staying in office. Furthermore, remarkably different and unrelated subjects are included in the decrees, which makes it difficult for parliamentarians to carefully examine the regulations in the text.

One clear example is the so-called Security Law, which, after passing the Chamber of Deputies in September 2024, has stalled for months in the Senate due to several necessary corrections identified by the President of the Republic. To resolve the parliamentary impasse, the Government incorporated most of its contents into Decree No. 48/2025 in April. This move was intended to accelerate final approval (achieved in June), while limiting parliamentary debate and the opposition's ability to propose amendments. Ultimately, to ensure the Decree's approval, the Government called for a motion of confidence.

The misuse of decrees has been implemented also to amend international agreements: in March, the Government approved Decree No. 37/2025 to modify the Italy-Albania Protocol; it was subsequently converted into Law No. 75/2025 in May following a motion of confidence. While the Protocol initially focused on transferring people rescued in international waters by Italian assets to Albanian centres, the new decree expands its scope. It modifies the intended use of the facilities to allow for the transfer of people from Italy who are under detention as subject to expulsion orders, effectively creating a repatriation centre (CPR) in a third country despite recent judiciary developments. In July, the Constitutional Court issued an advisory opinion concerning the regulation of CPRs. Judgment No. 96/2025 highlights a vulnus on the rule of law relating to the deprivation of physical freedom, whose modalities shall be regulated by primary legislation and shall include standards for living conditions and the protection of the fundamental rights of detainees. This is not the case for CPRs, where people are detained based on administrative decisions. The Court finally encourages the legislator to take appropriate measures in line with constitutional principles thereby stated.

In June, the Decree No.48/2025, so called Security Decree, was converted into Law No. 80/2025 at the Senate, after its previous approval at the Chamber of Deputies; this law provides for a series of measures in a securitarian perspective that restrict civic space for citizens, HRDs and CSOs, limit the right to protest and dissent, and tighten penalties for various crimes. Among the most concerning provisions are: the introduction of the crime of arbitrary occupation of property and the increase in penalties for those who occupy premises due to a state of necessity; the criminalization of obstructing roads and railways during public demonstrations; the introduction of a crime for violent protests in reception centres, hotspots and CPRs; the allocation of new resources for the CPR expansion (despite the dramatic living conditions documented in the visit report of the Council of Europe Anti-torture Committee). Furthermore, the law mandates up to two years' imprisonment for a ship's master who disobeys a warship's inspection order, escalating to ten years in cases of active resistance or violence.

This latter provision risks further criminalising the work of SAR NGOs. Indeed, the majority rejected an amendment proposed by the opposition parties that sought a humanitarian exemption to protect NGO captains from liability, while providing assistance in the Mediterranean. The rejection underscores a climate of hostility toward CSOs and HRDs, signalling relevant legal risks for those engaged in SAR operations.

During 2025, Italy reiterated the practice of assigning distant ports to SAR vessels, violating international laws rather than identifying a Place of Safety (POS) where rescue operations can be rapidly terminated to minimize the time survivors remain aboard. Assigning distant ports not only exacerbates the suffering of rescued people, delaying their access to essential services such as asylum request and adequate psychological support, but also severely constrains the SAR activities of NGOs. The most impactful consequences are a reduce presence

of SAR vessels along the Central Mediterranean route. Since December 2022, NGOs had to devote 760 days to reach distant ports, covering more than 300.000 kilometres, and to allocate more financial resources to cover unnecessary navigation costs, to the detriment of SAR operations that save lives at sea. In addition, due to violations of the Piantadosi Decree, 36 administrative detentions were ordered against NGO vessels, further hindering their operations. Despite this, many detentions have been suspended by different Italian Courts after appeals, recognising the life-saving role of SAR NGOs and their right to provide assistance at sea, an international obligation above administrative law.

In November 2022, the front page of an Italian weekly magazine “Panorama” headlined 'NGOs, the new pirates', comparing SAR NGOs to modern-day pirates. Together with other organisations, EMERGENCY took legal action against the director of the magazine to defend the role of NGOs working in the Mediterranean and of NGOs in general, whose mandate is to save lives in danger and relieve suffering in line with humanitarian principles. In November 2024, the Court of Milan decided not to archive the case of Panorama’s Director on charges of aggravated defamation of SAR NGOs. In December 2025, the same Court issued a defamation conviction against the then-director, who was ordered to compensate the NGOs with several thousand euros.
