Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

- (1) developments and measures taken in relation to the recommendations in the 2025 report,**
- (2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Where questions of particular relevance under the single market dimension, this is indicated before the relevant question.

Appointments of the president of RAI

The work of the Parliament's special committee tasked with appointing the new president of RAI, the Italian public broadcaster, has been stalled since November 2024.

On 07/05/2025, Usigrai, the RAI journalists' union, expressed its concern about this deadlock, stating: "If the parliamentary majority has been blocking the RAI Supervisory Committee for more than a year in an irresponsible manner and without respect for institutional procedures, the opposition must also show responsibility, particularly by taking clear decisions in order to resolve the issue of the company's presidency."

Independence of the public service media

In its report published on 21/07/2025 on public media in Europe, Reporters Without Borders highlighted the repeated attacks by Giorgia Meloni's government on Italy's public media. Since 2022, numerous instances of government interference in RAI's editorial line have been documented, including the redefinition of programming, the cancellation of shows, and strategic appointments. Other cases of political pressure on the media were also recorded in 2025.

For example, on 23/10/2025, the Italian Data Protection Authority (Garante per la protezione dei dati personali) notified RAI of a €150,000 fine following the broadcast, on the RAI programme Report, of an audio recording between a former minister and his wife concerning the incident that led to the minister's resignation. This decision fuelled suspicions of political pressure surrounding the sanction imposed on the programme, particularly as opposition MPs pointed out that, in the days preceding the announcement, a member of the Data Protection Authority had visited the national headquarters of Fratelli d'Italia, the party of the former minister in question.

Suspected surveillance of journalists

On 01/02/2025, the British newspaper The Guardian revealed that an Italian investigative journalist had been spied on using the Graphite software, marketed by the Israeli company Paragon. On 19 February, the Federazione Nazionale Stampa Italiana (FNSI), the Italian journalists' union, filed a complaint against unknown individuals for the interception and illegal access to the journalist's personal data, who had himself lodged a complaint with the Palermo prosecutor a week earlier.

On 03/03/2025, Reporters Without Borders condemned this surveillance as a serious threat to source confidentiality, a cornerstone of press freedom, now protected under the European Media Freedom Act (EMFA). While the full circumstances of the case have yet to be clarified, the organisation calls on the Italian authorities to identify and sanction those responsible.

The security situation for journalists in Italy remains worrying. Investigative journalists continue to be exposed to serious threats, particularly from mafia groups, with several dozen of them placed under police protection. According to figures from the Central Directorate of the Criminal Police, there were 81 incidents of intimidation against journalists in the first half of 2025, representing a 76% increase compared to the same period in 2024. Ossigeno per l'Informazione indicates that 361 journalists were threatened across 107 incidents in the first half of 2025 compared with 203 journalists during the same period in 2024.

On 16/10/2025, Sigfrido Ranucci, journalist and host of the programme Report, was the victim of an attack outside his home. Ranucci is known for his numerous investigations into organized crime and had previously received many threats. This attack was described as one of the most serious threats to press freedom in recent years.

On 25/10/2025, journalist Alessandro Sahebi was assaulted in Rome.

Another serious incident occurred on 28/11/2025, when the offices of the daily newspaper La Stampa were stormed by around one hundred demonstrators, followed by acts of vandalism targeting the premises.

The attack against Sigfrido Ranucci nevertheless triggered a political response, leading to the tabling of several parliamentary motions aimed at strengthening the protection of journalists.

On 11/12/2025, a motion by the parliamentary majority was adopted. This motion tends to downplay the seriousness of the current situation regarding press freedom in Italy by asserting that the Italian framework for press freedom is adequate. It states that the government already protects threatened journalists and is monitoring the situation. It notably calls for interministerial dialogue on SLAPPs, on the independence and effectiveness of the public audiovisual service, and on mechanisms for financial contributions by platforms that exploit journalistic content. However, opposition texts, which described a critical situation for press freedom in Italy and called for a more ambitious programme and urgent intervention, were not adopted.

Precariousness

Growing precariousness is dangerously undermining journalism in Italy, weakening its dynamism and independence.

On 28/11/2025, Italian journalists held a nationwide strike calling for the renegotiation of a collective bargaining agreement that has expired since 2016. Most major newspapers (La Repubblica, La Stampa, among others) and news agencies (ANSA and AGI) ceased publication for 24 hours.

The FNSI (Italian National Press Federation) has denounced the deterioration of working conditions over nearly a decade—characterised by minimal wage increases and staff reductions—which it says has had “serious repercussions on pluralism and the right to information.”

These strikes were followed by discussions with the government, led by the Undersecretary of State at the Presidency of the Council, responsible for information and publishing, with a view to drafting a bill to reform the current regulatory framework.

Threats to media pluralism

In December 2025, numerous rumours circulated about a potential sale of GEDI, Italy’s leading media group controlled by Exor, the holding company of the Agnelli-Elkann family, to Greek entrepreneur Theodore Kyriakou through his publishing group Antenna.

The sale of La Stampa and La Repubblica, two major daily newspapers in the Italian media landscape with a centre-left editorial orientation, to a group with little experience in print journalism and unclear guarantees of editorial independence could durably destabilise Italy’s media landscape and pose a serious threat to the right to pluralistic and independent information.

Following this announcement, journalists at La Repubblica, stating that “what is at stake is not the survival of a mere brand, but that of critical thinking in this country,” went on strike on 12/12/2025. Journalists at La Stampa had also organised a one-day strike the previous day.

On 22/11/2025, Reporters Without Borders called on the parties involved and the Italian authorities to publicly provide strong guarantees for the newspapers concerned. The transposition into Italian law of the European Media Freedom Act, which provides safeguards to preserve editorial independence and promote external pluralism, is urgent. Moreover, the lack of guarantees regarding the protection of journalists’ jobs within the group increases the risk of further precarisation of the profession in Italy.

On 07/01/2026, following a meeting with representatives of the GEDI Group, and while the sale process had not yet been finalised and was still ongoing, La Repubblica journalists stated that they had not yet received any
