

2026 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

**(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Since the law of 7th of August 2023, legal aid is free for all minors. Nevertheless, this is not the case for women victims of domestic violence, even though children are often victims as well in those cases. Language is sometimes an issue as the variety of children's background in Luxembourg is important.

The OKAJU deplores that the training of lawyers to be specialized in child law and of those appointed by the judge was reduced to one day. In addition, it is difficult to obtain information about the content of this training day.

The OKAJU deplores that the length of the asylum procedures has not be reduced in 2025. Conforming to a ministerial answer to a parliamentary request (https://wdocs-pub.chd.lu/docs/exped/2025/05/QP_58735_1746163765936.pdf), the average length has increased of 3 months. In addition, as the administrative jurisdictions are overwhelmed, the delays are becoming increasingly longer.

The OKJAU noted that administrative courts will be provided with additional staff. It will also oversee the national implementation of the Migration and Asylum Pact, which will have an impact on the work of administrative courts.

The bills to reform the justice system for children and adolescents are still undergoing discussions in Parliament.

On 5th of January 2026. the OKAJU has adressed an synthesis of his recommendations to the competent parliamentary commission in relation to the draft bill 7994 concerning assistance, support and youth protection. In this document, the OKAJU expresses his concerns related to a non-conformity of this text to an integrated child protection system as recommended by the European Commission, the Council of Europe and the FRA.

OKAJU does not want Bill 7994 to fail under any circumstances, but it believes that adjustments to the text are necessary to ensure that it complies with children's rights.

ANOTHER IMPORTANT AND PROBLEMATIC DEVELOPMENT is the fivefold increase in the number of minors placed in adult prisons (CPL). (See OKAJU Annual Report, page 148). Field visits revealed that minors are not presented personally to a judge within 24 hours. In many cases, the contact with a lawyer needs too many days before personal meeting with the minors.

Since the law of 16 May 2023 (<https://legilux.public.lu/eli/etat/leg/loi/2023/05/16/a232/jo>) on the protection of persons who report breaches of Union law, OKAJU has been assigned two missions. On the one hand, it has designed an external reporting channel enabling anyone working in the private or public sector to make a report in the course of their professional activities. On the other hand, OKAJU is responsible for monitoring the implementation and compliance of internal reporting channels within private and public sector entities whose areas of competence fall within OKAJU's field of activity. The latter is in the process of establishing procedures in collaboration with the Reporting Office and the State Information Technology Centre.

In 2024, two reports were made and were the subject of special reports (which have not yet been finalised). In 2025, three reports did not meet the conditions of Article 19 of the Law of 16 May 2023.

When a complaint against a natural or legal person appears justified, OKAJU makes recommendations aimed at respecting the rights of the child. OKAJU informs the natural or legal person who made the complaint in writing of the action taken. OKAJU is informed by the natural or legal person concerned by its recommendation of the action taken in response to its intervention within a period of time that it sets.

In the absence of a satisfactory response within the period of time it sets, or in the event of inaction following its intervention on the part of the natural or legal person concerned by its recommendation, OKAJU may publish these recommendations, which do not contain any personal data.

In 2025, 15 complaints gave rise to individual written recommendations.
