

2026 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Where questions of particular relevance under the single market dimension, this is indicated before the relevant question.

The regulatory and administrative burden is considerable due to the complexity and accumulation of rules. For example, a sports club (with a canteen and a number of events) must comply with an average of 104 legal obligations.

We see that the income side of CSOs is under pressure due to cuts in subsidies, the donation deduction has been reduced, gambling tax has been increased, and due to general rules the danger exists of more barriers for fundraising (telemarketing, door-to-door fundraising, digital campaigns), which is precisely the way for CSOs to become financially independent.

We are also seeing increasingly restrictive proposals from politicians and the government, such as limiting access to the courts, restricting the right to demonstrate (the cabinet is working on a law to ban face-covering clothing at demonstrations), imposing conditions on subsidies (no influencing or initiating legal proceedings), and the motion to revoke the ANBI status of certain CSOs.

CSOs, both at home and abroad, are also increasingly confronted with physical and verbal attacks and intimidation through the stigmatization or discrediting of their work or employees. For example, international aid workers and (human rights) activists are no longer safe, humanitarian aid to refugees is increasingly being criminalized, and we are also seeing an increase in legal proceedings against CSOs that defend social interests (Strategic Lawsuits Against Public Participation, known as SLAPPs).

Finally, we are seeing a shift from criminal law to administrative law, whereby the safeguards of criminal law (such as the presumption of innocence) are being circumvented, referred to by legal scholars as shadow criminal law. These legislative proposals also contain broad standards that make it easy to ban critical voices in society and demonstrations. The Wtmo bill is not unique in this respect. We also saw this with the Administrative Prohibition of Subversive Organizations Act and the Criminalization of Glorifying Terrorism and Publicly Expressing Support for Terrorist Organizations.
