It was recently involved in a major deal where JPMorgan Chase acquired a majority stake from Colony Capital in May 2023, as part of a restructuring effort. The bank does not have any known subsidiaries.

The founders, Ivon Skula and James Herbert, have established a reputation for creating tailored financial solutions for clients. In total, First Republic has completed 6 deals, with its latest funding round being an IPO that raised USD 281. 00 mn, which matches the total amount raised of USD 281. 00 mn.

First Republic Bank, now part of JPMorgan Chase, primarily offers a comprehensive suite of banking and financial services designed to meet the needs of high-net-worth individuals, businesses, and nonprofits. Their core products include private banking, commercial real estate loans, wealth management, and personalized banking services. These offerings are tailored to facilitate effective financial planning, provide access to tailored credit solutions, and enhance investment strategies for their clients, who primarily include affluent individuals, small to mid-sized businesses, and various organizations across the United States.
