Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

**(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Investigative center of Jan Kuciak has been running independent protection platform for journalists Safe. journalism.sk since 2023. The platform fully independent from the state is the only systemic tool for protection of journalists and monitoring of attacks against the journalists in the Slovak Republic. According to our preliminary statistics (annual report of the protection platform for 2025 will be available by the end of February 2026) in 2025 we have registered 77 incidents (74 in 2024), reported by the journalists or identified by the platform. 25 incidents involved women journalists, 23 men (2 both women and men) and 31 incidents targeted media in general or particular newsrooms.

35 incidents - Threat (verbal, online, through social networks, email, letter, I learned about the threat from my sources)

12 - Stalking/harassment - online or in person

3 - death threat to a journalist or his family

4 - censorship or limiting of publication

3 - Legal Threat/ Lawsuit/ SLAPP

2 - Denying of accreditation or access to a press conference

18 - Other

Three of the most serious incidents were reported to the police contact points established at the regional police headquarters. We have feedback that 2 of them were investigated.

Our analysis shows that there is increasing trend of serial attacks of campaigns against particular journalists and that the majority of the attacks has been perpetrated via online means. It is also important to mention that large portion of registered incidents were perpetrated by the politicians, especially those representing the government. We have also conducted separate analysis of the sponsored attacks against the journalists on social networks in the 1H 2025 in V4 countries. According to our analysis Slovakia was the worst with more than 200 sponsored attacks against the journalists. This analysis in comparison with the incidents registered by the protection platform suggests that attacks against the journalists are very latent with low level of reporting by journalists, and as many of the attacks come from the level of representatives of national institutions the attacks are becoming normalised and could transcribe to the real life dangers for the journalists. There was no action taken to protect the journalists in the reporting period we have registered several initiatives that could worsen the situation of the journalists and freedom of the press.

We have registered increasing number of limiting of access to the information by particular ministries and government actors, who do not reply to the requests for comments from independent media and in several cases we have also registered ignoring of the Freedom of Information act requests for information.

Government majority in the parliament adopted ammendment to the freedom of information act which invented fees for “exceptionally extensive” public information requests, but it was dismissed by the Constitutional court. Court held that access cannot be conditioned on payment.

Aktuality.sk journalist Laura Kellö Kalinská has been experiencing legal intimidation through criminal procedures related to her journalistic work. Slovakia's Police Inspectorate a body designated to investigate misconduct within police ranks, had initiated an investigation targeting Kalinská regarding how she obtained the personal telephone number of lawyer Valéria Haščáková, wife of prominent businessman Jaroslav Haščák from the Penta investment group. Kalinská stated that authorities suspect she might have acquired the number from a member of Slovakia's National Criminal Agency (NAKA). Despite explaining clearly on multiple occasions, including two questioning sessions held in March, that she does not recall how she received Haščáková's contact details and emphasising her ethical obligation as a journalist to protect her sources, the investigation continued.

- In 2 cases Dennik N was denied accreditation or access to the press conference by the organizations under the Ministry of Culture.
- Controlling body of the state broadcaster STVR is not complete and since July 2025 when then Chair had deceased it is chaired by the vice chair Lukáš Machala who is one of the highest ranking officials at the Ministry of Culture.
- Investigative reporter of public broadcasting STVR reported a censorship by the management due to last moment stop to his investigative report for the programme Reporteri. Management had stated that it was due to legal reasons. Shortly after this case was published management of the public broadcasting stopped indefinitely airing of the whole investigative programme Reporteri.
