

2026 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, six editions of the Rule of Law Report have been published since 2020.

As every year, the Commission would like to invite the stakeholders to provide contributions to the 2026 Rule of Law Report. On the basis of these contributions and on-going developments, further targeted questions may be shared at a later stage of preparation of the 2026 Rule of Law Report, in particular in the context of country visits, or bilateral contacts.

The Commission invites stakeholders to provide contributions which include:

(1) developments and measures taken in relation to the recommendations in the 2025 report,
(2) developments related to topics covered in the 2025 country chapters, as well as any other new developments related to the rule of law.

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

This questionnaire also integrates the separate questionnaire on the single market from last year. In addition to these specific questions, respondents to the questionnaire are invited to consider the Single Market dimension, including any relevant cross-border issues, in all their answers.

Where questions of particular relevance under the single market dimension, this is indicated before the relevant question.

A. Independence

Appointment and selection of judges, prosecutors and court presidents (incl. judicial review)

There have been no changes in the legislative area. The selection procedure for the position of judge is too formal and does not guarantee the selection of the best candidates. The Association of Judges of Slovakia (hereinafter referred to as "the Association") has long proposed reinstating the position of judicial trainees and revising other issues related to the selection, training, and education of judges. Although the intention to reintroduce this position is part of the government's program statement, no concrete legislative work in this direction has begun yet.

Irremovability of judges, including transfers, (incl. as part of judicial map reform), dismissal and retirement regime of judges, court presidents and prosecutors (incl. judicial review)

No law has yet been passed to regulate the detailed conditions for transferring a judge to another court without their consent if there is a change in the judicial system and this is required for the proper administration of justice. The Constitution provides for the adoption of such a law from January 2021. Since 2021, the ex constitutione termination of a judge's term of office upon reaching the age of 67 has been introduced. This age limit was determined based on the age of termination of a notary's term of office. During 2025, the age limit for notaries was raised to 70, but for judges, the termination of office at 67 remained unchanged.

Promotion of judges and prosecutors (incl. judicial review)

A legislative amendment has been adopted (effective from January 1, 2026) according to which judges in selection procedures for higher courts will no longer be subject to psychological assessment and translation from a foreign language

In 2025, the number of courts in the country remained unchanged. It is necessary to evaluate the impact of the judicial reform, which changed the judicial map in previous years (the effectiveness of the adopted change to the judicial map from 2022). Unfortunately, there is still no objective tool for comparing the allocation of cases – the workload of individual courts within agendas and regions.

Effective February 1, 2026, a two-stage disciplinary procedure for judges, prosecutors, notaries, and bailiffs will be introduced. In disciplinary matters involving judges, the members of the disciplinary senates will include not only judges of the Supreme Administrative Court, but also judges of other courts, selected from a database of judges created by the Judicial Council. At the first level, decisions will be made by three-member panels of the Supreme Administrative Court composed of one judge of that court, one judge of another court, and one representative of another legal profession. In appeal proceedings, decisions will be made by five-member panels of the Supreme Administrative Court composed of two judges from that court, two judges from other courts, and one representative of another legal profession. We also welcome the fact that a judge who is a member of the disciplinary panel must have served as a judge for at least ten years.

It is still a common practice in Slovakia that public statements by politicians from across the political spectrum, as well as other top representatives of public power and sometimes the media, have long exceeded the boundaries of permissible criticism of courts and their decisions, and often have the character of personal attacks against judges for their decision-making activities, bounded with calls for their criminal or disciplinary liability to be brought against them, which could have a chilling effect on judges as a whole. Such irresponsible conduct, which constitutes a standard of behaviour that is adopted by a significant part of the public, including the participants or parties to court proceedings undermines (whether intentionally or not) the authority of the judiciary and undermines public confidence in the judiciary (more details you can find e.g. in <https://zdruzenie.sk/zdruzenie-sudcov-slovenska-reaguje-na-obsah-rozhovoru-exministerky-spravodlivosti-marie-kolikovej-so-zuzanou-kovacik-hanzelovou-zo-dna-3-12-2025/>)

Effective from January 1, 2026, the method of creating separate territorial districts for district court workplaces, which were established as part of the 2022 judicial map change, has been simplified, creating legal space for better accessibility of district courts, especially in family and criminal matters.

Slovak judiciary is underfunded in general. The biggest problem is the low and undignified salaries of judicial staff. The lack of quality personnel seriously threatened the proper functioning of the judiciary. Positive is, that from January 1, 2025, funds have been specifically allocated for three years to be used to increase the salaries of judicial staff (from July 2025 salaries of judicial employees of the Supreme Court and the Supreme Administrative Court too). In the future, however, it is necessary to solve this problem systematically. A specific problem in Slovakia is the low difference between the salaries of judges at individual levels of courts. It is not an exception that when promoting to a higher court, a judge has a lower real income, especially if he has additional travel expenses. Also for this reason, we noticed a significantly lower interest of judges in promoting to the courts of higher levels (including the supreme courts). This negative trend threatens the quality of judiciary. A proposal for a special type of financial compensation for judges of higher courts was submitted as part of the legislative process, but it was not approved. Also, the condition of some court buildings (the Supreme Court of Slovak republic including) and their equipment is very bad.

From August 1, 2025, the influence of the Minister of Justice on the functioning of the Judicial Academy has been strengthened, and at the same time, its director no longer has to be a judge or prosecutor.

The change in the judicial map in 2022 had a negative impact – at least for a certain period – on existing specialization, as judges specializing in civil, family, commercial, and administrative law had to re-specialize, particularly at the level of the courts of appeal and the Supreme Court. In terms of the length of proceedings, this negative impact was most pronounced in administrative justice, in connection with the establishment of administrative courts (see The 2025 EU Justice Scoreboard).
