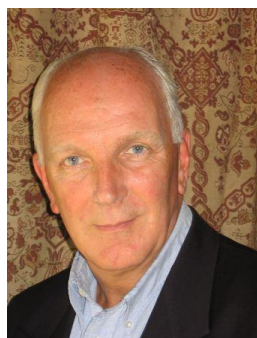

Before he began his career in public relations, Mark's background was as a broadcast journalist with the BBC. He was also a reporter on The Money Programme, BBC 2's award-winning weekly business magazine.

From 2015 to 2019 he was Spokesperson for the European Court of Auditors. Previously, he advised DG EMPL on communications for the EURES labour mobility project and worked with DG EAC on the team which developed the Erasmus Mundus programme for international students.
