The Code of Conduct for the Members of the Commission adopted by the Commission on 31 January 2018<sup>1</sup> established an Independent Ethical Committee which, upon request of the President of the Commission, shall advise the Commission on any ethical question related to the Code of Conduct and provide general recommendations to the Commission on ethical issues relevant under the Code.

Article 12(4) of the Code states that the Committee shall consist of three members selected for their competence, experience, independence and professional qualities. They shall have an impeccable record of professional behaviour as well as experience in high-level functions in European, national, or international institutions.
