### **EU-Bonds**

- The European Commission intends to issue €75 billion of long-term EU-Bonds between January and June 2024.
- The Commission has planned seven EU-Bond auctions and six syndicated transactions between January and June 2024.
- The funds raised will be used to meet payments primarily related to NextGenerationEU (including possible payments under REPowerEU, the EU's plan to end energy dependence on Russia).
- EU-Bonds will continue to be issued using benchmark maturities from 3 to 30 years, with tap transactions and new lines, using auctions and syndications. The maturities for the new lines will depend on market conditions and the intention to bring liquidity to the curve where more needed (with a tentative focus on 3y, 10y, 15y and possibly 30y for conventional lines).
- The Commission will continue to issue Next Generation EU
  Green Bonds via taps to finance the green component
  of the Recovery and Resilience Facility, which lies at
  the heart of Next Generation EU. In addition to tap
  transactions, one new long dated green bond may be
  considered, depending on market conditions.

## **EU-Bills**

- The Commission will continue to issue EU-Bills using 3-month and 6-month tenors.
- New 6-month lines will be issued during the first auction of the month, while the second auction of the month will be used to tap already outstanding issuances.
- In January and May, the first and second issuances have been shifted compared to the usual schedule while, for the other months (February, March, April and June), the general rule of the first and third Wednesday of the month will apply.
