Submission of the payment request (up to twice a year)




- MS chooses the best moment to submit
- Informal cooperation with Commission ahead of submission

Commission Assessment of the payment request (up to 2 months)




- Evidencebased assessment
- Thorough check of the satisfactory fulfilment of milestones and targets

EFC opinion (up to 4 weeks except emergency break)



- Economic Policy Committee discussion
- EFC opinion adopted by consensus

Commission adopts payment decision in comitology (around 2-3 weeks)



 Opinion by RRF (comitology) Committee




Commission processes payment (without undue delay)

- Member States will submit their payment requests once their milestones and targets are fulfilled.
- It is therefore difficult to precisely anticipate the timing.
- Expectation to receive 30-40 payment requests in 2022.
- Half of the Member States have chosen to have two payment requests per year. The others less frequently, up to once a year.
- The timing for requests linked to grants or loans can vary since instalments are separate.
- Indicative timing of payment requests are agreed in the Operational Arrangements.

The European Parliament will be kept informed on a regular basis of the related developments linked to the payment requests.






Transitioning to implementation phase: COM

On the side of the **Commission**:

- ✓ Transition from assessment of plans to assessment of milestones and targets (in context of payment request)
- ✓ Changes in internal structure to cater for implementation phase (re-staffing of negotiating teams for Member States with more payment requests/larger financial allocation)
- ✓ Transition from assessment to implementation mind-set: collecting and tracking information
- ✓ Support under TSI for implementation of recovery and resilience plans








Transitioning to implementation phase: MS

On the side the **Member States**:

- ✓ Transition from preparation of plans to implementation of measures
- ✓ Changes in internal structure to cater for implementation phase, for example at the level of the coordinating authority as well as at the level of audit authorities
- ✓ Transition to monitoring and implementation mind-set: data collection and reporting on individual milestones and targets and the common indicators









- Data collected by Member States on common indicators









Synergies with other EU programmes





Partnership agreements for 2021-2027 programming period

 44% of partnership agreements have been submitted to COM already (=12 Member States, incl. EL for which the partnership agreement was adopted already)



Operational programmes for 2021-2027 programming period

- 20% of the operational programmes have been submitted to the Commission so far
- Expected that in coming months the remaining Member States will follow

- The Commission is in the process of implementing the 2021-2027 funds
- One partnership agreement has been validated:
 Greece
- The Commission is in discussion with the other Member States regarding the preparation of their partnership agreements and the related programmes.

While discussions are ongoing, the Commission ensures consistency with the implementation of the recovery and resilience plans; in particular to ensure additionality of funding and avoidance of double funding.
