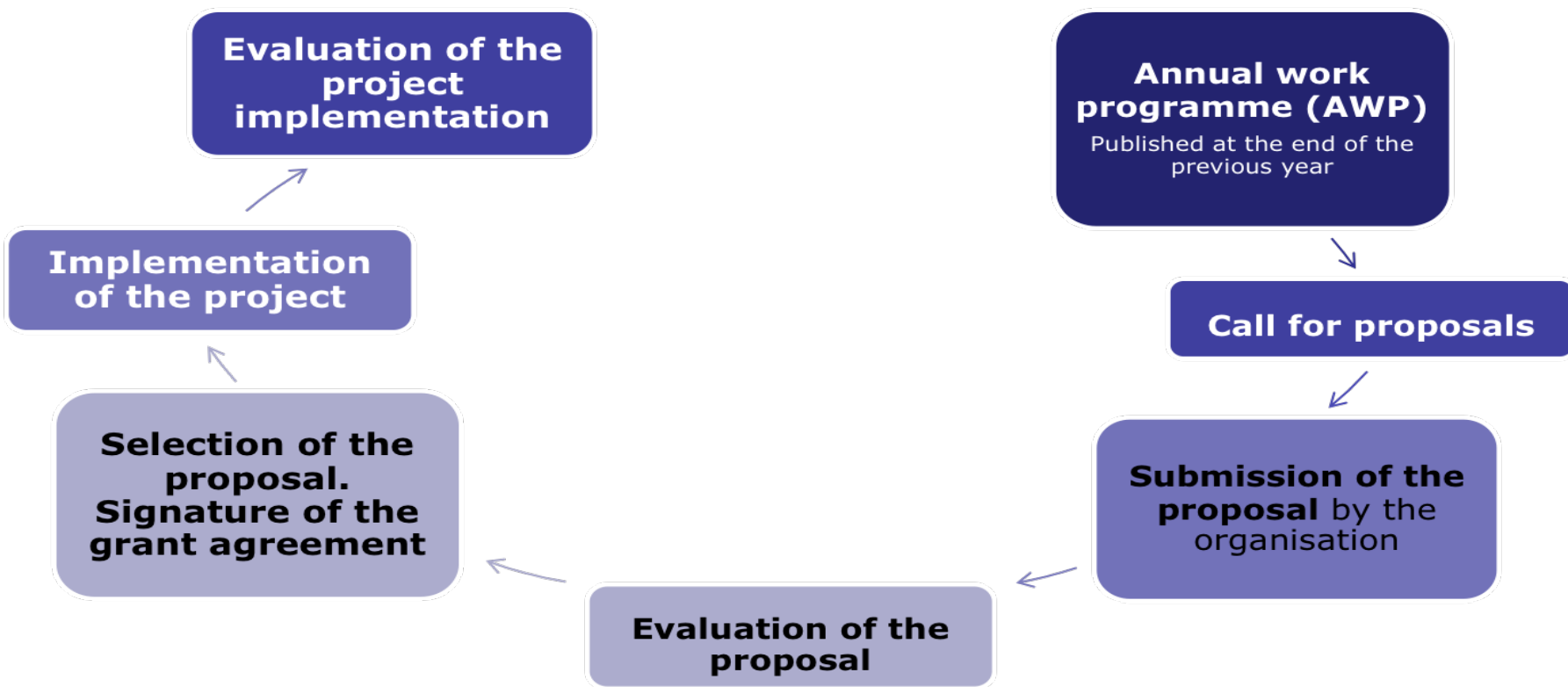

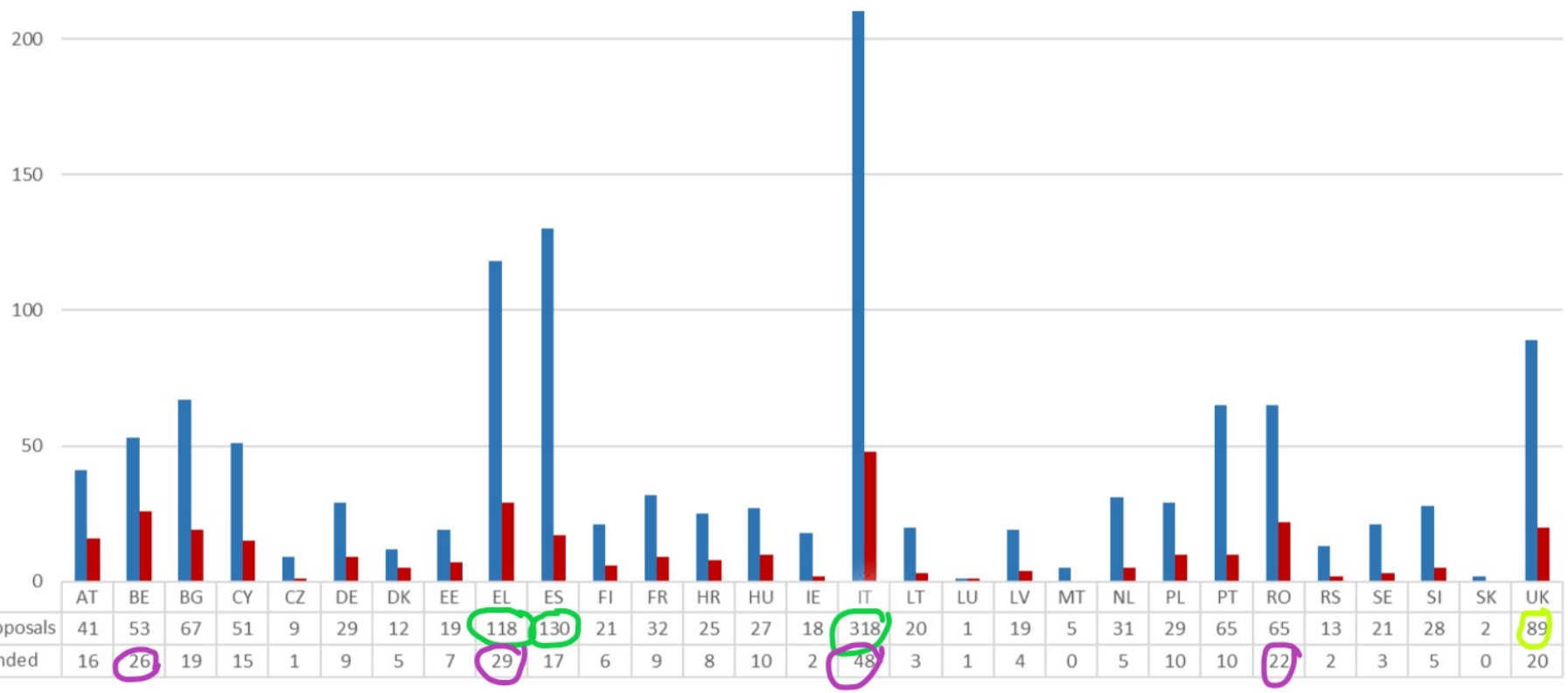

2. Project cycle of the REC funding



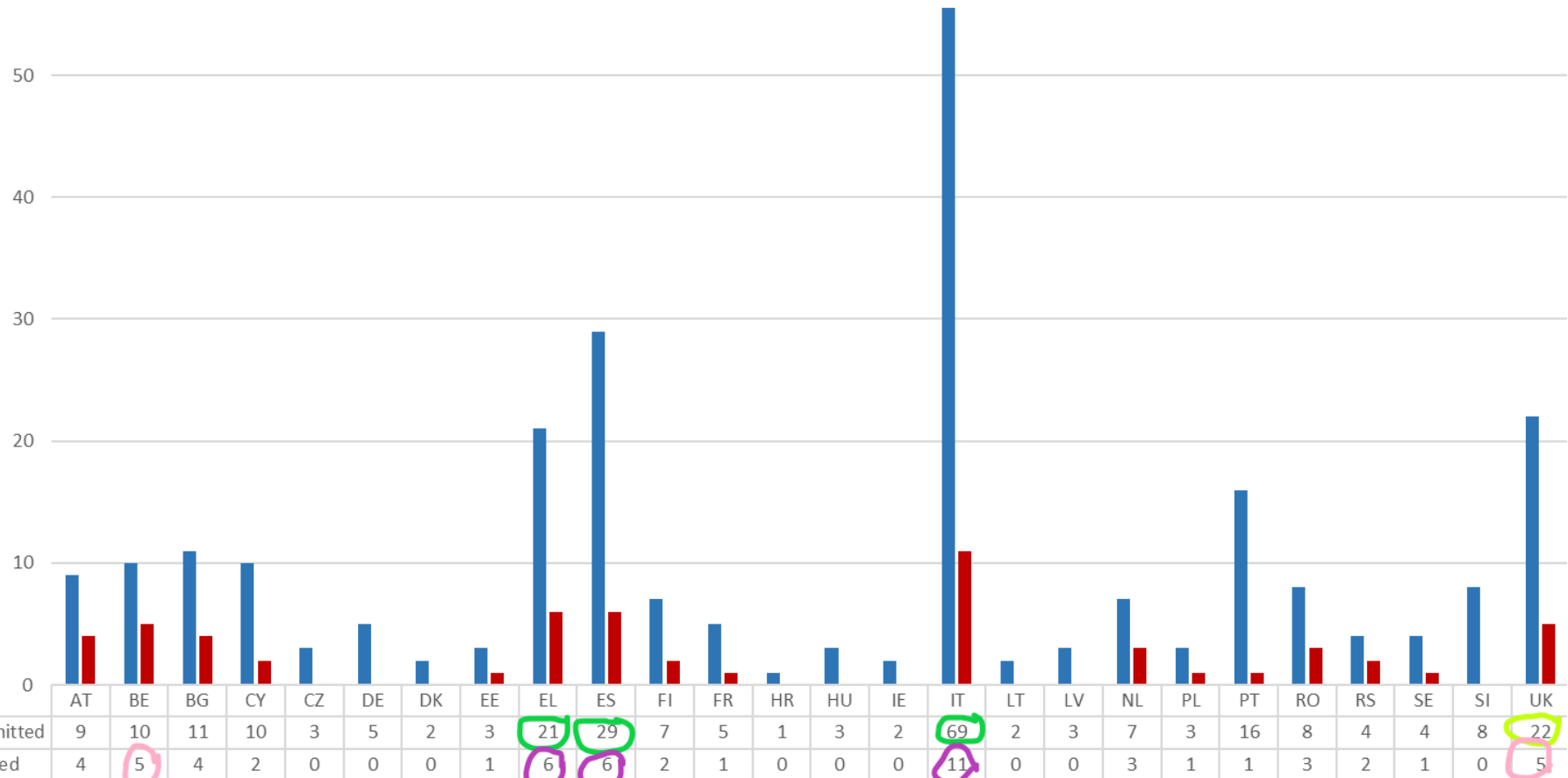

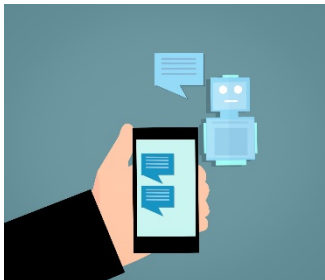
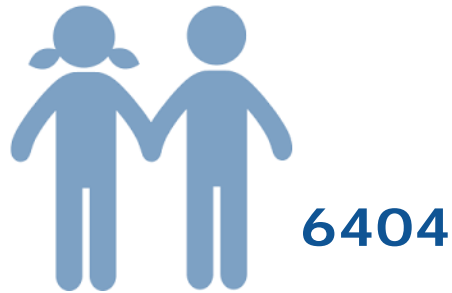
