REGULATION OF THE MINISTER OF SPORTS AND TOURISM¹

of 27 December 2017

on the determination of the contribution to the Travel Guarantee Fund²

The following provisions are hereby laid down pursuant to Article 36(9) of the Package Travel and Linked Travel Arrangements Act of 24 November 2017 (Journal of Laws item 2361):

§ 1. The following Travel Guarantee Fund contribution rates shall apply to the conclusion of package travel contracts:

- 1) to package travels organised using charter air transport in the territories of the European states listed in the Annex to this Regulation and in non-European states, except paragraph 6:
 - a) PLN 8 - in the case of travel businesses which accept payment for travel services upon completion of the package travel,
 - b) PLN 15 - in the case of other travel businesses;
- 2) to package travels in the territories of non-European states, organised using means of transport other than charter air transport:
 - a) PLN 7 - in the case of travel businesses which accept payment for travel services upon completion of the package travel,
 - b) PLN 13 - in the case of other travel businesses;
- 3) to package travels in the territories of non-European states if no transport service is provided:
 - a) PLN 4 - in the case of travel businesses which accept payment for travel services upon completion of the package travel,
 - b) PLN 7 - in the case of other travel businesses;
- 4) to package travels in the territories of the European states listed in the Annex to this Regulation organised using means of transport other than charter air transport, except paragraph 6:
 - a) PLN 5 - in the case of travel businesses which accept payment for travel services upon completion of the package travel,
 - b) PLN 10 - in the case of other travel businesses;

- 5) to package travels in the territories of the European states listed in the Annex to this Regulation if no transport service is provided, except paragraph 6:
 - a) PLN 3 - in the case of travel businesses which accept payment for travel services upon completion of the package travel,
 - b) PLN 5 - in the case of other travel businesses;
- 6) to package travels in the territories of states sharing a land border with Poland (in the case of Russia - within the Kaliningrad region and on Polish territory), irrespective of whether a transport service is provided or not:
 - a) PLN 0 - in the case of travel businesses which accept payment for travel services upon completion of the package travel,
 - b) PLN 0 - in the case of other travel businesses.

§ 2. The following Travel Guarantee Fund contribution rates shall apply to the facilitation of the procurement of linked travel arrangements:

- 1) to the facilitation of the procurement of linked travel arrangements in the territories of non-European states if transport service is provided:
 - a) PLN 4 - in the case of travel businesses which accept payment for travel services upon completion of linked travel arrangements,
 - b) PLN 7 - in the case of other travel businesses;
- 2) to the facilitation of the procurement of linked travel arrangements in the territories of non-European states if no transport service is provided:
 - a) PLN 2 - in the case of travel businesses which accept payment for travel services upon completion of linked travel arrangements,
 - b) PLN 4 - in the case of other travel businesses;
- 3) to the facilitation of the procurement of linked travel arrangements in the territories of the European states listed in the Annex to this Regulation if a transport service is provided, except paragraph 5:
 - a) PLN 3 - in the case of travel businesses which accept payment for travel services upon completion of linked travel arrangements,
 - b) PLN 5 - in the case of other travel businesses;
- 4) to the facilitation of the procurement of linked travel arrangements in the territories of the European states listed in the Annex to this Regulation if no transport service is provided, except paragraph 5:
 - a) PLN 2 - in the case of travel businesses which accept payment for travel services upon completion of linked travel arrangements,
 - b) PLN 3 - in the case of other travel businesses;
- 5) to the facilitation of the procurement of linked travel arrangements in the territories of states sharing a land border with Poland (in the case of Russia - within the Kaliningrad region and on Polish territory), irrespective of whether a transport service is provided or not:
 - a) PLN 0 - in the case of travel businesses which accept payment for travel services upon completion of linked travel arrangements,
 - b) PLN 0 - in the case of other travel businesses.

§ 3. This Regulation shall enter into force on 1 July 2018.³
