In my speech I will first try to analyse whether citizens participating in the Conference on the future of Europe can actually trigger any significant shifts in the EU policy areas, which are of particular interest to them (according to opinion polls). Then I will move on to one such policy area in particular, namely migration. I will focus on the recent Commission New Pact on Migration and Asylum. After presenting its guiding principles and the objectives pursued, I will briefly say how it has been received by MSs and NGOs.
