THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

*Article 1*

**Alt. 1:**

4) The following shall be added at the end of ---:

“The competent surveillance authority may in such cases issue a decision in accordance with Articles 6 and 8 of Regulation (EEC) No 17/62, or the corresponding provisions in Protocol 21 to the EEA Agreement, without any notification from the undertakings concerned being required.”
