

2024 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, four editions of the Rule of Law Report have been published in 2020, 2021, 2022 and 2023.

The Commission would like to invite stakeholders to provide contributions to the 2024 Rule of Law Report. This survey provides information on the type of information and topics that will be covered in the 2024 Rule of Law Report, in order to allow stakeholders to provide input. More targeted input may be requested at a later stage of preparation of the 2024 Rule of Law Report, including in the context of country visits, or bilateral contacts.

The 2024 Rule of Law Report will continue to deepen the assessment under the existing four pillars, and will also follow-up on the implementation of the recommendations to Member States, that were issued as part of the 2023 Rule of Law Report. The contribution to be provided should include **(1) information on measures taken to implement the recommendations addressed to the Member State in the 2023 Rule of Law report, as well as developments with regard to the points raised in the respective country chapter and (2) any other significant developments since January 2023^[1] falling under the ‘type of information’ outlined in section II.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

[1] Unless the information was already submitted in the input for the previous Rule of Law Reports.

Type of information

The topics are structured according to four pillars: I. Justice system; II. Anti-corruption framework; III. Media pluralism; and IV. Other institutional issues related to checks and balances. The replies could include aspects set out below under each pillar. This can include challenges, current work streams, positive developments and best practices:

A) Legislative developments

- Newly adopted legislation
- Legislative drafts currently discussed in Parliament
- Legislative plans envisaged by the Government

B) Policy developments

- Implementation of legislation
- Evaluations, impact assessment, surveys
- White papers/strategies/actions plans/consultation processes
- Follow-up to reports/recommendations of Council of Europe bodies or other international organisations
- Important administrative measures
- Generalised practices

C) Developments related to the judiciary / independent authorities

- Important case law by national courts
- Important decision/opinions from independent bodies/authorities
- State of play on terms, nominations and expired mandates for high-level positions (e.g. Supreme Court, Constitutional Court, Council for the Judiciary, heads of independent authorities included in the scope of the questionnaire[2])

D) Any other relevant developments

- Respondents are free to add any further information, which they deem relevant; however, this should be short and to the point.

The European Partnership for Democracy (EPD) welcomes the European Commission's continued efforts to systematically monitor and report on challenges to the rule of law in the European Union. However, over the past year we have not seen a significant impact of the report on addressing some of the most pressing horizontal challenges to the rule of law, including the protection of free, independent and pluralistic media and the protection of those working to protect the public interest.

Media freedom and pluralism is rightly one of the four main pillars of the 2023 Report. However, the attention paid to these issues has not prevented a number of worrying horizontal issues emerging throughout the past year. Media freedom and pluralism have steadily declined in

most, if not all, of the EU's member states, as evidenced by the numerous attacks on journalists and efforts by politicians to curb the independence of information, and as shown by the Media Pluralism Monitor 2023. In response to these threats, the European Commission presented the European Media Freedom Act (EMFA) and the Directive on the protection of persons participating in public life from manifestly unfounded or abusive legal proceedings ("strategic lawsuits against public participation", AntiSLAPP Directive). Both dossiers have been approved for the end of 2023. While these two pieces of legislation promised to improve the situation of journalists and the media in the EU, in the end they failed to live up to their potential.

For example, the report of the European Parliament's Culture and Education Committee contained very promising language on transparency of media ownership including a ban on media ownership by people holding important public positions, as well as state advertising, strong guarantees for editorial independence, and a clear definition of the inability of states to deploy surveillance against journalists except under strict conditions. However, the final text of the EMFA would not contain any of these positive changes that would greatly benefit the media environment. Without strong and ambitious language in key legislation such as the EMFA, we expect that future rule of law reports will continue to find a significant deterioration in media freedom in a number of Member States.

The AntiSLAPP Directive has also not had sufficient impact. The final text does not go far enough to protect journalists and civil rights defenders. For instance, as agreed-upon, the Directive only applies to manifestly unfounded cases. However, if the Directive were also to apply to actions which, although legally justified, have clear characteristics of an abuse of law or procedural rules, the protection for those unjustly attacked would be all the greater.

As such, the lack of clear and thorough protection of journalists and human rights defenders against unfounded lawsuits will continue to exacerbate issues related to media freedom and rule of law in the Member States.

Other remaining concerns relate to the lack of clearer language in the rule of law report, as well as the lack of transparency and the timing of the reporting cycle. The country chapters of the 2023 report read optimistically when it comes to Member States' progress on reforms, effectively glossing over persistent challenges and evidence-based shortcomings. While the Commission will start country visits for the next report in January 2024, there is once again no public information on the experts and partners the Commission will work with in the different Member States. To make the reporting cycle more transparent and participatory, we call on the European Commission to intensify its cooperation with all on the Commission to strengthen its cooperation with civil society and media organisations to reduce the privileged position that Member States still hold in reporting. Civil society's feedback on both process and substance should be sought in the cycle's evaluation.

Finally, we would like to point out once again the unfortunate timing of the planned publication of the report, as the report has only limited visibility and effectiveness due to the summer publication date. After consultation with the European Commission, EPD understands that a change in this practice is not foreseen due to the time constraints in the Commission's work programme. The formation of a new College of Commissioners in 2024, including a revision of their mandate and the Commission's work programme, provides an excellent opportunity to reconsider the annual reporting cycle and underline the importance of the Commission's annual rule of law report.
