

2024 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, four editions of the Rule of Law Report have been published in 2020, 2021, 2022 and 2023.

The Commission would like to invite stakeholders to provide contributions to the 2024 Rule of Law Report. This survey provides information on the type of information and topics that will be covered in the 2024 Rule of Law Report, in order to allow stakeholders to provide input. More targeted input may be requested at a later stage of preparation of the 2024 Rule of Law Report, including in the context of country visits, or bilateral contacts.

The 2024 Rule of Law Report will continue to deepen the assessment under the existing four pillars, and will also follow-up on the implementation of the recommendations to Member States, that were issued as part of the 2023 Rule of Law Report. The contribution to be provided should include **(1) information on measures taken to implement the recommendations addressed to the Member State in the 2023 Rule of Law report, as well as developments with regard to the points raised in the respective country chapter and (2) any other significant developments since January 2023^[1] falling under the ‘type of information’ outlined in section II.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

[1] Unless the information was already submitted in the input for the previous Rule of Law Reports.

Type of information

The topics are structured according to four pillars: I. Justice system; II. Anti-corruption framework; III. Media pluralism; and IV. Other institutional issues related to checks and balances. The replies could

Following calls for application, a total of 12 new members of the judiciary have been appointed in 2023 (five of whom will be assuming their duties in the coming days following a selection held in late November 2023). The number of court attorneys, who assist judges with legal research and judgement writing, has increased, and the salary of court attorneys was also increased in 2023. Limited availability of court room and office space remains a cause for concern, and hinders the efficient and expeditious resolution of cases. Human resources also remain limited, as recruitment of skilled support staff remains difficult.

Training of justice professionals (including judges, prosecutors, lawyers, court staff, clerks/trainees)

Training for judges and court attorneys is organised regularly by the Judicial Studies Committee. Some training for new judges is compulsory. The Judicial Studies Committee also assists judges with training outside of Malta organised by institutions such as ERA, and coordinates training for judges with other entities such as the United Kingdom High Commission and the United States Department of Justice.

Digitalisation (e.g. use of digital technology, particularly electronic communication tools, within the justice system and with court users, procedural rules, access to judgments online)

The efforts to digitalise the justice system are ongoing. Judgments of all courts can be accessed online by anyone free of charge. In civil courts case files are being scanned and made available to the parties' lawyers online on a 24/7 basis. Procedural rules are being revised to allow the possibility for witnesses to testify via video-conference when appropriate, including in criminal cases.

Use of assessment tools and standards (e.g. ICT systems for case management, court statistics and their transparency, monitoring, evaluation, surveys among court users or legal professionals)

Courts have premises in Malta and Gozo. The court in Gozo has its own registry and staff and handles both civil and criminal cases originating from Gozo. The

Court is divided into the following chambers: Constitutional Court, Civil Court, Commercial Court and Criminal Court. The Civil Court Chambers and Criminal Court Chambers have an inferior and superior jurisdiction depending on the value/subject matter of the case or the maximum potential term of imprisonment respectively. Within the criminal courts particular magistrates are assigned specialised duties, with some crimes being handled by one or two specialised magistrates, including, money laundering, drug cases, human trafficking, sanction evasion, domestic violence, environmental crime, income tax offences, VAT offences, customs offences, traffic offences and collisions, violations of health and safety regulations, and violations of employment law.

Starting from 2024, four specialised magistrates will handle all incoming magisterial inquiries.

Within the civil courts a specialised magistrate/judge handles administrative review cases. Three specialised judges handle family law cases within the Family Section of the Civil Court. The Civil Courts also have an Asset Recovery Section which handles cases of non-conviction based confiscation, challenges against forfeiture orders entered by the criminal courts and cases for the identification of tainted assets to be forfeited in accordance with orders entered by the criminal courts.
