

2024 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, four editions of the Rule of Law Report have been published in 2020, 2021, 2022 and 2023.

The Commission would like to invite stakeholders to provide contributions to the 2024 Rule of Law Report. This survey provides information on the type of information and topics that will be covered in the 2024 Rule of Law Report, in order to allow stakeholders to provide input. More targeted input may be requested at a later stage of preparation of the 2024 Rule of Law Report, including in the context of country visits, or bilateral contacts.

The 2024 Rule of Law Report will continue to deepen the assessment under the existing four pillars, and will also follow-up on the implementation of the recommendations to Member States, that were issued as part of the 2023 Rule of Law Report. The contribution to be provided should include **(1) information on measures taken to implement the recommendations addressed to the Member State in the 2023 Rule of Law report, as well as developments with regard to the points raised in the respective country chapter and (2) any other significant developments since January 2023^[1] falling under the ‘type of information’ outlined in section II.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

[1] Unless the information was already submitted in the input for the previous Rule of Law Reports.

Type of information

The topics are structured according to four pillars: I. Justice system; II. Anti-corruption framework; III. Media pluralism; and IV. Other institutional issues related to checks and balances. The replies could include aspects set out below under each pillar. This can include challenges, current work streams, positive developments and best practices:

A) Legislative developments

- Newly adopted legislation
- Legislative drafts currently discussed in Parliament
- Legislative plans envisaged by the Government

B) Policy developments

- Implementation of legislation
- Evaluations, impact assessment, surveys
- White papers/strategies/actions plans/consultation processes

- Important administrative measures
- Generalised practices

C) Developments related to the judiciary / independent authorities

- Important case law by national courts
- Important decision/opinions from independent bodies/authorities
- State of play on terms, nominations and expired mandates for high-level positions (e.g. Supreme Court, Constitutional Court, Council for the Judiciary, heads of independent authorities included in the scope of the questionnaire[2])

A. Independence

Appointment and selection of judges, prosecutors and court presidents (incl. judicial review)

Since 2021, a new procedure for selecting candidate judges of first-instance courts and courts of appeal has been set up and is being applied [The procedure is available here (in Latvian): <https://likumi.lv/ta/id/327188-par-rajona-pilsetas-tiesas-un-apgabaltiesas-tiesnesa-amata-kandidatu-atlases-kartibu>. It essentially provides for an open four-stage competition to be held once every three years. As a result of the competition, lists of candidates is drawn up for administrative, civil and criminal courts. If judicial vacancies become available, candidates are proposed from these lists].

The Judicial Council [<https://www.at.gov.lv/en/tieslietu-padome/darbibas-pamats>] deals with selecting candidate judges, appointing, and dismissing court presidents, determining the geographical distribution of courts, and approving the content of training. Candidate judges are selected through an open competition organised by the Judicial Council, ranked and placed on a list, from which the Minister for Justice proposes the candidate with the highest number of points to the Parliament for appointment. After three years in office and an evaluation by a judicial qualification panel (a body consisting of judges of all levels of jurisdiction) [<https://www.at.gov.lv/en/tieslietu-padome/tiesnesu-pasparvaldes-institucijas/tiesnesu-kvalifikacijas-kolegija/>], judges are appointed for an indefinite term by the Parliament upon a proposal from the Minister for Justice.

Irremovability of judges, including transfers, (incl. as part of judicial map reform), dismissal and retirement regime of judges, court presidents and prosecutors (incl. judicial review)

As a part of the continuation of reform of the geographical distribution of courts launched in 2015, the Regional Court of Daugavpils was merged with the same level court of Rēzekne, creating a Regional Court of Latgale [Decision No. 20 of the Judicial Council, 24 March 2023. Available (in Latvian) here: https://www.at.gov.lv/files/uploads/files/9_Tieslietu_padome/Lemumi/2023/TP_lemums_nr_20_2023.pdf]. The aim of this reorganization was to even out workload and improve judicial efficiency [Annex, point 1 et seq. to the Decision No. 20 of the Judicial Council, 24 March 2023]. The courts were merged legally, not physically, and parties may submit or receive documents in and from any of the court's locations.

Promotion of judges and prosecutors (incl. judicial review)

As it was mentioned before, in 2021 the Judicial Council approved a new procedure for selecting candidate judges of first-instance court and courts of appeal. The selection process has been fully entrusted to the judiciary, excluding the involvement of executive power. Judges of the Constitutional Court have been given an opportunity to apply to become judges of courts of appeal or the Supreme Court (after they complete their office in the Constitutional Court) [See Articles 53(3) and 54(3) of the Law on Judicial Power, available in English here: <https://likumi.lv/ta/en/en/id/62847-on-judicial-power>].

Judicial Council further amended the selection procedure to improve the assessment procedure of the judges. Thus, it amended the rules of procedure of the Judicial Qualification Committee, by providing detailed rules on the extraordinary assessment of the professional activities of judges of regional courts [Decision No. 69 of the Judicial Council, 8 September 2023. Available (in Latvian) here: https://www.at.gov.lv/files/uploads/files/9_Tieslietu_padome/Lemumi/2023/TP_Lemums_nr_69_2023_ar_pielikumu.pdf].

As it was mentioned in the Commission's 2022 rule of law report [See pp. 4-5 of the Latvia country chapter of the European Commission's rule of law report: https://commission.europa.eu/system/files/2022-07/33_1_194053_coun_chap_latvia_en.pdf], the process for appointing a judge to the Supreme Court was met with controversy surrounding potential political influence. On 17 February 2022, the candidate, a former President of the Constitutional Court, was rejected by Parliament. The Judicial Qualification Committee had evaluated the candidate and given a positive recommendation, and the Chief Justice of the Supreme Court had proposed the candidate to the Parliament. The candidate was rejected by the Parliament, with some members of the Parliament publicly criticizing the candidate's perceived political views and past decisions made during her tenure as a judge (and the President) of the Constitutional Court.

In 2023, however, the same candidate underwent a successful appointment procedure. Although no amendments were made in order to introduce safeguards in the appointment procedure for Supreme Court judges, on 5 October 2023 [There is a different governing coalition in the Parliament since 15 September 2023. The judge was sworn in on 5 January 2024.] the Parliament appointed the candidate to the Supreme Court.

Allocation of cases in courts

In 2023, the newly founded Court of Economic Cases continued its work. This is a specialized court for high profile criminal and civil cases. Since November 2022, all ten judges have been appointed to the Economic Court, previously functioning with nine judges since the beginning of its operations in March 2021.

In 2023 the Judicial Council approved a case weighing model (methodology for assessing the complexity of cases) elaborated by the Court Administration [Decision No. 23 of the Judicial Council, 28 April 2023. Available (in Latvian) here: https://www.at.gov.lv/files/uploads/files/9_Tieslietu_padome/Lemumi/2023/TP_lemums_nr_23_2023.pdf]. The case weighing model was a pilot project initiated in 2021 in several courts of first instance.

Following a crime of murder, which was the endpoint of a continued domestic violence case, the Judicial Council has set up a working group to evaluate the organisation of judicial work in domestic violence cases and threats to life or health [Decision No. 25 of the Judicial Council, 22 May 2023. Available (in Latvian) here: https://www.at.gov.lv/files/uploads/files/9_Tieslietu_padome/Lemumi/2023/TP_lemums_nr_25_2023.pdf]. The case ignited a high interest in the society and reaction in the media, especially regarding the response of the judiciary in cases of domestic violence.

In a later document, related to the same situation, the Judicial Council issued a statement following an interview given to the press by the Prosecutor General, in which he stated, inter alia, that the sworn advocate of the victim “could have done more” [to protect the victim before the courts and the office of prosecutor in the concrete case]. In its statement, following the referral of the matter to the Judicial Council by the Latvian Council of Sworn Advocates, the Judicial Council directly recognized that the failure to prevent the crime in the question “was a systemic mismanagement by the State” and it entails the responsibility of the State. The Judicial Council also acknowledged that the statement by the Prosecutor General was “unacceptable” and that the Prosecutor General was liable under the professional ethics code [Decision No. 36 of the Judicial Council, 16 June 2023. Available (in Latvian) here: https://www.at.gov.lv/files/uploads/files/9_Tieslietu_padome/Lemumi/2023/TP_lemums_nr_36_2023.pdf].

As mentioned in the 2022 report, the preparatory work to create the new centralised Academy of Justice is continuing. It is included as a milestone no. 192 under Latvia's Recovery and Resilience Plan as follows: "the establishment of a unified training centre for the development of qualifications for judges, prosecutors, and investigators, which would provide more stability and interdisciplinary approach to the training of judicial staff".

In 2023 The e-Case Management System is operational, and is being gradually extended to all courts. The e-Case portal notably allows its various users to complete and submit electronic forms as well as applications to the courts, consult the state of the proceedings and the judicial calendar [See also: Decision No. 2 of the plenary of the Supreme Court of 9 December 2021, 'On ensuring the right to a fair trial and uniform case law in the context of digitalisation of court work'. It is being gradually improved to develop the functionality of the online services to parties and representatives of litigants.
