

2024 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, four editions of the Rule of Law Report have been published in 2020, 2021, 2022 and 2023.

The Commission would like to invite stakeholders to provide contributions to the 2024 Rule of Law Report. This survey provides information on the type of information and topics that will be covered in the 2024 Rule of Law Report, in order to allow stakeholders to provide input. More targeted input may be requested at a later stage of preparation of the 2024 Rule of Law Report, including in the context of country visits, or bilateral contacts.

The 2024 Rule of Law Report will continue to deepen the assessment under the existing four pillars, and will also follow-up on the implementation of the recommendations to Member States, that were issued as part of the 2023 Rule of Law Report. The contribution to be provided should include **(1) information on measures taken to implement the recommendations addressed to the Member State in the 2023 Rule of Law report, as well as developments with regard to the points raised in the respective country chapter and (2) any other significant developments since January 2023^[1] falling under the ‘type of information’ outlined in section II.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

[1] Unless the information was already submitted in the input for the previous Rule of Law Reports.

Type of information

The topics are structured according to four pillars: I. Justice system; II. Anti-corruption framework; III. Media pluralism; and IV. Other institutional issues related to checks and balances. The replies could include aspects set out below under each pillar. This can include challenges, current work streams, positive developments and best practices:

A) Legislative developments

- Newly adopted legislation
- Legislative drafts currently discussed in Parliament
- Legislative plans envisaged by the Government

B) Policy developments

- Implementation of legislation
- Evaluations, impact assessment, surveys
- White papers/strategies/actions plans/consultation processes
- Follow-up to reports/recommendations of Council of Europe bodies or other international organisations
- Important administrative measures
- Generalised practices

C) Developments related to the judiciary / independent authorities

- Important case law by national courts
- Important decision/opinions from independent bodies/authorities
- State of play on terms, nominations and expired mandates for high-level positions (e.g. Supreme Court, Constitutional Court, Council for the Judiciary, heads of independent authorities included in the scope of the questionnaire[2])

D) Any other relevant developments

- Respondents are free to add any further information, which they deem relevant; however, this should be short and to the point.

On May 18, 2023, the Ministry of Justice (MoJ) initiated a public consultation on a draft law amending Government Ordinance 26/2000 on associations and foundations (<https://www.just.ro/proiectul-de-lege-pentru-modificarea-si-completarea-ordonantei-guvernului-nr-26-2000-cu-privire-la-asociatii-si-fundatii/>). The draft law was initiated as a result of the ECHR decision in the case of *Cegolea v. Romania*, but the scope of the law was extended in order to address the problems related to the establishment, functioning and dissolution of NGOs highlighted by NGOs.

The Center for Not-for-Profit law in Romania has documented these issues in the Research report on the administrative barriers in the establishment and functioning of NGOs in Romania (<https://clnr.ro/raport-de-cercetare-privind-barierile-administrative-in-organizarea-si-functionarea-ong-urilor-din-romania/>). The report also includes recommendations, which were the subject to an extensive consultation process in the spring of 2023, involving more than 200 NGO representatives, legal professionals and representatives of public institutions. The consultations included two debates and online public hearing held in Bucharest in a hybrid format, some of which were also attended by representatives of the MoJ.

Our organization submitted recommendations and participated in the consultation meetings organized by the MoJ with representatives of the civil society, in order to present the findings of the research and the reasoning behind the recommendations.

The key improvements brought by the draft law, following our recommendations, include:

- Streamlining the procedure for changing the headquarters of NGOs, board members and associated members (in the case of associations). The Registrar will simply take note of these changes and, within 3 days, will have them entered in the Register, for the sole purpose of ensuring publicity.
- Eliminating the requirement to obtain the prior approval from the General Secretariat of the Government (SGG), in order to use the words "national" or "Romanian", in the title of NGOs.
- Unifying the public registries of NGOs, under the National Register of Non-Profit Legal Entities held by the MoJ.
- Specifically stating that requests to the courts and public institutions may be sent by any means of

communication which ensures confirmation of receipt (including email).

- Streamlining the procedure of granting the public benefit status of NGOs, primarily by limiting the number of supporting documents requested. Also, the Government will have to justify the denial of the status. On November 3rd 2023 the draft law was submitted to the Parliament and has already been adopted in the Senate. It is not waiting for debate in the Chamber of deputies (PL-x nr. 763/2023, https://cdep.ro/pls/proiecte/upl_pck2015.proiect?cam=2&idp=21379).

We would also like to mention a legislative initiative submitted in the end of 2022, by a number of MPs aiming to restrict freedom of association and the activity of NGOs protecting the public interest (L857/2022, https://senat.ro/legis/lista.aspx?nr_cls=L857&an_cls=2022). This initiative aimed to establish the liability of the board members of NGOs engaged in litigation, for any damage caused to third parties if the case is dismissed by a final court judgment. In February 2023, NGOs protested against this initiative (<https://www.stareademocratiei.ro/2022/11/29/scrisoare-deschisa-catre-sustinatorii-propunerii-legislative-pentru-modificarea-si-completarea-ordonantei-guvernului-nr-26-2000-cu-privire-la-asociatii-si-fundatii-b-758-2022/>) and it was subsequently withdrawn by the initiator.
