

2024 Rule of Law Report - targeted stakeholder consultation

Introduction

The annual Rule of Law Report lies at the centre of the Annual Rule of Law Cycle, which acts as a preventive tool, deepening multilateral dialogue and joint awareness of rule of law issues. So far, four editions of the Rule of Law Report have been published in 2020, 2021, 2022 and 2023.

The Commission would like to invite stakeholders to provide contributions to the 2024 Rule of Law Report. This survey provides information on the type of information and topics that will be covered in the 2024 Rule of Law Report, in order to allow stakeholders to provide input. More targeted input may be requested at a later stage of preparation of the 2024 Rule of Law Report, including in the context of country visits, or bilateral contacts.

The 2024 Rule of Law Report will continue to deepen the assessment under the existing four pillars, and will also follow-up on the implementation of the recommendations to Member States, that were issued as part of the 2023 Rule of Law Report. The contribution to be provided should include **(1) information on measures taken to implement the recommendations addressed to the Member State in the 2023 Rule of Law report, as well as developments with regard to the points raised in the respective country chapter and (2) any other significant developments since January 2023^[1] falling under the ‘type of information’ outlined in section II.**

The input should consist of a short summary, if possible in English, covering the areas referred to below. Legislation or other documents may be referenced with a link. Contributions should focus on significant developments since the last Rule of Law Report both as regards the legal framework and its implementation in practice.

[1] Unless the information was already submitted in the input for the previous Rule of Law Reports.

Type of information

The topics are structured according to four pillars: I. Justice system; II. Anti-corruption framework; III. Media pluralism; and IV. Other institutional issues related to checks and balances. The replies could include aspects set out below under each pillar. This can include challenges, current work streams, positive developments and best practices:

A) Legislative developments

- Newly adopted legislation
- Legislative drafts currently discussed in Parliament
- Legislative plans envisaged by the Government

B) Policy developments

- Implementation of legislation
- Evaluations, impact assessment, surveys
- White papers/strategies/actions plans/consultation processes
- Follow-up to reports/recommendations of Council of Europe bodies or other international organisations
- Important administrative measures
- Generalised practices

C) Developments related to the judiciary / independent authorities

- Important case law by national courts
- Important decision/opinions from independent bodies/authorities
- State of play on terms, nominations and expired mandates for high-level positions (e.g. Supreme Court, Constitutional Court, Council for the Judiciary, heads of independent authorities included in the scope of the questionnaire[2])

D) Any other relevant developments

A. Independence

Appointment and selection of judges, prosecutors and court presidents (incl. judicial review)

The current model for the preparation of judicial candidates and the selection procedure of judges does not guarantee the selection of the best candidates. This is also evident from a comparison of the professional level of candidates from the ranks of higher judicial clerks or assistant of judges of the Supreme Court with the level of legal clerks of the prosecution service when taking the judicial examination.

The solution is to reinstate the previously existing institution of the judicial trainee, which has been a well-established form of preparing candidates for the office of judge for decades.

The amendment to the Constitution effective from 1 January 2021 allows for the transfer of a judge to another court without his or her consent, when the court system is changed, if this is necessary to ensure the proper administration of justice. The details are to be regulated by law (Article 148 of the Constitution)

However, no such law has yet been adopted.

Despite the recommendations, no measures have been taken to ensure that members of the Judicial Council, in particular those not elected as judges, are subject to sufficient guarantees of independence as regards their removal, taking into account European standards on the independence of judicial councils. After the parliamentary elections in September 2023, the new government took advantage of a constitutional amendment pushed through by the previous government in 2020, and the new government, without giving reasons, removed the three government-nominated members of the Judicial Council and appointed new members. Parliament is also expected to dismiss the members of the Judicial Council elected by Parliament without giving a reason.

Accountability of judges and prosecutors, including disciplinary regime and bodies and ethical rules, judicial immunity and criminal/civil (where applicable) liability of judges (incl. judicial review)

One of the recommendations of the Rule of Law Report 2023 is to ensure that sufficient safeguards are in place and duly observed when subjecting judges to criminal liability for the crime of “abuse of law” as regards their judicial decisions. No other safeguards have been put in place to prevent abuse of the limited functional immunity of judges, which also allows judges to be prosecuted for their decisions. In this regard, we consider the current trend of high-ranking politicians or public officials publicly demanding that judges be held criminally or disciplinarily liable for their decisions to be very dangerous, which, in conjunction with the limited functional immunity of judges and the very vaguely worded offence of bending the law, creates room for abuse and an increase in unacceptable pressure, and even intimidation of, on judges, and ultimately and realistically threatens their independence.

We consider the expanded vetting of judges from 2021 (in which information about the judge is also obtained from security bodies, including the secret services) to be highly problematic. Although the Judicial Council is entrusted with assessing judicial competence, the legislation does not exclude the possibility of abuse of this institute. It should be stressed that the vetting of judges is a compulsory part of the promotion of a judge. If, in the event of a negative finding, disciplinary proceedings are not brought against the judge by the President of the Judicial Council (which is not always necessary), the judge does not know the reasons for which he or she has failed to comply and, in effect, has no effective remedy. The Judicial Council decides whether or not he or she meets the conditions for judicial competence by a vote without giving reasons. At the same time, in proceedings before the Judicial Council, the judge does not have access to classified documents, which are part of the vetting process.

Remuneration/bonuses/rewards for judges and prosecutors, including observed changes (significant and targeted increase or decrease over the past year), transparency on the system and access to the information

With effect from 2021, the material support for judges during sickness has been significantly restricted. On 21 December 2023, the Constitutional Court ruled that this restriction was unconstitutional (PL. ÚS 12/2022). Another problem is the low pay gap between judges of different levels of courts. It is not unusual for a judge to have a lower income than a judge in a lower court when he or she is promoted to a higher court, due to the increased costs of travel and accommodation. This situation, which has not been resolved for a long time, has a negative impact on the intention of judges to be promoted to higher courts - particularly the Supreme Court of the Slovak Republic - which, as a result of understaffing, jeopardises the speed and quality of justice.

It has become a common practice in Slovakia that public statements by politicians from across the political spectrum, as well as other top representatives of public power, have long exceeded the boundaries of permissible criticism of courts and their decisions, and often have the character of personal attacks against judges for their decision-making activities, coupled with calls for their criminal or disciplinary liability to be brought against them. Such irresponsible conduct, which constitutes a standard of behaviour that is adopted by a significant part of the public, including the participants or parties to court proceedings, also, whether unintentionally or deliberately, undermines the authority of the judiciary and undermines public confidence in the judiciary.

In our view, this long-term negative trend also contributed to the 2023 shooting of a judge in the exercise of her profession.

One of the recommendations of the Rule of Law Report 2023 is to ensure effective public consultation and stakeholder involvement in the lawmaking process. Slovak legislation provides for a relatively broad involvement of stakeholders, including professional organizations, in the law-making process. The extent to which stakeholders are actually involved in this process depends to a large extent on the Minister of Justice. In this respect, the period from September 2022 to May 2023 can be assessed positively. The new government, which has been in office since October 2023, has also declared its intention to involve stakeholders in the law-making process as much as possible. From the perspective of the Association of Judges of Slovakia, it is positive that its members are members of working groups to assess the impact of the new judicial map, which came in force in 2023. and for the recodification of criminal law. On the other hand, despite its declared intention, the government decided to push through partial changes to the criminal

codes and the internal organisation of the prosecutor's office, in particular the existence of the Office of the Special Prosecution, in an urgent legislative procedure without a proper stakeholder comment procedure, claiming that all the legal conditions for such a procedure were fulfilled
