### 1. Introduction

The European Commission is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to Regulation (EU) 2018/1725 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

This privacy statement explains the reason for the processing of your personal data in the context of the Annual Conference of the Legal Service. It explains the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation the Annual Conference of the Legal Service, undertaken by the Legal Service, SJ.R.2 of the European Commission, is presented below.

## 2. Why and how do we process your personal data?

<u>Purpose of the processing operation</u>: Legal Service, SJ.R.2 collects and further processes your personal data to provide you with information about the Annual Conference of the European Commission Legal Service (before, during and after) and to process your application for participation in that conference.

Live web-streaming and audio-visual recording at the conference of the speakers, organisers and participants, as well as photographs of the speakers and panoramic photographs of participants and organisers will be taken and published in the context of the conference. Live web-streaming of the event will be published at <a href="https://webcast.ec.europa.eu/">https://webcast.ec.europa.eu/</a> the webpage of the Streaming Service of the European Commission whilst the audio-visual recording will not be published. Photos taken during the event will be published on the intranet of the European Commission (MyIntraComm).

The audience or non-speaker participants are not photographed individually or in groups. They may however appear on panoramic photographs of the whole event/audience. If you do not wish your photo to be taken, please notify the organisers via <u>SJ-conference@ec.europa.eu</u>, so that we can make the necessary and appropriate arrangements during the meeting/event.

Participants that do not wish to be part of the above web-streaming and recording/publishing activities have the possibility to object to processing by attending the conference in a listening room (Lord Jenkins) without web-streaming. Furthermore, there is the possibility to assist to the conference via web-streaming. No tracing of connections will be made.

Your personal data will <u>not</u> be used for any automated decision-making including profiling.

## 3. On what legal ground(s) do we process your personal data?

The processing operations on personal data, linked to the organisation, management, follow-up and promotion of the conference (including web-streaming, photos, audio-visual recording) are necessary for the management and functioning of the Commission, as mandated by the Treaties. Those provisions are in particular, Article 11 of the Treaty on European Union and Article 15 of the Treaty on the Functioning of the European Union. Consequently, those processing operations are lawful under Article 5(1)(a) of Regulation (EU) 2018/1725 (processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body).

Your consent is required for:

- The processing of your personal data relating to access requirements;
- The processing of your personal data for inviting you to future events the data controller may organise;
- The processing of your personal data for managing your subscription to communication and future updates from the data controller.

If you opt-in, you are giving us your explicit consent under Article 5(1)(d) of Regulation (EU) 2018/1725 to process your personal data for those specific purposes. You can give your consent via a clear affirmative act by ticking the box(es) on the online registration form.

Your consent for these services can be withdrawn at any time:

- for withdrawing consent that you have provided in order to benefit from other services, please contact the controller of the conference at <u>SJ-conference@ec.europa.eu</u>.

## 4. Which personal data do we collect and further process?

The following personal data will be processed:

- contact details (title, first name, last name, e-mail address, nationality, profession, name of organisation, job title, country);
- nationality, passport or identity card number and its date of issue and expiry date may be collected, so that the data subjects may obtain access to the premises where the meeting/event is held;
- Photographs, live web-streaming and audio-visual recording of the speakers, organisers and participants, will be taken and published in the context of the conference. Live web-streaming of the event will be published at https://webcast.ec.europa.eu/ the webpage of the Streaming Service of the European Commission whilst the audio-visual recording will not be published. Photos taken during the event will be published on the intranet of the European Commission (MyIntraComm). The audience or non-speaker participants are not photographed individually or in groups, but they may appear on panoramic photographs of the whole event. If you do not wish your photo to be taken, please notify the organisers via SJ-conference@ec.europa.eu, so that we can make the necessary and appropriate arrangements during the meeting/event. Participants that

do not wish to be part of the above web-streaming and recording/publishing activities have the possibility to object to processing by attending the conference in a listening room (Lord Jenkins) without web-streaming. Furthermore, there is the possibility to assist to the conference via web-streaming. No tracing of connections will be made.

The provision of personal data is mandatory. If you do not provide your personal data, we will not be able to finalise your registration to the event.

# 5. How long do we keep your personal data?

The Data Controller only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing.

For each of the categories of personal data that is processed, please find below the retention details and the reference to the relevant record of processing

- All personal data related to the organisation and management of the conference (this includes the information given during the registration, before, during or after the event) will be deleted **one year** after the last action in relation to the conference.
- Recordings from the web-streamed conference will be kept for **2 years** before being deleted. More information is available in the Record of Processing DPR-EC-00306 (Web-streaming of Commission events).
- Personal data shared with the Directorate-General for Human Resources and Security of the European Commission for the participants to gain access to Commission buildings is kept for 6 months after the termination of the link between the data subject and the Commission. More information is available in the Record of Processing DPR-EC-00655 (Commission Physical Access Control System (PACS)).
- Personal data shared with the controller for future mailing purposes (e.g., for receiving invitations to similar events) are processed in line with the Record of Processing DPR-EC-03928.1.

## 6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of the European Commission. All processing operations are carried out pursuant to <a href="Commission Decision (EU, Euratom) 2017/46">Commission Decision (EU, Euratom) 2017/46</a> of 10 January 2017 on the security of communication and information systems in the European Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

## 7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to other authorised Commission staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

The data controller is processing your personal data under Regulation (EU) 2018/1725 for the purposes of this conference. If you decide to take photographs/audio-visual recordings of participants of the conference and/or publish them online, you assume full responsibility for these actions. The same applies if you download the photographs that will be posted on the Intranet and publish them on the Internet. The data controller shall not be held accountable for any processing of personal data that you might carry out on your own initiative during or after the event.

### **Cookies**

Cookies are short text files stored on a user's device (such as a computer, tablet or phone) by a website. Cookies are used for the technical functioning of a website (functional cookies) or for gathering statistics (analytical cookies).

The registration for the conference takes place via a Commission website. The cookies employed by the Commission on the registrant's device for that purpose will be covered by the cookie policy of the Commission, which is available here: <a href="https://ec.europa.eu/info/cookies\_en">https://ec.europa.eu/info/cookies\_en</a>.

Cookies are stored by Europa Analytics, the corporate service which measures the effectiveness and efficiency of the European Commission's websites on EUROPA. More information is available in the Record of Processing DPR-EC-00685 (Europa Analytics).

Enabling these cookies is not strictly necessary for the website to work but it will provide you with a better browsing experience. You can delete or block these cookies, but if you do that, some features of the meeting/event website may not work as intended.

The cookie-related information is not used to identify data subjects personally and the pattern data is fully under the Commission's control. These cookies are not used for any purpose other than those described here.

Should you wish to opt your personal data out of our anonymised, aggregated statistics, you can do so on our cookies page. In particular, you can control and/or delete those cookies as you wish.

### Third party IT tools, including Social Media

We use third party IT tools to inform about and promote the Annual Conference of the European Commission Legal Service through widely used communication channels, including the social media. For detailed information about the use of social media by the European Commission, see the Record of Processing DPR-EC-00073 (Social Media Use by the European Commission).

In order to protect your privacy, our use of third party IT tools to connect to those services does not set cookies when our website pages are loaded on your computer (or other

devices), nor are you immediately redirected to those social media or other websites. Only in the event that you click on a button or "play" on a video to watch it, a cookie of the social media company concerned will be installed on your device. If you do not click on any social media buttons or videos, no cookies will be installed on your device by third parties.

In order to view such third-party content on our websites, a message will alert you that you need to accept those third parties' specific Terms and Conditions, including their cookie policies, over which the Commission has no control.

We recommend that users read the relevant privacy policies of Meta, LinkedIn and Twitter carefully before using them. These explain each company's policy of personal data collection and further processing, their use of data, users' rights and the ways in which users can protect their privacy when using those services.

# 8. What are your rights and how can you exercise them?

You have specific rights as a 'data subject' under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) of Regulation (EU) 2018/1725 on grounds relating to your particular situation.

You have consented to provide your personal data to the data controller for the present processing operation. You can withdraw your consent at any time by notifying the data controller by sending an email to <a href="mailto:SJ-conference@ec.europa.eu">SJ-conference@ec.europa.eu</a>. The withdrawal of your consent will not affect the lawfulness of the processing carried out before you have withdrawn the consent.

You can exercise your rights by contacting the data controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under Heading 9 below.

Where you wish to exercise your rights in the context of one or several specific processing operations, please provide their description (i.e. their Record reference(s) as specified under Heading 10 below) in your request.
