





2020 Market Monitoring Survey

The Consumer Market Monitoring Survey (MMS) assesses the performance of a range of product and service markets across the European Union, Iceland, Norway, and the United Kingdom. It looks at consumers' experiences and perceptions of the markets using a standard set of indicators to allow consistent and comparable monitoring across markets, countries and survey waves. The indicators include both 'core' items, asked for all markets, as well as market-specific indicators that are asked for selected markets only (and in varying combinations). This factsheet covers the core indicators only.

TECHNICAL NOTE

The MMS is conducted using CATI (Computer Assisted Telephone Interviews) and the target population is the general public aged 18 and older. Around 50,000 people are interviewed each wave across the 30 countries in scope. The 2020 wave of the survey was conducted between 27 July 2020 and 26 October 2020.

OVERVIEW OF FINDINGS

Overall, 81% of consumers trust operators in the packaged holidays and tours market, while 16% do not.


91% of consumers report positive experiences of making purchases in the market, while 6% report negative experiences. A total of 71% find it easy to compare the offers of different operators, while 6% find it difficult.

A total of 11% of consumers have experienced problems with services they purchased, or with operators, that they feel gave legitimate cause for complaint. Of this group, 40% have experienced financial loss while 79% have experienced other, non-financial impacts such as a loss of time, anger, frustration, stress or anxiety.


Of all those who have experienced problems the majority (62%) have gone on to make a complaint. Just over half (54%) reported being satisfied with the outcome of the complaint, while 42% reported being dissatisfied.



How much do you trust the operators overall?




How would you rate your experiences of purchasing services in this market?




How easy or difficult was it to compare the services of different operators?










