- **Title:** MEDICAL TRAININGS for Close Protection Officers

- **Type of call for tenders:** Negotiated procedure for a middle value contract of maximum EUR 143 999
- **Subject:** Services
- **Estimated total value of the contract:** 110 000 EUR (for all lots)
- **Indicative date of the launch of the procedure:** 28/05/2019
- **Duration of the contract:** framework contracts with 48 months validity

Description of the services to be purchased:

The subject of this call for tenders is the provision of **medical training courses**. The requirements have been divided into **four lots**. The tenderers may submit offers for one or more of the below lots.

- Lot 1 : Live tissue course
- Lot 2 : Combat Medic/EMT-B course and reaccreditation course
- Lot 3 : ITLS instructor course and reaccreditation course
- LOT 4 :
 - Prolonged field care & evacuation care course
 - Paramedic course
 - Tactical Trauma Life support course

The tenderer must be able to meet the following minimum selection criteria:

1. A total annual turnover for each of the last two financial years for which accounts have been closed exceeding :
 - EUR 20 000 for LOT 1
 - EUR 4 000 for LOT 2
 - EUR 6 000 for LOT 3

For each lot, tenderers must demonstrate an experience of 3 years in the field of medical trainings for close protection units, military units or other specialized law enforcement units, in the scope of the lot in question, and having trained both individual candidates and organised group training for companies / organisations.
3. Tenderers must be certified with :
- LOT 1: Accreditation / Certification: Hellenic Society of Cardiopulmonary Resuscitation (HSCPR) or equivalent
 - LOT 2:
 - a) Accreditation / Certification: HSCPR, ITLS or equivalent
 - b) Tactical Emergency Casualty Care accreditation from C-TECC or an equivalent recognised certification.
 - LOT 3: Accreditation / Certification: ITLS or an equivalent recognised certification.
 - LOT 4 : Accreditation / Certification: ACLS, ITLS, PALS, EMPACT or an equivalent recognised certification for the above or an equivalent recognised certification.

No documents proving the fulfilment of these criteria are requested at this stage.
